1 A BILL TO BE ENTITLED  
2 AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO PRODUCE  
3 VARIOUS SPECIAL REGISTRATION PLATES.

4 The General Assembly of North Carolina enacts:

5 **SECTION 1.** G.S. 20-63(b1) is amended by adding the following new subdivisions  
6 to read:

- 7 "( ) Electric Vehicle.  
8 ( ) Home of the Venus Flytrap.  
9 ( ) North Carolina Association of Fire Chiefs."

10 **SECTION 2.** G.S. 20-79.4(b) reads as rewritten:

11 "(b) Types. – The Division shall issue the following types of special registration plates:

12 ...

13 ( ) A Pet is Family. – Issuable to a registered owner of a motor vehicle in  
14 accordance with G.S. 20-81.12. The plate shall bear a picture of a paw print  
15 and the phrase "My Pet Is Family."

16 ...

17 ( ) Electric Vehicle. – Issuable to a registered owner of a motor vehicle. The plate  
18 shall have a background in two different shades of blue with the phrase  
19 "Electric Vehicle" displayed across the top banner and the phrase "North  
20 Carolina" displayed along the bottom. The plate shall bear a logo picturing a  
21 vehicle and a lightning bolt.

23 ( ) Home of the Venus Flytrap. – Issuable to a registered owner of a motor vehicle  
24 in accordance with G.S. 20-81.12. The plate shall bear a picture of a Venus  
25 Flytrap and the phrase "Home of the Venus Flytrap."

26 ...

27 ( ) North Carolina Association of Fire Chiefs. – Issuable to a registered owner of  
28 a motor vehicle in accordance with G.S. 20-81.12. The plate shall have a black  
29 background with a red line and the phrase "NC Fire Officer" across the top  
30 and the phrase "North Carolina" along the bottom. The plate shall bear the  
31 Association of Fire Chiefs logo on the left side and the letters "FO" on the  
32 right side.

34 ( ) Special Olympics NC. – Issuable to a registered owner of a motor vehicle in  
35 accordance with G.S. 20-81.12. The plate shall bear the Special Olympics NC  
36 logo.

2 SECTION 3. G.S. 20-79.7 reads as rewritten:

3 "§ 20-79.7. Fees for special registration plates and distribution of the fees.

4 ...

5 (a1) Fees. – All other special registration plates are subject to the regular motor vehicle  
6 registration fee in G.S. 20-87 or G.S. 20-88 plus an additional fee in the following amount:

26 (b) Distribution of Fees. – The Special Registration Plate Account and the Collegiate and  
27 Cultural Attraction Plate Account are established within the Highway Fund. The Division must  
28 credit the additional fee imposed for the special registration plates listed in subsection (a1) of this  
29 section among the Special Registration Plate Account (SRPA), the Collegiate and Cultural  
30 Attraction Plate Account (CCAPA), the Clean Water Management Trust Fund (CWMTF), which  
31 is established under G.S. 143B-135.234, and the Parks and Recreation Trust Fund, which is  
32 established under G.S. 143B-135.56, as follows:

8                   **SECTION 4.** G.S. 20-81.12 is amended by adding the following new subsections to  
 9 read:

10       "() A Pet is Family. – The Division shall transfer quarterly the money in the Collegiate  
 11 and Cultural Attraction Plate Account derived from the sale of "A Pet is Family" plates to The  
 12 Sergei Foundation, Inc., to be used to assist low-income families in paying for veterinary care.

13       () Home of the Venus Flytrap. – The Division shall transfer quarterly the money in the  
 14 Collegiate and Cultural Attraction Plate Account derived from the sale of "Home of the Venus  
 15 Flytrap" plates to the North Carolina Botanical Garden Foundation, Inc., to be used to support  
 16 plant conservation and plant research.

17       () North Carolina Association of Fire Chiefs. – The Division shall transfer quarterly the  
 18 money in the Collegiate and Cultural Attraction Plate Account derived from the sale of North  
 19 Carolina Association of Fire Chiefs plates to the North Carolina Association of Fire Chiefs to be  
 20 used for education programs for North Carolina firefighters.

21       () Special Olympics NC. – The Division shall transfer quarterly the money in the  
 22 Collegiate and Cultural Attraction Plate Account derived from the sale of Special Olympics NC  
 23 plates to Special Olympics North Carolina to be used to fund athletic programs throughout North  
 24 Carolina."

25                   **SECTION 5.** The Revisor of Statutes is authorized to alphabetize, number, and  
 26 renumber the special registration plates listed in G.S. 20-63(b1), 20-79.4(b), and 20-81.12 to  
 27 ensure that all the special registration plates are listed in alphabetical order and numbered  
 28 accordingly.

29                   **SECTION 6.** This act becomes effective July 1, 2021.
