1 A BILL TO BE ENTITLED
2 AN ACT TO ALLOW FULL CAPACITY ATTENDANCE AT STADIUMS IN CERTAIN
3 COUNTIES.
4 The General Assembly of North Carolina enacts:
5 **SECTION 1.** Notwithstanding Article 1A of Chapter 166A of the General Statutes,
6 any executive order, secretarial order, or directive authorized pursuant to Article 1A of Chapter
7 166A of the General Statutes, or any other provision of law, a stadium located on the campus or
8 property of a constituent institution of The University of North Carolina or a private
9 postsecondary institution, as defined in G.S. 116-280, shall be permitted to operate at one
10 hundred percent (100%) of the occupancy limits established pursuant to the North Carolina State
11 Building Code.
12 **SECTION 2.** The Governor is authorized and empowered to order the closure of any
13 individual stadium identified in Section 1 of this act (individual stadium) only as follows:
14 (1) The Governor may order, by executive order, an individual stadium to close,
15 restrict, or reduce operations within the individual stadium when necessary to
16 protect the health and safety of athletes, staff, and attendees.
17 (2) For any order issued as provided in subdivision (1) of this section, the
18 Governor shall provide reasons specific to that individual stadium for
19 requiring closure, restriction, or reduction in the operation of the individual
20 stadium. The Governor may require such actions for any reason deemed
21 necessary by the Governor.
22 (3) The Governor may only restrict, by executive order, an individual stadium and
23 shall not order a statewide closure, restriction, or reduction of the operation of
24 stadiums identified in Section 1 of this act in a single executive order.
25 (4) The Governor shall not use the authority granted in Article 1A of Chapter
26 166A of the General Statutes, or any other provision of law other than the
27 authority granted by this section, to direct the statewide closure, restriction, or
28 reduction of the operation of a stadium identified in Section 1 of this act.
29 **SECTION 3.** This act applies only to Cumberland County, Durham County, Forsyth
30 County, Guilford County, Harnett County, Jackson County, Mecklenburg County, Orange
31 County, Pasquotank County, Pitt County, Robeson County, Wake County, and Watauga County.
32 **SECTION 4.** This act is effective when it becomes law.
