Short Title: Amend Controlled Substances Act. (Public) Sponsors: Referred to: May 3, 2021 A BILL TO BE ENTITLED AN ACT REVISING THE NORTH CAROLINA CONTROLLED SUBSTANCES ACT. The General Assembly of North Carolina enacts: **SECTION 1.** G.S. 90-87 reads as rewritten: "§ 90-87. Definitions. As used in this Article: (14a) The term "isomer" means any type of isomer, including structural, geometric, or optical isomers, and stereoisomers. the optical isomer, unless otherwise specified. "Narcotic drug" means any of the following, whether produced directly or (17)indirectly by extraction from substances of vegetable origin, or independently by means of chemical synthesis, or by a combination of extraction and chemical synthesis: Opium, opiate and opioid, and any salt, compound, derivative, or a. preparation of opium, opiate, or opioid. Any salt, compound, isomer, derivative, or preparation thereof which b. is chemically equivalent or identical with any of the substances referred to in clause a, but not including the isoquinoline alkaloids of opium. Opium poppy and poppy straw. c. Cocaine and any salt, isomer, isomer (whether optical or geometric), d. salts of isomers, compound, derivative, or preparation thereof, or coca leaves and any salt, isomer, salts of isomers, compound, derivative or
