2	AN ACT TO PROVIDE FOR EXTENDED-YEAR CONTRACTS FOR INITIALLY
3	LICENSED TEACHERS, MENTOR TEACHERS, TEACHERS IN LOW-PERFORMING
4	SCHOOLS, AND CERTAIN VETERAN TEACHERS.
5	Whereas, students who are struggling in school need an extended school year and
6	individualized instructional support; and
7	Whereas, students and teachers would benefit from additional opportunities for
8	teachers to participate in professional development; and
9	Whereas, teachers have limited time to engage in professional development during
10	the school year because their time is largely committed to working with students; and
11	Whereas, teachers need more time to learn from other teachers in the context of
12	teacher-designed and teacher-led professional development; and
13	Whereas, effective professional development requires learning that is situated in
14	teachers' actual practice and focused on students' thinking and work instead of separated from
15	teaching and learning by time and location; and
16	Whereas, communities of practice are essential to providing teachers with
17	opportunities to lead, learn from, and collaborate with their professional peers; and
18	Whereas, transformative learning takes time to become established, and professional
19	development that is sustained over the course of an academic year provides that time; and
20	Whereas, teacher evaluations should provide meaningful feedback to teachers; and
21	Whereas, the teacher evaluation process can incorporate professional development in
22	order to improve teacher performance; and
23	Whereas, teachers should be compensated for participating in professional activities
24	by way of an extended contractual year; and
25	Whereas, the General Assembly supports providing compensation for teachers in
26	accordance with advanced teaching roles; and
27	Whereas, extended-year teacher contracts and advanced teaching roles can
28	complement one another to improve teacher performance and student achievement; Now,
29	therefore,
30	The General Assembly of North Carolina enacts:
31	SECTION 1. G.S. 115C-302.1 reads as rewritten:

State-allotted teachers shall be made. This set pay date may differ from the end of the month of service. The daily rate of pay for teachers shall equal midway between one twenty-first and one twenty-second of the monthly rate of pay. Except for teachers employed in a year-round school or school, paid in accordance with a year-round calendar, or both, employed on an extended-year contract, the initial pay date for teachers shall be no later than August 31 and shall include a full monthly payment. Subsequent pay dates shall be spaced no more than one month apart and shall include a full monthly payment.

Teachers may be prepaid on the monthly pay date for days not yet worked. A teacher who fails to attend scheduled workdays or who has not worked the number of days for which the teacher has been paid and who resigns, is dismissed, or whose contract is not renewed shall repay to the local board any salary payments received for days not yet worked. A teacher who has been prepaid and continues to be employed by a local board but fails to attend scheduled workdays may be subject to dismissal under G.S. 115C-325 or G.S. 115C-325.4 or other appropriate discipline.

Any individual teacher who is not employed in a year-round school may be paid in 12 monthly installments if the teacher so requests on or before the first day of the school year. The request shall be filed in the local school administrative unit which employs the teacher. The payment of the annual salary in 12 installments instead of 10 or 11 shall not increase or decrease the teacher's annual salary nor in any other way alter the contract made between the teacher and the local school administrative unit. Teachers employed for a period of less than 10 months shall not receive their salaries in 12 installments.

Notwithstanding this subsection, the term "daily rate of pay" for the purpose of
G.S. 115C-12(8) or for any other law or policy governing pay or benefits based on the teacher
salary schedule shall not exceed one twenty-second of a teacher's monthly rate of pay.

44 (b1) The State Board of Education shall maintain the same policies related to masters pay
 45 for teachers that were in effect for the 2008-2009 fiscal year.

47 (c) Vacation. – Included within the 10 month term term of employment shall be annual 48 vacation leave at the same rate provided for State employees, computed at one-twelfth of the 49 annual rate for State employees for each month of employment. Local boards shall provide at 50 least 10 days of annual vacation leave at a time when students are not scheduled to be in regular 51 attendance. However, instructional personnel who do not require a substitute may use annual

vacation leave on days that students are in attendance. Career and technical education teachers 1 2 Teachers who are employed for 11 or 12 months may, with prior approval of the principal, work 3 on annual vacation leave days designated in the school calendar and may use those annual 4 vacation leave days during the eleventh or twelfth month of employment. Local boards of 5 education may adopt policies permitting instructional personnel employed for 11 or 12 months in year-round schools to, with the approval of the principal, take vacation leave at a time when 6 7 students are in attendance; local funds shall be used to cover the cost of substitute teachers. 8 On a day that pupils are not required to attend school due to inclement weather, but employees 9 are required to report for a workday, a teacher may elect not to report due to hazardous travel 10 conditions and to take an annual vacation day or to make up the day at a time agreed upon by the teacher and the teacher's immediate supervisor or principal. 4 **SECTION 4.** There is appropriated from the General Fund to the Department of 5 Public Instruction the sum of two hundred ninety-seven million dollars (\$297,000,000) in 6 recurring funds to provide extended-year teacher contracts to certain teachers in accordance with 7 G.S. 115C-306.1, as enacted by this act.

8 **SECTION 5.** This act becomes effective July 1, 2021, and applies beginning with 9 the 2021-2022 school year.
