HOUSE BILL DRH40578-NGa-80

Short Title: Social and Emotional Learning Pilot.

(Public)

Referred to:

1 A BILL TO BE ENTITLED  
2 AN ACT TO ESTABLISH A PILOT PROGRAM TO IMPLEMENT SOCIAL AND  
3 EMOTIONAL LEARNING CURRICULUM IN KINDERGARTEN CLASSROOMS.

4 Whereas, decades of scientific research show social and emotional learning (SEL) is  
5 highly correlated with significant and sustained academic success and improved behavior; and

6 Whereas, SEL can have a long-term, positive impact through adulthood, including  
7 decreasing the likelihood of being on a waiting list for or living in public housing, receiving  
8 public assistance, being involved with police before adulthood, and spending time in a detention  
9 facility; and

10 Whereas, many preschool teachers in North Carolina are trained in evidence-based  
11 practices to support social and emotional learning and student development in this area using the  
12 Preschool Pyramid Model of the Department of Public Instruction; and

13 Whereas, kindergarten teachers are often not prepared to support the social and  
14 emotional well-being of students; and

15 Whereas, establishing evidence-based SEL practices in kindergarten will better  
16 prepare teachers and provide alignment and continuity for children when they transition into  
17 kindergarten; and

18 Whereas, the Department of Public Instruction currently recognizes 37 local school  
19 administrative units with at least 135 practitioner coaches and 365 teachers using the Preschool  
20 Pyramid Model, which is only thirty-two percent (32%) of local school administrative units and  
21 seventeen percent (17%) of preschools operated by local school administrative units; Now,  
22 therefore,

23 The General Assembly of North Carolina enacts:

24 **SECTION 1.** Pilot Program; Purpose. – The Department of Public Instruction shall  
25 establish the Kindergarten Social and Emotional Learning Pilot Program (Program) for the  
26 2021-2023 fiscal biennium. The purpose of the Program is to support and promote the expansion  
27 of the existing social and emotional learning (SEL) curriculum from the NC Preschool Pyramid  
28 Model used in preschool classrooms into kindergarten classrooms.

29 **SECTION 2.** Definitions. – The following definitions shall apply in this act:

30 (1) Administrator. – A principal or assistant principal.

31 (2) Coach. – An employee of a local school administrative unit who receives  
32 Preschool Pyramid Model training and support from the Department of Public  
33 Instruction. Coaches will be tasked with supporting teachers and  
34 administrators participating in the Program. Coaches may be peer teachers,  
35 preschool coordinators, instructional facilitators, exceptional children staff  
36 members, or other similar employees of the local school administrative unit.



- 1 (3) District Implementation Leadership Team (DILT). – A team composed of  
2 persons outlined in the Preschool Pyramid Model from within each local  
3 school administrative unit that participates in the Program. The DILT is tasked  
4 with implementing the Preschool Pyramid Model in the local school  
5 administrative unit. The DILT shall fulfill all responsibilities under the  
6 Preschool Pyramid Model, as well as responsibilities required by this act.

7 **SECTION 3.** Participation. – The Department of Public Instruction shall develop an  
8 application process for the Program by August 1, 2021. Any local school administrative unit that  
9 is identified as low performing for the 2018-2019, 2019-2020, or 2020-2021 school year may  
10 apply to participate in the Program by October 1, 2021. The Department of Public Instruction  
11 shall select six local school administrative units that are geographically and culturally diverse to  
12 participate in the program by December 1, 2021. Priority shall be given to local school  
13 administrative units that receive low-wealth supplemental funding.

14 **SECTION 4.** Implementation. – The Department of Public Instruction shall allocate  
15 funds to each local school administrative unit, as necessary, to implement the Program, with at  
16 least five thousand dollars (\$5,000) being allocated to each local school administrative unit for  
17 classroom materials necessary for the Program. Each local school administrative unit shall  
18 implement the Program in six kindergarten classrooms. The Department of Public Instruction  
19 shall provide SEL training to six kindergarten teachers, two administrators, and two coaches from  
20 each local school administrative unit. Each local school administrative unit shall establish a  
21 DILT, pursuant to the Preschool Pyramid Model, to lead the implementation of the Program. The  
22 Program shall be implemented as follows:

- 23 (1) Planning and training. – No later than December 31, 2021, the SEL Preschool  
24 Pyramid Model shall be adapted for use in kindergarten classrooms by the  
25 Department of Public Instruction in consultation with the B-3 Interagency  
26 Council. The Department of Public Instruction shall have a method for  
27 stakeholder input on the adaptation of the model. Between January 1, 2022,  
28 and June 1, 2022, teachers, administrators, and coaches shall be trained by the  
29 Department of Public Instruction in cooperation with the DILT in the  
30 implementation of the model for use in kindergarten classrooms. The  
31 Department of Public Instruction shall have a method for receiving feedback  
32 and input from participants in the Program, including teachers, administrators,  
33 coaches, and other stakeholders. The curriculum for kindergarten classrooms  
34 may be revised based on that feedback and input. On or before July 15, 2022,  
35 the Department of Public Instruction shall provide a report to the Joint  
36 Legislative Education Oversight Committee and the Joint Legislative  
37 Oversight Committee on Health and Human Services evaluating the progress  
38 of the Program.
- 39 (2) Implementation into classrooms. – For the 2022-2023 school year, each local  
40 school administrative unit shall implement the SEL Preschool Pyramid Model  
41 in the six kindergarten classrooms. The Department of Public Instruction shall  
42 provide professional development to coaches to assist the coaches in  
43 supporting teachers and administrators participating in the Program. DILTs  
44 shall meet for team training and development and local expansion and  
45 sustainability planning. Throughout the process, the Department of Public  
46 Instruction shall maintain a method of feedback and input from teachers,  
47 administrators, coaches, and other stakeholders from local school  
48 administrative units participating in the Program. The Department of Public  
49 Instruction shall make any final revisions to the Program before providing a  
50 final evaluation report on the Program to the Joint Legislative Education  
51 Oversight Committee and Joint Legislative Oversight Committee on Health

- 1 and Human Services on or before July 15, 2023. The report shall include at
- 2 least the following:
- 3 a. Methods for increasing capacity of DILTs within local school
- 4 administrative units.
- 5 b. Methods for increasing coaches in local school administrative units.
- 6 c. Methods of local expansion and sustainability.
- 7 d. A plan for statewide expansion of the Program.

8 **SECTION 5.** Appropriation. – There is appropriated from the General Fund to the  
9 Department of Public Instruction the sum of two hundred ninety-two thousand seven hundred  
10 fifty-eight dollars (\$292,758) in nonrecurring funds for the 2021-2022 fiscal year and the sum of  
11 two hundred forty-eight thousand six hundred fifty-seven dollars (\$248,657) in nonrecurring  
12 funds for the 2022-2023 fiscal year for the implementation of the Program.

13 **SECTION 6.** Effective Date. – This act becomes effective July 1, 2021.
