HOUSE BILL DRH40615-MKa-167

Short Title: HBCU/HMSI Funds/Adv. Bd./Teaching Fellows. (Public)

1 A BILL TO BE ENTITLED  
2 AN ACT TO ALLOCATE ADDITIONAL FUNDS TO CONSTITUENT INSTITUTIONS  
3 IDENTIFIED AS HISTORICALLY MINORITY-SERVING INSTITUTIONS TO  
4 ADDRESS UNDERFUNDING AT THOSE INSTITUTIONS, TO ESTABLISH THE  
5 HISTORICALLY MINORITY-SERVING INSTITUTIONS ADVISORY BOARD, AND  
6 TO ADD CERTAIN INSTITUTIONS TO THE NORTH CAROLINA TEACHING  
7 FELLOWS PROGRAM.

8 The General Assembly of North Carolina enacts:

9 **SECTION 1.** The General Assembly finds that, due to the historical and continued  
10 inequality in funding provided to constituent institutions of The University of North Carolina  
11 identified as Historically Minority-Serving Institutions (HMSIs) and to provide enhancement  
12 funding for the purpose of ensuring these institutions are comparable and competitive with other  
13 constituent institutions in all facets of their operations and programs, there is appropriated from  
14 the General Fund to the Board of Governors of The University of North Carolina the sum of  
15 twenty million dollars (\$20,000,000) in additional recurring funds to be allocated to each of the  
16 following constituent institutions for 10 fiscal years, beginning with the 2021-2022 fiscal year  
17 until the 2030-2031 fiscal year:

- 18 (1) North Carolina Central University
- 19 (2) North Carolina Agricultural and Technical State University
- 20 (3) Fayetteville State University
- 21 (4) Winston-Salem State University
- 22 (5) Elizabeth City State University
- 23 (6) University of North Carolina at Pembroke.

24 These funds may be used for scholarships, faculty recruitment, course development,  
25 and general operational support.

26 **SECTION 2.(a)** There is established the Historically Minority-Serving Institutions  
27 Advisory Board (Board). The Board shall be located administratively in The University of North  
28 Carolina System Office.

29 **SECTION 2.(b)** The Board shall be composed of 17 members as follows:

- 30 (1) Seven members appointed by the President Pro Tempore of the Senate, three  
31 of which shall be legislators. At least four of the appointees shall have  
32 attended or graduated from one of the historically minority-serving  
33 constituent institutions of The University of North Carolina.
- 34 (2) Seven members appointed by the Speaker of the House of Representatives,  
35 three of which shall be legislators. At least four of the appointees shall have

1 attended or graduated from one of the historically minority-serving  
2 constituent institutions of The University of North Carolina.

- 3 (3) Three members appointed by the Governor, one of whom the Governor shall  
4 designate as the Chair. At least one of the appointees shall have attended or  
5 graduated from one of the historically minority-serving constituent  
6 institutions of The University of North Carolina.

7 **SECTION 2.(c)** The Board shall study strategies and actions that can be taken to  
8 increase the rates of enrollment, retention, and graduation for the historically minority-serving  
9 institutions that are constituent institutions of The University of North Carolina. The Board shall  
10 also study (i) disparities in the funding formulas for the historically minority-serving institutions  
11 that are constituent institutions with specific attention to the funding disparities for certain  
12 programs of the institutions, specifically educator preparation programs, and (ii) the historical  
13 gap in funding for the historically minority-serving institutions that are constituent institutions.

14 **SECTION 2.(d)** The Board shall meet upon the call of the Chair. A quorum of the  
15 Board shall be nine members. Any vacancy on the Board shall be filled by the appointing  
16 authority.

17 **SECTION 2.(e)** The University of North Carolina System Office shall provide  
18 meeting space, administrative support, equipment, and supplies to the Board.

19 **SECTION 2.(f)** The Board members shall receive per diem, subsistence, and travel  
20 allowances in accordance with G.S. 138-5, 138-6, or 120-3.1, as appropriate.

21 **SECTION 2.(g)** The Board shall submit its preliminary findings and  
22 recommendations to the Board of Governors of The University of North Carolina and to the Joint  
23 Legislative Education Oversight Committee no later than December 15, 2022, and shall submit  
24 a final report to the Board of Governors and the Joint Legislative Education Oversight Committee  
25 no later than March 15, 2023. The Board shall terminate on March 15, 2023, or upon the filing  
26 of its final report, whichever occurs first.

27 **SECTION 3.** G.S. 116-209.62 reads as rewritten:

28 "**§ 116-209.62. North Carolina Teaching Fellows Program established; administration.**

29 ...

30 (f) Program Selection Criteria. – The Authority shall administer the Program in  
31 cooperation with up to ~~eight~~10 institutions of higher education with approved educator  
32 preparation programs selected by the Commission that represent a diverse selection of both  
33 postsecondary constituent institutions of The University of North Carolina and private  
34 postsecondary institutions operating in the State. The Commission shall include at least the  
35 following constituent institutions of The University of North Carolina in the Program: one  
36 institution that is designated as a Historically Black College or University (HBCU) and one  
37 institution that is designated as a Historically American Indian University. The Commission shall  
38 adopt stringent standards for selection of the most effective educator preparation programs,  
39 including the following:

- 40 (1) Demonstrates high rates of educator effectiveness on value-added models and  
41 teacher evaluations, including using performance-based, subject-specific  
42 assessment and support systems, such as edTPA or other metrics of evaluating  
43 candidate effectiveness that have predictive validity.
- 44 (2) Demonstrates measurable impact of prior graduates on student learning,  
45 including impact of graduates teaching in STEM or special education  
46 licensure areas.
- 47 (3) Demonstrates high rates of graduates passing exams required for teacher  
48 licensure.
- 49 (4) Provides curricular and co-curricular enhancements in leadership, facilitates  
50 learning for diverse learners, and promotes community engagement,  
51 classroom management, and reflection and assessment.

- 1           (5)     Requires at least a minor concentration of study in the subject area that the
- 2                     candidate may teach.
- 3           (6)     Provides early and frequent internship or practical experiences, including the
- 4                     opportunity for participants to perform practicums in diverse school
- 5                     environments.
- 6           (7)     Is approved by the State Board of Education as an educator preparation
- 7                     program.
- 8       (g)     Awards of Forgivable Loans. – The Program shall provide forgivable loans to selected
- 9     students to be used at the ~~eight selected~~ participating institutions for completion of a program
- 10    leading to initial teacher licensure as follows:
- 11           (1)     North Carolina high school seniors. – Forgivable loans of up to four thousand
- 12                     one hundred twenty-five dollars (\$4,125) per semester for up to eight
- 13                     semesters.
- 14           (2)     Students applying for transfer to a selected educator preparation program at
- 15                     an institution of higher education. – Forgivable loans of up to four thousand
- 16                     one hundred twenty-five dollars (\$4,125) per semester for up to six semesters.
- 17           (3)     Individuals currently holding a bachelor's degree seeking preparation for
- 18                     teacher licensure. – Forgivable loans of up to four thousand one hundred
- 19                     twenty-five dollars (\$4,125) per semester for up to four semesters.
- 20           (4)     Students matriculating at institutions of higher education who are changing to
- 21                     enrollment in a selected educator preparation program. – Forgivable loans of
- 22                     up to four thousand one hundred twenty-five dollars (\$4,125) per semester for
- 23                     up to four semesters.

24           Forgivable loans may be used for tuition, fees, the cost of books, and expenses related to

25    obtaining licensure.

26           ...."

27           **SECTION 4.** This act becomes effective July 1, 2021. Section 3 of this act applies

28    beginning with the 2022-2023 academic year.
