1 moves to amend the bill on page 630, lines 43-44 by inserting between the lines the following:

3 **"REMOVE HMMWV ("HUMVEE") AFFIDAVIT REQUIREMENT FOR**  
4 **REGISTRATION AND TITLE APPLICATIONS**

5 **SECTION 41.58.(a)** G.S. 20-53.5 reads as rewritten:

6 **'§ 20-53.5. Titling and registration of HMMWV.**

7 (a) Registration and Certificate of Title. – The Division shall register and issue a  
8 certificate of title for an HMMWV if all of the following conditions are met:

9 (1) ~~The applicant for the title and registration of the HMMWV has provided to the~~  
10 ~~Division a sworn affidavit from a manufacturer, motor vehicle dealer, or seller of the HMMWV~~  
11 ~~certifying that the vehicle complies with all applicable federal motor vehicle safety standards for~~  
12 ~~vehicles designed for highway use.~~

13 (2) ~~The~~ vehicle has a vehicle identification number that matches the vehicle  
14 ownership documents. If the vehicle does not have a vehicle identification number, the Division  
15 shall assign one to the vehicle prior to registration. The existence of a valid vehicle identification  
16 number for the vehicle shall be verified by the License and Theft Bureau of the Division prior to  
17 its registration and titling.

18 (b) Applicability of This Chapter. – All provisions of this Chapter shall apply to an  
19 HMMWV, including the provisions of Article 3A and Article 9A of this Chapter, to the same  
20 extent they would apply to any other registered motor vehicle.

21 (c) Fees. – The vehicle registration fees applicable to property-hauling vehicles shall  
22 apply to the registration of an HMMWV.

23 (d) No Liability for Operations. – Neither the State nor its commission contract agents  
24 shall be liable for any injury or damages resulting from the operation of an HMMWV registered  
25 or titled pursuant to this section."

26 **SECTION 41.58.(b)** This section becomes effective October 1, 2021, and applies to  
27 applications for registration and certificate of title submitted on or after that date.'".


