15 **"PART V: SCHOOL FACE COVERING POLICIES**

16 **SECTION 5.** Section 10 of S.L. 2021-130 reads as rewritten:

17 **"SECTION 10.** For the 2021-2022 school year, all public school units shall adopt a
18 policy regarding the use of face coverings by employees and students. The governing body of
19 the public school unit shall vote ~~at least once a month~~ on whether the face covering policy should
20 be ~~modified~~ modified as follows:

21 (1) Following consultation with the local health director, the governing body of a
22 public school unit shall establish criteria, based on public health metrics for
23 the geographic area served by the public school unit, for when consideration
24 of modifications should be made to face covering policies. The established
25 criteria shall not prevent a public school unit from voting more frequently on
26 whether modifications should be made to the face covering policy, in the
27 discretion of the governing body.

28 (2) The Secretary of Health and Human Services may require, notwithstanding
29 local criteria, all public school units to vote on whether modifications should
30 be made to face covering policies when certain public health metrics are
31 present for the State."
