5 REPRESENTATIVES AND THE PRESIDENT PRO TEMPORE OF THE SENATE.
6 The General Assembly of North Carolina enacts:

8 **PART I. MODIFICATIONS**

9 **SECTION 1.1.** Section 1.22 of S.L. 2021-131 reads as rewritten:

10 "SECTION 1.22. William R. "Russ" Davis of Onslow County is appointed to the North
11 Carolina Board for Licensing of Soil Scientists for a term expiring ~~June 30, 2024.~~June 30, 2023."

12 **SECTION 1.2.** Section 1.29 of S.L. 2021-131 reads as rewritten:

13 "SECTION 1.29. Michael J. Rusher of Wake County is appointed to the North Carolina
