2 AN ACT TO APPOINT PERSONS TO VARIOUS PUBLIC OFFICES UPON THE  
3 RECOMMENDATION OF THE SPEAKER OF THE HOUSE OF REPRESENTATIVES  
4 AND THE PRESIDENT PRO TEMPORE OF THE SENATE.

5 Whereas, G.S. 120-121 authorizes the General Assembly to make certain  
6 appointments to public offices upon the recommendation of the Speaker of the House of  
7 Representatives and the President Pro Tempore of the Senate; and

8 Whereas, the Speaker of the House of Representatives and the President Pro Tempore  
9 of the Senate have made recommendations; Now, therefore,  
10 The General Assembly of North Carolina enacts:

18 **PART III. EFFECTIVE DATE**

19          **SECTION 3.** Unless otherwise provided, this act is effective when it becomes law.
