12	PART I. VIRTUAL EDUCATION		
13	<b>SECTION 1.(a)</b> G.S. 115C-84.3(c) reads as rewritten:		
14	"(c) Except as provided in <u>Part 3A of Article 16 of this Chapter or subsection</u> (b) of this		
15	section, a public school unit shall not use remote instruction to satisfy the minimum required		
16	number of instructional days or hours for the school calendar."		
17	<b>SECTION 1.(b)</b> Section 3(i) of S.L. 2021-130 reads as rewritten:		
18	"SECTION 3.(i) This section is effective when it becomes law and applies to-beginning		
19	with the 2021-2022 school year. This section is repealed June 30, 2022."

21	PART II. REMOTE ACADEMIES		
22	SECTION 2.(a) Article 16 of Chapter 115C of the General Statutes is amended by		
23	adding a new Part to read:		
24	"Part 3A. Remote Academies.		
25	" <u>§ 115C-234. Remote academies.</u>		
26	(a) <u>A local school administrative unit may apply to the State Board of Education for</u>		
27	approval of remote academies that meet the requirements of this Part.		
28	(b) <u>A remote academy is a public school whose instruction is provided primarily online</u>		
29	through a combination of synchronous and asynchronous instruction delivered to students in a		
30	remote location outside of the school facility. A remote academy may include any combination		
31	of grade levels.		
32	(c) Notwithstanding G.S. 115C-84.3, a remote academy approved by the State Board of		
33	Education may satisfy the minimum required number of instructional days or hours for the school		
34	calendar through remote instruction.

4	PART III. CHARTER SCHOOL VIRTUAL EDUCATION
5	SECTION 3.(a) Notwithstanding G.S. 115C-84.3, as amended by this act, a charter
6	school that submitted a virtual instruction plan for the 2021-2022 school year to the Department
7	of Public Instruction may continue to provide virtual instruction in accordance with that plan for
8	the 2023-2024 school year.
9	SECTION 3.(b) Section 8.35 of S.L. 2014-100, as amended by Section 8.13 of S.L.
10	2016-94 and Section 7.13 of S.L. 2018-5, reads as rewritten:
11	"SECTION 8.35.(a) Notwithstanding G.S. 115C-218.5 or any other provision of law to the
12	contrary, the State Board of Education shall establish a pilot program to authorize the operation
13	of two virtual charter schools serving students in kindergarten through twelfth grade. The State
14	Board shall establish an application process to allow student enrollment in the selected virtual
15	charter schools beginning with the 2015-2016 school year. A virtual charter school participating
16	in the pilot may serve any grade span of students in kindergarten through twelfth grade. The pilot
17	program shall continue for a period of eight-10 school years and shall end with the 2022-2023
18	<u>2024-2025</u> school year.

20	SECTION 3.(c) A virtual charter school that participated in the pilot program
21	authorized by Section 8.35 of S.L. 2014-100, as amended by Section 8.13 of S.L. 2016-94,
22	Section 7.13 of S.L. 2018-5, and this section, shall be eligible to apply to the State Board of
23	Education for a charter renewal as provided in G.S. 115C-218.6.

SECTION 4. Except as otherwise provided, this act is effective when it becomes law
and applies beginning with the 2022-2023 school year.
