1 A BILL TO BE ENTITLED
2 AN ACT REMOVING THE CAP ON SATELLITE ANNEXATIONS FOR THE CITY OF
3 SHELBY AND THE TOWNS OF STANLEY AND VASS.

4 The General Assembly of North Carolina enacts:

5 SECTION 1. G.S. 160A-58.1 reads as rewritten:

6 "§ 160A-58.1. Petition for annexation; standards.

7 ...

8 (b) A noncontiguous area proposed for annexation must meet all of the following
9 standards:

10 ...

11 (5) The area within the proposed satellite corporate limits, when added to the area
12 within all other satellite corporate limits, may not exceed ten percent (10%)
13 of the area within the primary corporate limits of the annexing city.

14 This subdivision does not apply to the Cities of Asheboro, Belmont,
15 Claremont, Concord, Conover, Durham, Elizabeth City, Gastonia, Greenville,
16 Hickory, Kannapolis, Locust, Marion, Mount Airy, Mount Holly, New Bern,
17 Newton, Oxford, Randleman, Roanoke Rapids, Rockingham, Saluda,
18 Sanford, Salisbury, Shelby, Southport, Statesville, and Washington and the
19 Towns of Ahoskie, Angier, Apex, Ayden, Benson, Bladenboro, Bridgeton,
20 Bunn, Burgaw, Calabash, Carthage, Catawba, China Grove, Clayton,
21 Columbia, Columbus, Cramerton, Creswell, Dallas, Dobson, Four Oaks,
22 Franklin, Franklinton, Fuquay-Varina, Garner, Godwin, Granite Quarry,
23 Green Level, Grimesland, Harrisburg, Holly Ridge, Holly Springs,
24 Hookerton, Hope Mills, Huntersville, Jamestown, Kenansville, Kenly,
25 Knightdale, Landis, Leland, Lillington, Louisburg, Maggie Valley, Maiden,
26 Mayodan, Maysville, Middlesex, Midland, Mocksville, Morrisville, Mount
27 Pleasant, Nashville, Oak Island, Ocean Isle Beach, Pembroke, Pine Level,
28 Pollocksville, Princeton, Ranlo, Richlands, Rolesville, Rutherfordton,
29 Shallotte, Siler City, Smithfield, Spencer, Spring Lake, Stanley, Stem, Stovall,
30 Surf City, Swansboro, Taylorsville, Troutman, Troy, Vass, Wallace, Warsaw,
31 Watha, Waynesville, Weldon, Wendell, West Jefferson, Wilson's Mills,
32 Windsor, Yadkinville, Youngsville, and Zebulon.
