Short Title: School Cal Flexibility/Yadkin & Davie Co. (Local)

1 A BILL TO BE ENTITLED
2 AN ACT TO ALLOW YADKIN COUNTY SCHOOLS AND DAVIE COUNTY SCHOOLS
3 TO ALIGN THEIR SCHOOL CALENDARS WITH SURRY COUNTY COMMUNITY
4 COLLEGE'S OR DAVIDSON-DAVIE COMMUNITY COLLEGE'S CALENDAR.

5 The General Assembly of North Carolina enacts:

6 **SECTION 1.** G.S. 115C-84.2(d) reads as rewritten:

7 "(d) Opening and Closing Dates. – Local boards of education shall determine the dates of
8 opening and closing the public schools under subdivision (a)(1) of this section. Except for
9 year-round schools, the opening date for students shall be no earlier than the Monday closest to
10 August 26, and the closing date for students shall be no later than the Friday closest to June 11.
11 On a showing of good cause, the State Board of Education may waive the requirement that the
12 opening date for students be no earlier than the Monday closest to August 26 and may allow the
13 local board of education to set an opening date no earlier than the Monday closest to August 19,
14 to the extent that school calendars are able to provide sufficient days to accommodate anticipated
15 makeup days due to school closings. A local board may revise the scheduled closing date if
16 necessary in order to comply with the minimum requirements for instructional days or
17 instructional time. For purposes of this subsection, the term "good cause" means that schools in
18 any local school administrative unit in a county have been closed eight days per year during any
19 four of the last 10 years because of severe weather conditions, energy shortages, power failures,
20 or other emergency situations.

21 The required opening and closing dates under this subsection shall not apply to any school
22 that a local board designated as having a modified calendar for the 2003-2004 school year or to
23 any school that was part of a planned program in the 2003-2004 school year for a system of
24 modified calendar schools, so long as the school operates under a modified calendar.

25 Notwithstanding the required opening and closing dates under this subsection, a local board
26 of education may align the calendar of schools in the local school administrative unit with the
27 calendar of a community college serving in the city or county in which the unit is located."

28 **SECTION 2.** This act applies only to Yadkin County Schools and Davie County
29 Schools.

30 **SECTION 3.** This act is effective when it becomes law and applies beginning with
31 the 2023-2024 school year.
