4 The General Assembly of North Carolina enacts:

6 **PART I. MEDICAID**

7
8 **NC HEALTH WORKS**

9 **SECTION 1.1.(a)** Section 3 of S.L. 2013-5 is repealed.

10 **SECTION 1.1.(b)** G.S. 108A-54.3A is amended by adding a new subdivision to
11 read:

12 "(24) Individuals described in section 1902(a)(10)(A)(i)(VIII) of the Social Security
13 Act who are in compliance with any work requirements established in the
14 State Plan and in rule. Coverage for individuals under this subdivision is
15 available through an Alternative Benefit Plan that is established by the
16 Department consistent with federal requirements, unless that individual is
17 exempt from mandatory enrollment in an Alternative Benefit Plan under 42
18 C.F.R. § 440.315."

19 **SECTION 1.1.(c)** Subsection (b) of this section is effective on the later of the
20 following dates:

- 21 (1) The date approved by the Centers for Medicare and Medicaid Services (CMS)
22 for Medicaid coverage to begin in North Carolina for individuals described in
23 section 1902(a)(10)(A)(i)(VIII) of the Social Security Act.
24 (2) The date the Current Operations Appropriations Act for the 2023-2024 fiscal
25 year becomes law.

26 **SECTION 1.1.(d)** The Secretary of the Department of Health and Human Services
27 shall notify the Fiscal Research Division and the Revisor of Statutes of the date approved by
28 CMS for Medicaid coverage to begin in North Carolina for individuals described in section
29 1902(a)(10)(A)(i)(VIII) of the Social Security Act.

30 **SECTION 1.2.(a)** Part 6 of Article 2 of Chapter 108A of the General Statutes is
31 amended by adding two new sections to read:

32 "**§ 108A-54.3B. Nonfederal share of NC Health Works costs.**

33 (a) As used in this section, the following definitions apply:

- 34 (1) Cost. – All expenses incurred by the State and counties that are eligible for
35 Medicaid federal financial participation.

- 1 (2) NC Health Works. – The provision of Medicaid coverage to the individuals
2 described in G.S. 108A-54.3A(24).
- 3 (b) It is the intent of the General Assembly to fully fund the nonfederal share of the cost
4 of NC Health Works through a combination of the following sources:
- 5 (1) Increases in revenue from the gross premiums tax under G.S. 105-228.5 due
6 to NC Health Works.
- 7 (2) Excluding any State retention, the increases in intergovernmental transfers
8 due to NC Health Works.
- 9 (3) Excluding any State retention, the hospital health advancement assessments
10 under Part 3 of Article 7B of Chapter 108A of the General Statutes.
- 11 (4) Savings to the State attributable to NC Health Works that correspond to State
12 General Fund budget reductions to other State programs.
- 13 (c) By February 1 of each year, beginning in 2025, the Department shall submit a report
14 to the Joint Legislative Oversight Committee on Medicaid, the Office of State Budget and
15 Management, and the Fiscal Research Division containing all of the following information with
16 supporting calculations:
- 17 (1) The total nonfederal share of the cost of NC Health Works for the preceding
18 State fiscal year and the total funding available from the sources described in
19 subsection (b) of this section.
- 20 (2) The projected total nonfederal share of the cost of NC Health Works for the
21 current State fiscal year and the total projected funding available from the
22 sources described in subsection (b) of this section.
- 23 (3) The method used by the Department to determine the amount of the health
24 advancement assessments proceeds that were distributed to each county
25 department of social services in compliance with G.S. 108A-147.13(b) for the
26 preceding fiscal year, including the total amount of proceeds each county
27 received in that fiscal year.
- 28 (4) The savings and benefits to the State resulting from NC Health Works for the
29 preceding fiscal year, including savings to various State agencies and
30 programs.
- 31 The Department shall submit detailed data supporting any calculations contained in the report
32 to the Fiscal Research Division.
- 33 (d) If, for any fiscal year, the nonfederal share of the cost of NC Health Works cannot be
34 fully funded through the sources described in subsection (b) of this section, then Medicaid
35 coverage for the category of individuals described in G.S. 108A-54.3A(24) shall be discontinued
36 as expeditiously as possible. Upon a determination by the Secretary that the nonfederal share of
37 the cost of NC Health Works exceeds the funding from the sources described in subsection (b)
38 of this section, the Secretary shall promptly do all of the following:
- 39 (1) Notify the Joint Legislative Oversight Committee on Medicaid, the Office of
40 State Budget and Management, and the Fiscal Research Division of the
41 determination and post this notice on the Department's website. The notice
42 must include the proposed effective date of the discontinuation of coverage.
- 43 (2) Submit all documents to the Centers for Medicare and Medicaid Services
44 necessary to discontinue Medicaid coverage for the category of individuals
45 described in G.S. 108A-54.3A(24).

46 **"§ 108A-54.3C. NC Health Works federal financial participation.**

47 If the federal medical assistance percentage for Medicaid coverage provided to the category
48 of individuals described in G.S. 108A-54.3A(24) falls below ninety percent (90%), then
49 Medicaid coverage for this category of individuals shall be discontinued as expeditiously as
50 possible but no earlier than the date the lower federal medical assistance percentage takes effect.

1 Upon receipt of information indicating that the federal medical assistance percentage will be
2 lower than ninety percent (90%), the Secretary shall promptly do all of the following:

- 3 (1) Notify the Joint Legislative Oversight Committee on Medicaid, the Office of
4 State Budget and Management, and the Fiscal Research Division of the
5 determination and post this notice on the Department's website. The notice
6 must include the proposed effective date of the discontinuation of coverage.
7 (2) Submit all documents to the Centers for Medicare and Medicaid Services
8 necessary to discontinue Medicaid coverage for the category of individuals
9 described in G.S. 108A-54.3A(24)."

10 **SECTION 1.2.(b)** This section is effective on the later of the following dates:

- 11 (1) The date approved by the Centers for Medicare and Medicaid Services (CMS)
12 for Medicaid coverage to begin in North Carolina for individuals described in
13 section 1902(a)(10)(A)(i)(VIII) of the Social Security Act.
14 (2) The date the Current Operations Appropriations Act for the 2023-2024 fiscal
15 year becomes law.
16

17 **ARPA TEMPORARY SAVINGS FUND**

18 **SECTION 1.3.(a)** The ARPA Temporary Savings Fund is established as a
19 nonreverting special fund in the Department of Health and Human Services, Division of Health
20 Benefits (DHB). The ARPA Temporary Savings Fund shall consist of any savings realized by
21 DHB as a result of federal receipts arising from the enhanced federal medical assistance
22 percentage (FMAP) available to the State under section 9814 of the American Rescue Plan Act
23 of 2021, P.L. 117-2 (ARPA). Upon receipt by DHB of any federal receipts arising from that
24 enhanced FMAP, DHB is directed to deposit the savings associated with those receipts into the
25 ARPA Temporary Savings Fund. Funds in the ARPA Temporary Savings Fund may be allocated
26 or expended only upon an act of appropriation by the General Assembly.

27 **SECTION 1.3.(b)** This section expires 10 years after the date this act becomes law.

28 **SECTION 1.3.(c)** This section is effective on the date the Current Operations
29 Appropriations Act for the 2023-2024 fiscal year becomes law.
30

31 **HEALTHCARE ACCESS AND STABILIZATION PROGRAM**

32 **SECTION 1.4.** Article 7B of Chapter 108A of the General Statutes is amended by
33 adding a new Part to read:

34 "Part 4. Healthcare Access and Stabilization Program.

35 "§ 108A-148.1. Healthcare access and stabilization program.

36 (a) The healthcare access and stabilization program is a directed payment program that
37 provides acute care hospitals with increased reimbursements funded through hospital
38 assessments in accordance with this section.

39 (b) The Department shall submit a 42 C.F.R. § 438.6(c) preprint requesting approval for
40 the HASP program that includes any required demonstration for the financing of the nonfederal
41 share of the HASP program costs. The Department shall not make any HASP directed payments
42 prior to CMS approval of the initial preprint. The Department may not request any date of service
43 for claims eligible for reimbursement through the HASP program earlier than July 1, 2022. The
44 Department shall continue to submit any necessary documentation requesting continued approval
45 for the HASP program as described in this section in the time and manner as required by CMS.

46 (c) All State funds required to make HASP directed payments shall be derived from
47 HASP components of the hospital assessments under this Article, subject to all of the following
48 limitations:

- 49 (1) If the Department determines that the HASP components under this Article
50 will not generate funds in an amount equal to or greater than the total State
51 funds required to make all HASP directed payments in any given quarter of

1 the State fiscal year, then the Department shall reduce the amount of the HASP
2 directed payments in the lowest amount necessary to ensure that the HASP
3 components under this Article will generate enough funds to equal the total
4 State funds required to make all the HASP directed payments in that quarter.

5 (2) If the aggregate amount of all assessments due from hospitals under this
6 Article are determined by the Department to exceed the permissible limit
7 established under 42 C.F.R. § 433.68(f) in any quarter of the State fiscal year,
8 then the Department shall reduce the amount of the HASP directed payments
9 in the lowest amount necessary to ensure that these hospital assessments in
10 aggregate do not exceed the permissible limit.

11 (d) As part of the preprint submission required under this section, for the 2022-2023 State
12 fiscal year, the Department shall not request any amount of HASP hospital reimbursements that
13 is greater than the maximum amount allowable under 42 C.F.R. § 438.6(c). Beginning with the
14 2023-2024 State fiscal year, the Department shall not request any amount of HASP hospital
15 reimbursements that is (i) greater than the maximum amount allowable under 42 C.F.R. §
16 438.6(c) or (ii) less than an annual estimated total dollar amount of three billion two hundred
17 million dollars (\$3,200,000,000) for services provided to not newly eligible individuals."

18 **ASSESSMENTS FOR HEALTH ADVANCEMENT AND THE HASP PROGRAM**

19 **SECTION 1.5.(a)** For purposes of this section, the following terms have the same
20 definition as in G.S. 108A-145.3: acute care hospital, critical access hospital, and hospital costs.
21 For the State fiscal quarter beginning October 1, 2023, each acute care hospital, except for critical
22 access hospitals, is subject to an assessment of a percentage of its hospital costs. This hospital
23 assessment shall be imposed by the Department of Health and Human Services (DHHS) in
24 accordance with the procedures for hospital assessments under Part 1 of Article 7B of Chapter
25 108A of the General Statutes. DHHS shall calculate the hospital assessment percentage by
26 dividing twelve million eight hundred thousand dollars (\$12,800,000) by the total hospital costs
27 for all acute care hospitals except for critical access hospitals. From the proceeds of this
28 assessment, DHHS shall use the sum of four million dollars (\$4,000,000) to provide funding to
29 county departments of social services to support the counties with implementation of Section 1.1
30 of this act.

31 **SECTION 1.5.(b)** No later than March 1, 2024, DHHS shall submit to the Joint
32 Legislative Oversight Committee on Medicaid and the Fiscal Research Division a report that
33 details the amount of the proceeds from the assessment imposed in accordance with subsection
34 (a) of this section that DHHS provided to each county department of social services and the date
35 that those proceeds were provided to each county department of social services.

36 **SECTION 1.5.(c)** Subsection (a) of this section expires December 31, 2023.

37 **SECTION 1.5.(d)** This section is effective on the date that the Current Operations
38 Appropriations Act for the 2023-2024 fiscal year becomes law. If, by September 30, 2023, no
39 Current Operations Appropriations Act for the 2023-2024 fiscal year has become law, then this
40 section shall expire on that date.

41 **SECTION 1.6.(a)** G.S. 108A-145.3 reads as rewritten:

42 "§ 108A-145.3. Definitions.

43 The following definitions apply in this Article:

44 (1a) Actual nonfederal expenditures. – The nonfederal share for newly eligible
45 individuals multiplied by the amount of the Medicaid assistance payment
46 expenditures attributable to newly eligible individuals, inclusive of any
47 adjustments, reported by the Department to CMS on the Form CMS-64.

48 ~~(1b)~~(1b) Acute care hospital. – A hospital licensed in North Carolina that is not a
49 freestanding psychiatric hospital, a freestanding rehabilitation hospital, a
50 long-term care hospital, or a State-owned and State-operated hospital.

- 2 (4a) Consumer Price Index: All Urban Consumers. – The most recent Consumer
- 3 Price Index for All Urban Consumers for the South Region published by the
- 4 Bureau of Labor Statistics of the United States Department of Labor available
- 5 on March 1 of the previous State fiscal year.
- 6 (4b) Consumer Price Index: Medical Care. – The most recent Consumer Price
- 7 Index for All Urban Consumers for Medical Care, U.S. city average,
- 8 seasonally adjusted, published by the Bureau of Labor Statistics of the United
- 9 States Department of Labor.
- 10 ...
- 11 (5a) Current quarter. – The State fiscal quarter for which the assessment is being
- 12 calculated.
- 13 (6) FMAP. – Federal medical assistance percentage (FMAP).—percentage.
- 14 (6a) FMAP for newly eligible individuals. – The FMAP specified in 42 U.S.C. §
- 15 1396d(y)(1), expressed as a decimal.
- 16 (6b) FMAP for not newly eligible individuals. – The federal share of North
- 17 Carolina Medicaid service costs as calculated by the federal Department of
- 18 Health and Human Services in accordance with section 1905(b) of the Social
- 19 Security Act, in effect at the start of the applicable assessment quarter,
- 20 expressed as a decimal.
- 21 (6c) HASP directed payments. – Payments made by the Department to prepaid
- 22 health plans to be used for (i) increased reimbursements to hospitals under the
- 23 HASP program and (ii) the costs to prepaid health plans from the gross
- 24 premiums tax under G.S. 105-228.5 and the insurance regulatory charge under
- 25 G.S. 58-6-25 associated with those hospital reimbursements.
- 26 (6d) Healthcare access and stabilization program (HASP). – The directed payment
- 27 program providing increased reimbursements to acute care hospitals approved
- 28 by CMS and authorized by G.S. 108A-148.1.
- 29 ...
- 30 (7a) IGT. – Intergovernmental transfer.
- 31 ...
- 32 (12b) Newly eligible individual. – As defined in 42 C.F.R. § 433.204.
- 33 (12c) Nonfederal share for newly eligible individuals. – One minus the FMAP for
- 34 newly eligible individuals.
- 35 (12d) Nonfederal share for not newly eligible individuals. – One minus the FMAP
- 36 for not newly eligible individuals.
- 37"

38 **SECTION 1.6.(b)** Article 7B of Chapter 108A of the General Statutes is amended
39 by adding a new Part to read:

40 "Part 3. Health Advancement Assessments.

41 **"§ 108A-147.1. Public hospital health advancement assessment.**

42 (a) The public hospital health advancement assessment imposed under this Part shall
43 apply to all public acute care hospitals.

44 (b) The public hospital health advancement assessment shall be assessed as a percentage
45 of each public acute care hospital's hospital costs. The assessment percentage shall be calculated
46 quarterly by the Department in accordance with this Part. The percentage for each quarter shall
47 equal the aggregate health advancement assessment collection amount calculated under
48 G.S. 108A-147.3 multiplied by the public hospital historical assessment share and divided by the
49 total hospital costs for all public acute care hospitals holding a license on the first day of the
50 assessment quarter.

51 **"§ 108A-147.2. Private hospital health advancement assessment.**

1 (a) The private hospital health advancement assessment imposed under this Part shall
2 apply to all private acute care hospitals.

3 (b) The private hospital health advancement assessment shall be assessed as a percentage
4 of each private acute care hospital's hospital costs. The assessment percentage shall be calculated
5 quarterly by the Department in accordance with this Part. The percentage for each quarter shall
6 equal the aggregate health advancement assessment collection amount calculated under
7 G.S. 108A-147.3 multiplied by the private hospital historical assessment share and divided by
8 the total hospital costs for all private acute care hospitals holding a license on the first day of the
9 assessment quarter.

10 **"§ 108A-147.3. Aggregate health advancement assessment collection amount.**

11 (a) The aggregate health advancement assessment collection amount is an amount of
12 money that is calculated quarterly by adjusting the total nonfederal receipts for health
13 advancement calculated under subsection (b) of this section by (i) subtracting the health
14 advancement presumptive IGT adjustment component calculated under G.S. 108A-147.9, (ii)
15 adding the positive or negative health advancement IGT actual receipts adjustment component
16 calculated under G.S. 108A-147.10, and (iii) subtracting the positive or negative IGT share of
17 the reconciliation adjustment component calculated under G.S. 108A-147.11(b).

18 (b) The total nonfederal receipts for health advancement is an amount of money that is
19 calculated quarterly by adding all of the following:

20 (1) The presumptive service cost component calculated under G.S. 108A-147.5.

21 (2) The HASP health advancement component calculated under
22 G.S. 108A-147.6.

23 (3) The administration component calculated under G.S. 108A-147.7.

24 (4) The State retention component under G.S. 108A-147.9.

25 (5) The positive or negative health advancement reconciliation adjustment
26 component calculated under G.S. 108A-147.11(a).

27 **"§ 108A-147.4.** Reserved for future codification purposes.

28 **"§ 108A-147.5. Presumptive service cost component.**

29 (a) For every State fiscal quarter prior to the fiscal quarter in which G.S. 108A-54.3A(24)
30 becomes effective, the presumptive service cost component is zero.

31 (b) For the State fiscal quarter in which G.S. 108A-54.3A(24) becomes effective, the
32 presumptive service cost component is the product of forty-eight million seven hundred fifty
33 thousand dollars (\$48,750,000) multiplied by the number of months in that State fiscal quarter in
34 which G.S. 108A-54.3A(24) is effective during any part of the month.

35 (c) For the first State fiscal quarter after the State fiscal quarter in which
36 G.S. 108A-54.3A(24) becomes effective, the presumptive service cost component is one hundred
37 forty-six million two hundred fifty thousand dollars (\$146,250,000).

38 (d) For the second State fiscal quarter after the State fiscal quarter in which
39 G.S. 108A-54.3A(24) becomes effective, and for each State fiscal quarter thereafter, the
40 presumptive service cost component is an amount of money that is the greatest of the following:

41 (1) The prior quarter's presumptive service cost component amount.

42 (2) The prior quarter's presumptive service cost component amount increased by
43 a percentage that is the sum of each monthly percentage change in the
44 Consumer Price Index: Medical Care for the most recent three months
45 available on the first day of the current quarter.

46 (3) The prior quarter's presumptive service cost component amount increased by
47 the percentage change in the weighted average of the base capitation rates for
48 standard benefit plans for all rating groups associated with newly eligible
49 individuals compared to the prior quarter. The weight for each rating group
50 shall be calculated using member months documented in the Medicaid
51 managed care capitation rate certification for standard benefit plans.

1 (4) The prior quarter's presumptive service cost component amount increased by
2 the percentage change in the weighted average of the base capitation rates for
3 BH IDD tailored plans for all rating groups associated with newly eligible
4 individuals compared to the prior quarter. The weight for each rating group
5 shall be calculated using member months documented in the Medicaid
6 managed care capitation rate certification for BH IDD tailored plans.

7 (5) The amount produced from multiplying 1.15 by the highest amount produced
8 when calculating, for each quarter that is at least two and not more than five
9 quarters prior to the current quarter, the actual nonfederal expenditures for the
10 applicable quarter minus the HASP health advancement component calculated
11 under G.S. 108A-147.6 for the applicable quarter.

12 **"§ 108A-147.6. HASP health advancement component.**

13 The HASP health advancement component is an amount of money that is calculated by
14 multiplying the aggregate amount of HASP directed payments due to PHPs in the current quarter
15 for hospital reimbursements attributable to newly eligible individuals by the nonfederal share for
16 newly eligible individuals.

17 **"§ 108A-147.7. Administration component.**

18 (a) The administration component is an amount of money that is calculated by adding the
19 State administration subcomponent calculated under subsection (b) of this section and the county
20 administration subcomponent calculated under subsection (c) of this section.

21 (b) For each quarter of the 2022-2023 State fiscal year and the 2023-2024 State fiscal
22 year, the State administration subcomponent is the product of one million one hundred thousand
23 dollars (\$1,100,000) multiplied by the number of months in that State fiscal quarter in which
24 G.S. 108A-54.3A(24) is effective during any part of the month. For each quarter of the
25 2024-2025 State fiscal year, the State administration subcomponent is three million three hundred
26 thousand dollars (\$3,300,000) increased by the Consumer Price Index: All Urban Consumers.
27 For each subsequent State fiscal year, the State administration subcomponent shall be increased
28 over the prior year's quarterly amount by the Consumer Price Index: All Urban Consumers.

29 (c) For each quarter of the 2022-2023 State fiscal year and the 2023-2024 State fiscal
30 year, the county administration subcomponent is the product of one million six hundred
31 sixty-seven thousand dollars (\$1,667,000) multiplied by the number of months in that State fiscal
32 quarter in which G.S. 108A-54.3A(24) is effective during any part of the month. The county
33 administration subcomponent is seven million four hundred thousand dollars (\$7,400,000) for
34 each quarter of the 2024-2025 State fiscal year and seven million eight hundred thousand dollars
35 (\$7,800,000) for each quarter of the 2025-2026 State fiscal year. For each State fiscal year after
36 the 2025-2026 State fiscal year, the county administration subcomponent shall be increased over
37 the prior year's quarterly amount by the Consumer Price Index: All Urban Consumers.

38 **"§ 108A-147.8. State retention component.**

39 (a) For every State fiscal quarter prior to the fiscal quarter in which G.S. 108A-54.3A(24)
40 becomes effective, the State retention component is zero.

41 (b) For the State fiscal quarter in which G.S. 108A-54.3A(24) becomes effective, and
42 each State fiscal quarter thereafter, the State retention component is ten million seven hundred
43 fifty thousand dollars (\$10,750,000) for each assessment quarter.

44 **"§ 108A-147.9. Health advancement presumptive IGT adjustment component.**

45 (a) The health advancement presumptive IGT adjustment component is an amount of
46 money calculated by adding the public hospital health advancement IGT adjustment
47 subcomponent calculated under subsection (b) of this section, the UNC Health Care System
48 health advancement IGT adjustment subcomponent calculated under subsection (c) of this
49 section, and the East Carolina University health advancement IGT adjustment subcomponent
50 calculated under subsection (d) of this section.

1 (b) The public hospital health advancement IGT adjustment subcomponent is the total of
2 the following amounts:

- 3 (1) Sixty percent (60%) of the public hospital share of the sum of the presumptive
4 service cost component calculated under G.S. 108A-147.5 for the current
5 quarter, the administration component calculated under G.S. 108A-147.7 for the current
6 quarter, and the State retention component under G.S. 108A-147.8
7 for the current quarter. The public hospital share is the total hospital costs for
8 all public acute care hospitals divided by the total hospital costs for all acute
9 care hospitals except for critical access hospitals for the current quarter.
- 10 (2) Sixty percent (60%) of the nonfederal share for newly eligible individuals of
11 the aggregate amount of the HASP directed payments due to PHPs in the
12 current quarter for reimbursements to public acute care hospitals that are
13 attributable to newly eligible individuals.

14 (c) The UNC Health Care System health advancement IGT adjustment subcomponent is
15 the total of the following amounts:

- 16 (1) The UNC Health Care System share of the presumptive service cost
17 component calculated under G.S. 108A-147.5 for the current quarter and the
18 administration component calculated under G.S. 108A-147.7 for the current
19 quarter. The UNC Health Care System share is the total hospital costs for the
20 UNC Health Care System hospitals divided by the total hospital costs for all
21 acute care hospitals except for critical access hospitals for the current quarter.
- 22 (2) The nonfederal share for newly eligible individuals of the aggregate amount
23 of the HASP directed payments due to PHPs in the current quarter for
24 reimbursements to UNC Health Care System hospitals that are attributable to
25 newly eligible individuals.

26 (d) The East Carolina University health advancement IGT adjustment subcomponent is
27 the total of the following amounts:

- 28 (1) The East Carolina University share of the presumptive service cost component
29 calculated under G.S. 108A-147.5 for the current quarter and the
30 administration component calculated under G.S. 108A-147.7 for the current
31 quarter. The East Carolina University share is the total hospital costs for the
32 primary affiliated teaching hospital for the East Carolina University Brody
33 School of Medicine divided by the total hospital costs for all acute care

44 45 **DECREASE MEDICAID ENROLLMENT BURDEN ON COUNTY DEPARTMENTS OF** 46 **SOCIAL SERVICES**

47 **SECTION 1.8.(a)** Notwithstanding G.S. 108A-54(d) and in accordance with
48 G.S. 143B-24(b), the Department of Health and Human Services (DHHS) is authorized, on a
49 temporary basis to conclude no later than 12 months after the date approved by the Centers for
50 Medicare and Medicaid Services (CMS) for Medicaid coverage to begin in North Carolina for
51 individuals described in section 1902(a)(10)(A)(i)(VIII) of the Social Security Act, to utilize the

1 federally facilitated marketplace (Marketplace), also known as the federal health benefit
2 exchange, to make Medicaid eligibility determinations. In accordance with G.S. 108A-54(b),
3 these eligibility determinations shall be in compliance with all eligibility categories, resource
4 limits, and income thresholds set by the General Assembly.

5 **SECTION 1.8.(a1)** Notwithstanding G.S. 108A-54(d) and in accordance with
6 G.S. 143B-24(b), DHHS is authorized to make any necessary request to, or enter into any
7 agreement with, the Marketplace to facilitate the ability of the Marketplace to make Medicaid
8 eligibility determinations as soon as the use of the Marketplace for this purpose is authorized by
9 the General Assembly, as provided for under subsection (a) of this section.

10 **SECTION 1.8.(b)** G.S. 108A-25(b) reads as rewritten:

11 "(b) The program of medical assistance is established as a program of public assistance
12 and shall be administered by the Department of Health and Human Services in accordance with
13 G.S. 108A-54. Medicaid eligibility administration may be delegated to the county departments

16 **PART II. CREATING SEAMLESS WORKFORCE DEVELOPMENT**
17 **OPPORTUNITIES**

19 **COMPREHENSIVE WORKFORCE DEVELOPMENT PROGRAM**

20 **SECTION 2.1.(a)** No later than December 1, 2024, the Secretary of the Department
21 of Commerce (Secretary) shall develop a plan to create a seamless, statewide, comprehensive
22 workforce development program, bringing together new opportunities with the current workforce
23 development opportunities within the Department of Commerce (Commerce), the Department of
24 Labor (Labor), and other State agencies. The plan to create a seamless, statewide, comprehensive
25 workforce development program shall be developed in collaboration with the stakeholders
26 outlined in subsection (b) of this section. The Secretary may contract with third-party entities in
27 the development and implementation of the plan. As part of the plan, the Secretary shall strive to
28 ensure that all workforce development opportunities are available to participants statewide by
29 coordinating efforts and resources across State agencies.

30 The plan developed under this section shall include all of the following components:

- 31 (1) Identification of currently existing workforce development programs for
32 unemployed individuals or low-wage workers in this State and any gaps or
33 opportunities for improvement of those existing programs.
- 34 (2) Identification of the specific labor force needs within the State, specifically
35 including healthcare workforce needs.
- 36 (3) Identification of the specific needs of current and potential future workforce
37 development participants in order to achieve the goal of reducing the number
38 of people that are utilizing social service programs, including the North
39 Carolina Medicaid program.
- 40 (4) All of the following specific services shall be included in the plan:
 - 41 a. Job training assistance.
 - 42 b. Career paths and job readiness.
 - 43 c. Job placement.
 - 44 d. Resources for job seekers.
 - 45 e. Recruiting services.
 - 46 f. Healthcare workforce support.
- 47 (5) Measures by which to determine the success of the workforce development
48 programs, such as increases in participant earning capacity, greater economic
49 stability of participants, and self-sufficiency of participants.

50 **SECTION 2.1.(b)** As part of the development of the plan required under subsection
51 (a) of this section, the Secretary shall collaborate with the following entities:

- 1 (1) The Department of Labor.
- 2 (2) NCWorks.
- 3 (3) The North Carolina Community College System.
- 4 (4) The North Carolina Area Health Education Centers (AHEC).
- 5 (5) The Department of Public Instruction.
- 6 (6) The University of North Carolina.
- 7 (7) The Department of Health and Human Services (DHHS).
- 8 (8) Hospitals and healthcare providers licensed in the State.
- 9 (9) Prepaid health plans, as defined under G.S. 108D-1.
- 10 (10) The North Carolina nonprofit corporation with which the Department of
- 11 Commerce contracts pursuant to G.S. 143B-431.01(b).
- 12 (11) The North Carolina Chamber.
- 13 (12) Any North Carolina community organization with relevant expertise.
- 14 (13) Local workforce development boards.

15 **SECTION 2.1.(c)** No later than December 1, 2024, the Secretary of Commerce shall
16 report to the Joint Legislative Oversight Committee on General Government, the Joint
17 Legislative Oversight Committee on Health and Human Services, and the Joint Legislative
18 Oversight Committee on Medicaid regarding the plan required under subsection (a) of this
19 section. The report shall include, at a minimum, all of the following:

- 20 (1) The comprehensive plan developed in accordance with this section, including
21 the anticipated date of implementation.
- 22 (2) Identification of the entity within the Department of Commerce that will be
23 responsible for implementation of the plan.
- 24 (3) The workforce needs of North Carolina employers by industry, skill, required
25 education level, and geography.
- 26 (4) Existing workforce development gaps and opportunities for improvement.
- 27 (5) Workforce training infrastructure and needs.
- 28 (6) Any cost to the State to implement the plan and to continue successful
29 operation of the plan into the future.
- 30 (7) Any recommended legislation.

31 **SECTION 2.2.(a)** In collaboration with Commerce, the Department of Health and
32 Human Services (DHHS) shall develop a method by which to assist individuals enrolled in the
33 North Carolina Medicaid program and other relevant social service programs with accessing
34 appropriate workforce development services. DHHS shall develop a plan for assessing the
35 current employment status and any barriers to employment of newly enrolled Medicaid
36 beneficiaries, including the enrollees that will be newly eligible for Medicaid benefits under
37 Section 1.1 of this act, as well as newly enrolled participants in other relevant social service
38 programs. DHHS and Commerce shall work together to determine the best method by which
39 Medicaid beneficiaries and beneficiaries of other relevant social service programs will be
40 provided an initial assessment and consultation with a workforce development case manager, or
41 other similar professional, to ensure that interested individuals are able to fully participate in the
42 workforce development programs offered in this State. DHHS may contract with third-party
43 entities or prepaid health plans, as defined under G.S. 108D-1, to assist in providing these
44 services and may consider the use of incentives to prepaid health plans with regard to these
45 services.

46 **SECTION 2.2.(b)** No later than December 1, 2024, DHHS shall report to the Joint
47 Legislative Oversight Committee on Medicaid and to the Joint Legislative Oversight Committee
48 on Health and Human Services on the method determined to be best to provide Medicaid
49 beneficiaries and beneficiaries of other relevant social service programs an initial assessment and
50 consultation with a workforce development case manager, or other similar professional, as
51 required by subsection (a) of this section. The report shall include a time line for implementation

1 of that method and the annual cost to DHHS for both the initial implementation and ongoing
2 costs.

3 **SECTION 2.2.(c)** Beginning February 1, 2025, and for five years thereafter, DHHS,
4 in collaboration with Commerce, shall report no later than February 1 of each year to the Joint
5 Legislative Oversight Committee on Medicaid and to the Joint Legislative Oversight Committee
6 on Health and Human Services all of the following information:

- 7 (1) The total number of Medicaid beneficiaries and beneficiaries of other relevant
8 social service programs who have participated in workforce development,
9 including the number of individuals who completed an assessment by a
10 workforce development case manager or similar professional.
- 11 (2) A breakdown of the types of workforce development services or programs that
12 participants utilized, including specific information about the activities
13 participated in by beneficiaries of Medicaid and other relevant social service
14 programs.
- 15 (3) General demographic information for the beneficiaries of Medicaid and other
16 relevant social service programs who participated in workforce development
17 programs.
- 18 (4) The average length of time individuals who participated in workforce
19 development programs and were eligible for Medicaid benefits or benefits
20 under other beneficiaries of Medicaid and other relevant social service
21 programs remained eligible for those benefits.
- 22 (5) The number of individuals who were employed or reemployed in a position
23 providing higher wages as a result of participation in a workforce development
24 program.
- 25 (6) The number of individuals who were no longer qualified for Medicaid or any
26 other relevant social service program due to obtaining gainful employment or
27 higher wages as a result of participation in any workforce development
28 program.

30 **NOTICE TO MEDICAID BENEFICIARIES OF HEALTH INSURANCE**
31 **MARKETPLACE**

32 **SECTION 2.3.(a)** The General Assembly finds that awareness of, and assistance
33 with, enrollment in health benefit coverage on the federal Health Insurance Marketplace will
34 alleviate the false perception that the loss of Medicaid coverage equals an immediate loss of
35 access to healthcare. In order to counteract any disincentive to obtaining employment or
36 increasing income that this false perception may bring and in order to facilitate a smoother
37 transition of health benefit coverage from Medicaid to private insurance, the Department of
38 Health and Human Services, Division of Health Benefits (DHB), shall work with the NC

44 minimum, and no later than January 1, 2024, DHB shall provide all Medicaid applicants written
45 or electronic notification about the Health Insurance Marketplace that includes contact
46 information for the NC Navigators Consortium. Written or electronic notification about the
47 Health Insurance Marketplace that includes contact information for the NC Navigators
48 Consortium shall also be provided to all Medicaid recipients except those recipients qualifying
49 under subdivision (14), (17), (18), (19), or (20) of G.S. 108A-54.3A upon each redetermination
50 and upon termination from the Medicaid program.

1 **SECTION 2.3.(b)** No later than March 1, 2024, DHB shall report to the Joint
2 Legislative Oversight Committee on Medicaid all of the following information:

- 3 (1) Details of the mechanism, developed in accordance with subsection (a) of this
4 section, to assist a Medicaid recipient who is transitioning from qualifying for
5 the Medicaid program to qualifying for premium or cost-sharing assistance
6 for health insurance obtained on the Health Insurance Marketplace, or who
7 could reasonably be determined to be eligible for that premium or cost-sharing
8 assistance in the near future, with that transition by a qualified Navigator or
9 similar professional.
- 10 (2) Specific details on the written notification being provided to all Medicaid
11 applicants and certain Medicaid recipients, as required by subsection (a) of
12 this section.

13 **PURSUIT OF MEDICAID WORK REQUIREMENTS**

14 **SECTION 2.4.** If there is any indication that work requirements as a condition of
15 participation in the Medicaid program may be authorized by the Centers for Medicare and
16 Medicaid Services (CMS), then the Department of Health and Human Services, Division of
17 Health Benefits (DHB), shall enter into negotiations with CMS to develop a plan for those work
18 requirements and to obtain approval of that plan. Within 30 days of entering into negotiations
19 with CMS pursuant to this section, DHB shall notify, in writing, the Joint Legislative Oversight
20 Committee on Medicaid (JLOC) and the Fiscal Research Division (FRD) of these negotiations.
21 Within 30 days of approval by CMS of a plan for work requirements as a condition of
22 participation in the Medicaid program, DHB shall submit a report to JLOC and FRD containing
23 the full details of the approved work requirements, including the approved date of
24 implementation of the requirements.

46 equipment shall be included. The capital expenditure for the equipment shall
47 be deemed to be the fair market value of the equipment or the cost of the
48 equipment, whichever is greater. Beginning September 30, 2022, and on

September 30 each year thereafter, the cost threshold amount in this subdivision shall be adjusted using the Medical Care Index component of the Consumer Price Index published by the U.S. Department of Labor for the 12-month period preceding the previous September 1.

(9b) Health service facility. – A hospital; long-term care hospital; ~~psychiatric facility;~~ rehabilitation facility; nursing home facility; adult care home; kidney disease treatment center, including freestanding hemodialysis units; intermediate care facility for individuals with intellectual disabilities; home health agency office; ~~chemical dependency treatment facility;~~ diagnostic center; hospice office, hospice inpatient facility, hospice residential care facility; and ambulatory surgical facility.

(9c) Health service facility bed. – A bed licensed for use in a health service facility in the categories of (i) acute care beds; ~~(ii) psychiatric beds;~~ (iii) rehabilitation beds; (iv) nursing home beds; (v) intermediate care beds for individuals with intellectual disabilities; ~~(vi) chemical dependency treatment beds;~~ ~~(vii) hospice inpatient facility beds;~~ (viii) hospice residential care facility beds; (ix) adult care home beds; and (x) long-term care hospital beds.

...

(22a) Replacement equipment. – Equipment that costs less than ~~two million dollars (\$2,000,000)~~ three million dollars (\$3,000,000) and is purchased for the sole purpose of replacing comparable medical equipment currently in use which will be sold or otherwise disposed of when replaced. In determining whether the replacement equipment costs less than ~~two million dollars (\$2,000,000),~~ three million dollars (\$3,000,000) the costs of equipment, studies, surveys, designs, plans, working drawings, specifications, construction, installation, and other activities essential to acquiring and making operational the replacement equipment shall be included. The capital expenditure for the equipment shall be deemed to be the fair market value of the equipment or the cost of the equipment, whichever is greater. Beginning September 30, 2023, and on September 30 each year thereafter, the cost threshold amount in this subdivision shall be adjusted using the Medical Care Index component of the Consumer Price Index published by the U.S. Department of Labor for the 12-month period preceding the previous September 1.

3 ~~Substance Abuse Services, one or more of the area mental health,~~
4 ~~developmental disabilities, and substance abuse authorities, or a combination~~
5 ~~thereof to provide psychiatric beds to patients referred by the contracting~~
6 ~~agency or agencies.~~

7 (2) ~~The total number of beds to be converted shall not be more than twice the~~
8 ~~number of beds for which the contract pursuant to subdivision (1) of this~~

 11 any other new institutional health service other than that allowed in
 12 G.S. 131E-176(16)b.
 13 (3) The licensed health service facility proposing to incur the capital expenditure
 14 shall provide prior written notice to the Department, along with supporting
 15 documentation to demonstrate that it meets the exemption criteria of this
 16 subsection.

20 (a) Inpatient chemical dependency or substance abuse facilities that provide services

 23 shall be exempt from licensure by the Department of Health and Human Services under Chapter

 25 provides services both to inmates or offenders under supervision and to members of the general

Major medical equipment does not include replacement equipment as defined in this ~~section~~ section or magnetic resonance imaging scanners in counties with a population greater than 125,000 according to the 2020 federal decennial census or any subsequent federal decennial census. Beginning September 30, 2022, and on September 30 each year thereafter, the cost threshold amount in this subdivision shall be adjusted using the Medical Care Index component of the Consumer Price Index published by the U.S. Department of Labor for the 12-month period preceding the previous September 1.

7. Magnetic resonance imaging scanner. This sub-sub-subdivision applies only to counties with a population of 125,000 or less according to the 2020 federal decennial census or any subsequent federal decennial census.
8. Positron emission tomography scanner.
9. Simulator.

SECTION 3.3.(b) Subsection (a) of this section becomes effective three years from the date the Department of Health and Human Services (DHHS) issues the first directed payment in accordance with the Healthcare Access and Stabilization Program (HASP) under G.S. 108A-148.1, as enacted by Section 1.4 of this act, and applies to activities occurring on or after that date. The Secretary of Health and Human Services shall notify the Revisor of Statutes when DHHS has issued the first directed payment in accordance with HASP and the date of issuance. If the DHHS has not made any HASP directed payments by June 30, 2025, then subsection (a) of this section shall expire on that date.
