G.S. 90-108 reads as rewritten: 8 "§ 90-108. Prohibited acts; penalties. 9 It shall be unlawful for any person: (a) 10 . . . 11 (12)To make, distribute, or possess any punch, die, plate, stone, or other thing 12 designed to print, imprint, or reproduce the trademark, trade name, or other identifying mark, imprint, or device of another or any likeness of any of the 13 14 foregoing upon any drug or container or labeling thereof so as to render such 15 drug a counterfeit controlled substance. To possess any three-neck round-bottom flask, tableting machine, 16 (12a)encapsulating machine, or gelatin capsule, or any equipment, chemical, 17 18 product, or material which may be used to manufacture a controlled substance 19 or listed chemical, knowing, intending, or having reasonable cause to believe 20 that it will be used to manufacture a controlled substance. This subdivision 21 shall not apply to a pharmacy, a pharmacist, a pharmacy technician, or a 22 pharmacy intern licensed or permitted under Article 4A of Chapter 90 of the 23 General Statutes possessing any item included in this subdivision utilized in 24 the compounding, dispensing, delivering, or administering of a controlled 25 substance pursuant to a prescription. (12b) To manufacture, distribute, export, or import any three-neck round-bottom 26 27 flask, tableting machine, encapsulating machine, or gelatin capsule, or any equipment, chemical, product, or material which may be used to manufacture 28 a controlled substance or listed chemical, knowing, intending, or having 29 reasonable cause to believe that it will be used to manufacture a controlled 30 31 substance. This subdivision shall not apply to a pharmacy, a pharmacist, a 32 pharmacy technician, or a pharmacy intern licensed or permitted under Article 33 4A of Chapter 90 of the General Statutes in the compounding, dispensing, delivering, or administering of a controlled substance pursuant to a 34 35 prescription.
