Short Title: Mickey's Freedom Restoration Act. (Public)

Sponsors: Senators Garrett, Chaudhuri, and Batch (Primary Sponsors).

Referred to:

1 A BILL TO BE ENTITLED  
2 AN ACT TO CREATE A STUDY COMMISSION TO DEVELOP A PLAN TO ATTRACT  
3 FAMILY AMUSEMENT PARKS TO THE STATE.

4 Whereas, some state governments have recently begun to prioritize "culture war"  
5 politics over economic development; and

6 Whereas, North Carolina has proven to be a stable and vibrant environment for  
7 businesses, both large and small, to flourish; and

8 Whereas, the state government of North Carolina and its elected leaders from both  
9 political parties have prioritized economic development for the benefit of its citizens; and

10 Whereas, North Carolina seeks to further strengthen its tourism and entertainment  
11 industries by welcoming businesses considering relocation; and

12 Whereas, Bob Iger, the chief executive officer of the Walt Disney Company, called  
13 actions taken by the state government of Florida "anti-business," on April 3, 2023; Now,  
14 therefore,

15 The General Assembly of North Carolina enacts:

16 **SECTION 1.** Commission Created. – The North Carolina Family Amusement Park  
17 Study Commission (the "Commission") is created.

18 **SECTION 2.** Purpose. – The purpose of the Commission is to develop strategies that  
19 encourage family amusement parks (family parks) to locate in tier one counties by:

- 20 (1) Studying and consulting major family parks outside of the State to determine  
21 (i) the amount of interest among family parks to expand into the State, (ii) the  
22 priorities of family parks when considering an expansion into a new state, and  
23 (iii) any other information relevant to developing a plan that recruits family  
24 parks and encourages them to expand into the State.  
25 (2) Coordinating with relevant State and local governments and agencies,  
26 including the Department of Commerce, the Department of Transportation,  
27 and the Economic Development Partnership of North Carolina, to develop  
28 strategic economic incentive plans designed to encourage family parks to  
29 expand or relocate into the State.

30 **SECTION 3.** Membership. – The Commission shall consist of 11 members. The  
31 Governor shall appoint five members to the Commission, the Speaker of the House of  
32 Representatives shall appoint two members, the President Pro Tempore of the Senate shall  
33 appoint two members, the Secretary of Commerce shall appoint one member, and the Secretary  
34 of Transportation shall appoint one member. In the event a vacancy occurs on the Commission,  
35 the appointing authority that appointed the member that created the vacancy shall appoint a  
36 replacement.

1           **SECTION 4.** Expenses of Members. – Members of the Commission shall receive  
2 per diem, subsistence, and travel allowances in accordance with G.S. 120-3.1, 138-5, or 138-6,  
3 as appropriate.

4           **SECTION 5.** Cochairs; Meetings. – The President Pro Tempore of the Senate shall  
5 designate one Senator as cochair and the Speaker of the House of Representatives shall designate  
6 one Representative as cochair of the Commission from among the respective appointees. The  
7 Commission shall meet upon the call of the cochairs. A majority of the members of the  
8 Commission shall constitute a quorum. The Commission may meet in the Legislative Building  
9 or in the Legislative Office Building.

10          **SECTION 6.** Staff. – The Legislative Services Officer shall assign professional staff  
11 to assist the Commission in its work. The Senate's and the House of Representatives' Directors  
12 of Legislative Assistants shall assign clerical staff to the Commission, and the expenses relating  
13 to the clerical employees shall be borne by the Commission.

14          **SECTION 7.** Powers. – The Commission, while in the discharge of its official duties,  
15 may exercise all powers provided for under G.S. 120-19 and G.S. 120-19.4. All State  
16 departments and agencies and local governments and their subdivisions shall furnish the  
17 Commission with any information in the possession or available to them.

18          **SECTION 8.** Report. – The Commission shall submit a final report of its findings  
19 and recommendations by July 1, 2024, to the Joint Legislative Economic Development and  
20 Global Engagement Oversight Committee. The report may include draft legislation to implement  
21 its recommendations, along with an analysis of the fiscal impact of each recommendation. The  
22 Commission shall terminate upon filing its report.

23          **SECTION 9.** Appropriation. – There is appropriated from the General Fund to the  
24 North Carolina Family Amusement Park Study Commission the sum of seven hundred fifty  
25 thousand dollars (\$750,000) for the 2023-2024 fiscal year for the cost of the Commission  
26 performing its work under this act.

27          **SECTION 10.** This act becomes effective July 1, 2023.
