G.S. 45-21.12A reads as rewritten: 6 "§ 45-21.12A. Power of sale barred during periods of military service. 7 Power of Sale Barred. - A mortgagee, trustee, or other creditor shall not exercise a (a) 8 power of sale contained in a mortgage or deed of trust, or provided by statute, during, or within 9 90-365 days after, a mortgagor's, trustor's, or debtor's period of military service. The clerk of 10 court shall not conduct a hearing pursuant to G.S. 45-21.16(d) unless the mortgagee, trustee or other creditor seeking to exercise a power of sale under a mortgage or deed of trust, or provided 11 by statute, files with the clerk a certification that the hearing will take place at a time that is not 12 during, or within 90-365 days after, a period of military service for the mortgagor, trustor or 13 14 debtor. This subsection applies only to mortgages and deeds of trust that originated before the 15 mortgagor's or trustor's period of military service. Waiver. - This section shall not apply if the mortgagor, trustor, or debtor waives his (b) or her rights under this section pursuant to a written agreement of the parties executed during or after the mortgagor's, trustor's, or debtor's period of military service, as an instrument separate from the obligation or liability to which the waiver applies. Any waiver in writing of a right or protection provided by this section must be in at least 12 point type and shall specify the legal instrument creating the obligation or liability to which the waiver applies. Purpose. - The purpose of this section is to supplement and complement the (c) provisions of the Servicemembers Civil Relief Act, 50 U.S.C. App. § 501, et seq., and to afford greater peace and security for persons in federal active duty. Definitions. – The following definitions apply in this section: (d) Military service. -(1)In the case of a member of the United States Army, Navy, Air Force, a.

14	SECTION 2. This act becomes effective December 1, 2023, and applies to notices
15	of hearings filed on or after that date.
