31	shall be posted with the clerk of superior court. The defendant shall also deposit the same amount				
32	with the clerk of superior court every 30 days thereafter until the litigation is resolved, unless the				
33	defendant requests a hearing no less than five business days prior to the expiration of a 30-day				
34	period. If the defendant fails to deposit the funds within five business days of the initial hearing,				
35	or five business days of the expiration of a 30-day period, the animal is forfeited by operation of

1 law. If funds have been deposited in accordance with this section, the operator of the animal

- 2 shelter may draw from the funds the actual costs incurred in caring for the animal.
- 3 In the event of forfeiture, the animal shelter may shall determine whether the animal is
- 4 suitable for adoption and whether adoption can be arranged for the animal. The animal may not
- 5 be adopted by the defendant or by any person residing in the defendant's household. If the adopted
- 6 animal is a dog used for fighting, the animal shelter shall notify any persons adopting the dog of
- 7 the liability provisions for owners of dangerous dogs under Article 1A of Chapter 67 of the
- 8 General Statutes. If no adoption can be arranged after the forfeiture, or the animal is unsuitable
- 9 for adoption, the shelter shall humanely euthanize the animal."
  10 SECTION 2. This act becomes effective October 1, 2023.
