2	AN ACT TO PROVIDE THAT REGULAR MUNICIPAL ELECTIONS FOR
3	MUNICIPALITIES IN HENDERSON, POLK, AND RUTHERFORD COUNTIES ARE
4	HELD IN EVEN-NUMBERED YEARS; TO EXTEND THE TERMS OF THE MAYOR IN
5	THE TOWN OF TRYON AND ALL ELECTED OFFICERS IN THE TOWN OF RUTH
6	FROM TWO TO FOUR YEARS; AND TO PROVIDE FOR FOUR-YEAR TERMS OF
7	OFFICE FOR ALL MEMBERS OF THE POLK COUNTY BOARD OF
8	COMMISSIONERS.
9	The General Assembly of North Carolina enacts:

11	PART I. MUNICIPALITIES IN HENDERSON COUNTY
12	SECTION 1.1.(a) Chapter III of the Charter of the Village of Flat Rock, being
13	Chapter 48 of the 1995 Session Laws, reads as rewritten:
14	"CHAPTER III.
15	"GOVERNING BODY.
16	
17	"Sec. 3.3. Term of Office of Council Members. In the 1995 municipal election, two Two
18	members shall be elected from each electoral district. In each electoral district in 1995, the person
19	receiving the highest number of votes is elected to a four-year term, and the person receiving the
20	next highest number of votes is elected to a two-year term. In 1997 and biennially thereafter, one
21	person is elected from each electoral district for a staggered four-year term.terms.
22	"Sec. 3.4. Election of Mayor; Term of Office. The qualified voters of the entire Village
23	elect the Mayor. A-Mayor shall be elected in 1995 and quadrennially thereafter for a four-year
24	term."
25	SECTION 1.1.(b) Section 4.1 of the Charter of the Village of Flat Rock, being
26	Chapter 48 of the 1995 Session Laws, reads as rewritten:
27	"Sec. 4.1. Conduct of Village Elections. Regular municipal elections shall be held at the
28	time of the general election in each even-numbered year. Village officers shall be elected on a
29	nonpartisan basis and results determined by the primary method as provided in G.S. 163-294.
30	Except as otherwise provided by this act, the election shall be conducted in accordance with the
31	uniform municipal election laws in Chapter 163 of the General Statutes."
32	SECTION 1.1.(c) No municipal elections shall be conducted in the Village of Flat
33	Rock in 2023. The terms of the Mayor and the three Council members serving on the effective
34	date of this act whose terms are set to expire in 2023 shall be extended by one year. The terms of

Regular municipal elections shall be conducted in the 3 Village of Flat Rock in even-numbered years beginning in 2024. 4 **SECTION 1.1.(d)** In 2024 and quadrennially thereafter, a mayor and one Council 5 member from each electoral district shall be elected to serve four-year terms. In 2026 and 6 quadrennially thereafter, one Council member from each electoral district shall be elected to 7 serve a four-year term. 8 **SECTION 1.2.(a)** Chapter III of the Charter of the Town of Fletcher, being Chapter 9 44 of the 1989 Session Laws, reads as rewritten: 10 "Chapter III. "Governing Body. 11 12 13 "Sec. 3.3. Term of office of Council members. Members of the Town Council are elected to 14 staggered four-year terms, except at the initial election in 1989, the two highest vote getters who 15 are elected to district seats shall be elected to four year terms, and the next two highest votegetters elected to district seats shall be elected to two-year terms. In 1991 and quadrennially 16 thereafter, two members of the Council shall be elected for four-year terms. In 1993 and 17 18 quadrennially thereafter, two members of the Council shall be elected for four-year terms. 19 "Sec. 3.4. Selection of Mayor; term of office. The qualified voters of the entire town nominate 20 and elect the Mayor. A mayor shall be elected in 1989 and quadrennially thereafter for a four-year 21 term." 22 SECTION 1.2.(b) Chapter IV of the Charter of the Town of Fletcher, being Chapter 23 44 of the 1989 Session Laws, reads as rewritten: 24 "Chapter IV. 25 "Elections. 26 "Sec. 4.1. Conduct of Town elections. Regular municipal elections shall be held at the time 27 of the general election in each even-numbered year. The Town Council and Mayor shall be 28 elected on a nonpartisan basis and the results determined by the primary method as provided by 29 G.S. 163-294; provided that if the City of Hendersonville is scheduled to hold a primary on the 30 sixth Tuesday before the election under G.S. 163-279(a)(2), the nonpartisan primary in the Town 31 of Fletcher shall be on that date. Except as otherwise provided by this act, the election shall be 32 conducted in accordance with the uniform municipal election laws of North Carolina." 33 **SECTION 1.2.(c)** No municipal elections shall be conducted in the Town of Fletcher 34 in 2023. The terms of the two Council members serving on the effective date of this act whose 35 terms are set to expire in 2023 shall be extended by one year. The terms of the Mayor and the 36 two Council members serving on the effective date of this act whose terms are set to expire in 37 2025 shall be extended by one year. Regular municipal elections shall be conducted in the Town 38 of Fletcher in even-numbered years beginning in 2024. 39 **SECTION 1.2.(d)** In 2024 and quadrennially thereafter, one Council member from each of Districts 2 and 3 shall be elected to serve four-year terms. In 2026 and quadrennially 40 41 thereafter, a mayor and one Council member from each of Districts 1 and 4 shall be elected to 42 serve four-year terms. 43 **SECTION 1.3.(a)** Article IV of the Charter of the City of Hendersonville, being 44 Chapter 874 of the 1971 Session Laws, as amended by City Ordinance No. 1995-06-08 adopted 45 on June 8, 1995, and S.L. 2016-15, reads as rewritten: 46 "ARTICLE IV. ELECTION PROCEDURES 47 "Sec. 4.1. Regular Municipal Elections. Regular municipal elections shall be held quadrennially on the date provided by law. In each election year, there shall be elected by the 48 49 qualified voters of the City four Council Members (in addition to the Mayor) to serve for terms 50 of four years, or at the time of the general election in each even-numbered year. The Mayor and Council Members shall serve until their successors are elected and qualified. 51

1 "Sec. 4.2. Regular Municipal Primaries. There shall be a regular municipal primary at which 2 each political party shall nominate four candidates for City Commissioners and one for the office 3 of Mayor, to be filled at the regular municipal election. The Mayor and Council Members shall 4 be elected on a nonpartisan basis and results determined by the primary method as provided in 5 G.S. 163-294. 6 "Sec. 4.3. Voting. In the elections to be held during the calendar year 1997, each voter shall 7 be entitled to vote for four (4) candidates for City Council and one (1) candidate for the office of 8 mayor. In the election to be held in 1997, two (2) of the council members shall be elected each 9 for a term of two (2) years and two (2) of the council members shall be elected for a term of four 10 (4) years; provided, that the two candidates for council seats receiving the greatest and second greatest number of votes shall be declared elected to the terms of four (4) years, and that the two 11 12 (2) candidates receiving the third and fourth greatest number of votes shall be declared elected 13 to the terms of two (2) years. In the case of a tie involving the second and third greatest number 14 of votes, declaration for the two (2) year and four (4) year terms shall be decided by lot. 15 Beginning in 1999, elections shall be held every two (2) years and all vacated council seats shall be filled for a term of four (4) years. The Council Members shall be elected for staggered terms 16 of four years. The mayor shall be elected every four (4) years for a term of four (4) years. 17 18 "Sec. 4.4. Regulation of Elections. All municipal elections shall be conducted in accordance 19 with the general laws of North Carolina relating to municipal elections, uniform municipal 20 election laws in Chapter 163 of the General Statutes, except as otherwise herein 21 provided.provided by this act." 22 SECTION 1.3.(b) No municipal elections shall be conducted in the City of 23 Hendersonville in 2023. The terms of the two Council members serving on the effective date of 24 this act whose terms are set to expire in 2023 shall be extended by one year. The terms of the 25 Mayor and the two Council members serving on the effective date of this act whose terms are set 26 to expire in 2025 shall be extended by one year. Regular municipal elections shall be conducted 27 in the City of Hendersonville in even-numbered years beginning in 2024. 28 SECTION 1.3.(c) In 2024 and quadrennially thereafter, two Council members shall 29 be elected to serve four-year terms. In 2026 and quadrennially thereafter, a mayor and two 30 Council members shall be elected to serve four-year terms. 31 SECTION 1.4.(a) Section 3.1 of the Charter of the Town of Laurel Park, being S.L. 32 2000-8, reads as rewritten: 33 "Section 3.1. Regular Municipal Elections. Regular municipal elections shall be held at 34 the time of the general election in each odd-numbered year even-numbered year. Except as 35 otherwise provided by this act, the election shall be conducted in accordance with the uniform 36 municipal election laws of North Carolina. Elections shall be conducted on a nonpartisan basis 37 and the results determined using the nonpartisan plurality method as provided in G.S. 163-292." 38 **SECTION 1.4.(b)** Sections 3.2 and 3.3 of the Charter of the Town of Laurel Park, 39 being S.L. 2000-8, are repealed. 40 SECTION 1.4.(c) No municipal elections shall be conducted in the Town of Laurel 41 Park in 2023. The terms of the Mayor and the two Commissioners serving on the effective date 42 of this act whose terms are set to expire in 2023 shall be extended by one year. The terms of the 43 two Commissioners serving on the effective date of this act whose terms are set to expire in 2025 44 shall be extended by one year. Regular municipal elections shall be conducted in the Town of 45 Laurel Park in even-numbered years beginning in 2024. 46 SECTION 1.4.(d) In 2024 and quadrennially thereafter, a mayor and two 47 Commissioners shall be elected to serve four-year terms. In 2026 and quadrennially thereafter, 48 two Commissioners shall be elected to serve four-year terms. 49 SECTION 1.5.(a) Section 3.3 of the Charter of the Town of Mills River, being S.L.

50 2003-242, reads as rewritten:

"Section 3.3. Manner of Electing Town Council; Terms of Office. Two of the Council 1 2 members shall be elected at large from the residents of the Town and three shall be elected from 3 each of Districts 1, 2, and 3 respectively, as provided in Article IV of this Charter. The qualified 4 voters of the entire Town shall elect all the members of the Town Council, and, except as 5 provided in this section, and they shall serve staggered four-year terms. In 2003, two Council members shall be elected at large and they shall serve for four-year terms, and one Council 6 7 member shall be elected from each of Districts 1, 2, and 3, respectively and they shall serve for 8 two-year terms. In 2005, and quadrennially thereafter, one Council member shall be elected from 9 each of Districts 1, 2, and 3 respectively and they shall serve for four year terms. In 2007, and 10 quadrennially thereafter, two members shall be elected at large and they shall serve for four-year terms." 11 12 SECTION 1.5.(b) Section 4.1 of the Charter of the Town of Mills River, being S.L. 13 2003-242, reads as rewritten: 14 "Section 4.1. Conduct of Town Elections. Town elections shall be conducted on a nonpartisan basis and the results determined by plurality, as provided in G.S. 163-292. Elections 15 shall be conducted by the Henderson County Board of Elections in accordance with general law, 16 17 except as may be modified by this Charter. Elections." 18 SECTION 1.5.(c) Section 4.2 of the Charter of the Town of Mills River, being S.L. 19 2003-242, reads as rewritten: 20 "Section 4.2. Regular Municipal Elections; District Boundaries. Regular municipal 21 elections shall be held at the time of the general election in each odd-numbered year 22 even-numbered year. Except as otherwise provided by this act, the election shall be conducted in 23 accordance with the uniform municipal election laws of North Carolina. For purpose of the 24 election of Town Council members, the Town is divided into three geographical subdivisions, 25 known as districts, and all qualified voters of the Town may cast a vote for each seat. A written 26 description or map showing the current boundaries of the three election districts shall be 27 maintained in the office of the Town Clerk and shall be available for public inspection. The 28 district boundaries may be amended periodically pursuant to the provisions of general law. 29 Whenever areas are hereafter annexed and made part of the Town, the Town Council shall, by 30 ordinance, redefine and rearrange the three election districts so as to include the annexed areas. 31 The ordinance shall be adopted at least seven days prior to the opening of candidate filing for the 32 municipal election next succeeding the date of any annexation and shall provide for three election 33 districts of approximately equal population. In redefining and rearranging the election district 34 lines, the Town Council shall follow as nearly as practical existing district lines." 35 SECTION 1.5.(d) No municipal elections shall be conducted in the Town of Mills 36 River in 2023. The terms of the two Council members serving on the effective date of this act 37 whose terms are set to expire in 2023 shall be extended by one year. The terms of the three 38 Council members serving on the effective date of this act whose terms are set to expire in 2025 39 shall be extended by one year. Regular municipal elections shall be conducted in the Town of 40 Mills River in even-numbered years beginning in 2024. SECTION 1.5.(e) In 2024 and quadrennially thereafter, two Council members shall 41 42 be elected at-large to serve four-year terms. In 2026 and quadrennially thereafter, one Council 43 member shall be elected from each of Districts 1, 2, and 3, respectively, to serve four-year terms. 44 45 PART II. MUNICIPALITIES IN POLK COUNTY 46 SECTION 2.1.(a) Article III of the Charter of the Town of Columbus, being Chapter 47 46 of the 1985 Session Laws, as amended by Town Ordinance No. 68 adopted on February 18, 48 2003, reads as rewritten: 49 "ARTICLE III. ELECTIONS "Section 3.1. Regular Municipal Elections. Regular municipal elections shall be held at the 50 time of the general election in each odd-numbered year even-numbered year. Except as otherwise 51

1 provided by this act, the election shall be conducted in accordance with the uniform municipal 2 election laws of North Carolina. The Mayor and Council members shall be elected by the voters 3 of the Town on an at-large basis, by the nonpartisan plurality method of election.election, as 4 provided in G.S. 163-292. 5 "Section 3.2. Election of the Council Members. The Council members serving on the date of 6 ratification of this Charter may continue to shall serve until expiration of their terms, or until 7 their successors are elected and qualified. Council members shall continue to be elected and to 8 serve on a staggered term system. At each such-municipal election the candidate receiving the 9 highest number of votes shall serve for a term of four years, and the two candidates receiving the 10 next highest number of votes shall serve for a period of two years. 11 "Section 3.3. Election of the Mayor. The Mayor serving on the date of ratification of this Charter may continue to serve until the expiration of his or her term, or shall serve until a 12 13 successor is elected and qualified. At the regular municipal election in 1985 and every two years 14 thereafter, there The Mayor shall be elected a Mayor to serve as provided in Article II of this 15 Charter. 16" 17 **SECTION 2.1.(b)** No municipal elections shall be conducted in the Town of 18 Columbus in 2023. The terms of the Mayor and the two Council members serving on the effective 19 date of this act whose terms are set to expire in 2023 shall be extended by one year. The terms of 20 the two Council members serving on the effective date of this act whose terms are set to expire 21 in 2025 shall be extended by one year. Regular municipal elections shall be conducted in the 22 Town of Columbus in even-numbered years beginning in 2024. 23 **SECTION 2.1.(c)** In 2024 and biennially thereafter, a mayor shall be elected to serve 24 a two-year term and three Council members shall be elected for staggered terms. 25 **SECTION 2.2.(a)** Notwithstanding the Charter of the City of Saluda, being Chapter 26 5 of the Private Laws of 1881, as amended by Chapter 93 of the Private Laws of 1903, Chapter 27 20 of the Private Laws of 1907, and Chapter 191 of the Private Laws of 1913, regular municipal 28 elections in the City of Saluda for the election of the Mayor and Commissioners shall be held at 29 the time of the general election in even-numbered years. Election of the Mayor and 30 Commissioners shall be on a nonpartisan plurality basis and the results determined in accordance 31 with G.S. 163-292. Except as otherwise provided by this act, the election shall be conducted in 32 accordance with the uniform municipal election laws in Chapter 163 of the General Statutes. 33 **SECTION 2.2.(b)** No municipal elections shall be conducted in the City of Saluda 34 in 2023. The terms of the two Commissioners serving on the effective date of this act whose 35 terms are set to expire in 2023 shall be extended by one year. The terms of the Mayor and the 36 two Commissioners serving on the effective date of this act whose terms are set to expire in 2025 37 shall be extended by one year. Regular municipal elections shall be conducted in the City of 38 Saluda in even-numbered years beginning in 2024. 39 **SECTION 2.2.(c)** In 2024 and quadrennially thereafter, two Commissioners shall be 40 elected to serve four-year terms. In 2026 and quadrennially thereafter, a mayor and two 41 Commissioners shall be elected to serve four-year terms. 42 **SECTION 2.3.(a)** Section 3.3 of the Charter of the Town of Tryon, being Chapter 43 441 of the 1971 Session Laws, as amended by S.L. 2013-261, reads as rewritten: 44 "Sec. 3.3. Terms; Qualifications; Vacancies. (a) Except as provided in Section 4.1, the 45 members of the Board of Commissioners shall serve for staggered terms of four years, and the 46 Mayor shall serve for a term of two-four years, beginning the day and hour of the organizational 47 meeting following their election, as established by ordinance in accordance with this Charter; 48 provided, they shall serve until their successors are elected and qualify. 49 "

SECTION 2.3.(b) Section 4.1 of the Charter of the Town of Tryon, being Chapter 1 2 441 of the 1971 Session Laws, as amended by Town Ordinance No. 2003-7 adopted on August 3 19, 2003, reads as rewritten: 4 "Sec. 4.1. Regular Elections. 5 Regular municipal elections shall be held biennially on the Tuesday after the first (a) 6 Monday in November in May in odd-numbered years. at the time of the general election in each 7 even-numbered year. In each biennial election, there shall be elected two commissioners. 8 Election of the mayor and commissioners shall be on a nonpartisan plurality basis and the results 9 determined in accordance with G.S. 163-292. Except as otherwise provided by this act, the 10 election shall be conducted in accordance with the uniform municipal election laws in Chapter 163 of the General Statutes. 11 12 (b)Notwithstanding the provisions of subsection (a) above, in 2003 only, there shall be 13 elected three commissioners. The candidates for commissioner who receive the largest and 14 second largest number of votes shall each be elected for a term of four (4) years, and the candidate for commissioner who receives the third largest number of votes shall be elected for a term of 15 16 two (2) years." 17 **SECTION 2.3.(c)** No municipal elections shall be conducted in the Town of Tryon 18 in 2023. The terms of the Mayor and the two Commissioners serving on the effective date of this 19 act whose terms are set to expire in 2023 shall be extended by one year. The terms of the two 20 Commissioners serving on the effective date of this act whose terms are set to expire in 2025 21 shall be extended by one year. Regular municipal elections shall be conducted in the Town of 22 Tryon in even-numbered years beginning in 2024. 23 In 2024 and quadrennially thereafter, a mayor and two SECTION 2.3.(d) 24 Commissioners shall be elected to serve four-year terms. In 2026 and quadrennially thereafter, 25 two Commissioners shall be elected to serve four-year terms. 26 27 PART III. MUNICIPALITIES IN RUTHERFORD COUNTY 28 SECTION 3.1.(a) Section 4 of the Charter of the Town of Bostic, being Chapter 263 29 of the Private Laws of 1913, as amended by Town Resolution adopted on March 2, 2009, reads 30 as rewritten: 31 "Sec. 4. It shall be the duty of the Town Commissioners to provide for an election to be held 32 on the first Tuesday in November, 2009, according to the laws of the State and the Regular 33 municipal elections shall be held at the time of the general election in each even-numbered year. 34 The officers elected shall hold their offices until their successors are elected and qualified. The 35 Town Commissioners shall be composed of 5-five members, each of whom shall be elected for 36 a term staggered terms of four years, provided they shall serve until their successors are elected 37 and qualified. Notwithstanding the foregoing, the terms of the two commissioners receiving the most votes in the 2009 election shall be four years and the terms of the remaining three 38 39 commissioners in that election shall be two years. Thereafter, the terms of all Town 40 Commissioners shall be four years as referenced above. Notwithstanding the foregoing, the term of the Mayor elected in the 2009 Election shall be four years and thereafter the years. The term 41 42 of the Mayor shall be four years, as referenced above. years. The Commissioners and Mayor shall 43 be elected according to the nonpartisan plurality election method in accordance with G.S. 163-292. Except as otherwise provided by this act, the election shall be conducted in 44 45 accordance with the uniform municipal election laws of North Carolina." 46 **SECTION 3.1.(b)** No municipal elections shall be conducted in the Town of Bostic 47 in 2023. The terms of the three Commissioners serving on the effective date of this act whose 48 terms are set to expire in 2023 shall be extended by one year. The terms of the Mayor and the 49 two Commissioners serving on the effective date of this act whose terms are set to expire in 2025 50 shall be extended by one year. Regular municipal elections shall be conducted in the Town of 51 Bostic in even-numbered years beginning in 2024.

SECTION 3.1.(c) In 2024 and quadrennially thereafter, three Commissioners shall 1 2 be elected to serve four-year terms. In 2026 and quadrennially thereafter, a mayor and two 3 Commissioners shall be elected to serve four-year terms. 4 **SECTION 3.2.(a)** Section 3-3 of the Charter of Chimney Rock Village, being 5 Chapter 444 of the 1991 Session Laws, reads as rewritten: 6 "Sec. 3-3. Term of Office of Council Members. Members of the Council are elected to 7 staggered four-year terms. At the initial election in 1991, the three highest vote getters shall be 8 elected to four-year terms and the next two highest vote getters shall be elected to two-year terms. 9 In 1993 and quadrennially thereafter, two members of the Council shall be elected for four-year 10 terms. In 1995 and quadrennially thereafter, three members of the Council shall be elected for four-year terms." 11 SECTION 3.2.(b) Section 4-1 of the Charter of Chimney Rock Village, being 12 13 Chapter 444 of the 1991 Session Laws, reads as rewritten: 14 "Sec. 4-1. Conduct of Village Elections. <u>Regular municipal elections shall be held at the</u> time of the general election in each even-numbered year. Village officers shall be elected on a 15 nonpartisan basis and results determined by a plurality as provided in G.S. 163-292. Except as 16 17 otherwise provided by this act, the election shall be conducted in accordance with the uniform 18 municipal election laws in Chapter 163 of the General Statutes." 19 **SECTION 3.2.(c)** No municipal elections shall be conducted in Chimney Rock 20 Village in 2023. The terms of the three Council members serving on the effective date of this act 21 whose terms are set to expire in 2023 shall be extended by one year. The terms of the two Council 22 members serving on the effective date of this act whose terms are set to expire in 2025 shall be 23 extended by one year. Regular municipal elections shall be conducted in Chimney Rock Village 24 in even-numbered years beginning in 2024. 25 SECTION 3.2.(d) In 2024 and quadrennially thereafter, three Council members shall 26 be elected to serve four-year terms. In 2026 and quadrennially thereafter, two Council members 27 shall be elected to serve four-year terms. 28 SECTION 3.3.(a) Article III of the Charter of the Town of Ellenboro, being Chapter 29 425 of the 1983 Session Laws, as amended by S.L. 2007-310, reads as rewritten: 30 "ARTICLE III. 31 "ELECTIONS. 32 "Sec. 3.1. Regular Municipal Elections; Conduct and Method of Election. Regular municipal 33 elections shall be held in the Town every two years in odd numbered years and at the time of the 34 general election in each even-numbered year. Except as otherwise provided by this act, the 35 election shall be conducted in accordance with the uniform municipal election laws of North 36 Carolina. The Mayor and members of the Council shall be elected according to the nonpartisan 37 plurality method of election.election in accordance with G.S. 163-292. 38 "Sec. 3.2. Election of Council Members. Council members shall be elected to serve staggered 39 four-year terms. All council members shall be nominated and voted upon by the voters of the 40 Town voting at large. At the regular municipal election in 2007, the persons receiving the two 41 highest numbers of votes are elected to four year terms, and the three persons receiving the next 42 highest numbers of votes are elected to two-year terms. In 2009 and quadrennially thereafter, 43 three members are elected for four-year terms. In 2011 and quadrennially thereafter, two 44 members are elected for four-year terms. "Sec. 3.3. Election of the Mayor. At the regular municipal election in 2007, and quadrennially 45 46 thereafter, there The Mayor shall be elected a Mayor to serve a term of four years. In 2024 and quadrennially thereafter, two Board members shall be elected to 9 serve four-year terms. In 2026 and quadrennially thereafter, two Board members shall be elected 10 to serve four-year terms. 11 SECTION 3.6.(a) Notwithstanding the Charter of the Town of Ruth, being Chapter 12 55 of the Private Laws of 1893, as amended by Chapter 53 of the Public Laws of 1939, regular 13 municipal elections in the Town of Ruth for the election of Mayor and Commissioners shall be 14 held at the time of the general election in an even-numbered year. The Mayor and Commissioners 15 shall be elected to serve four-year terms. Election of the Mayor and Commissioners shall be on 16 a nonpartisan plurality basis and the results determined in accordance with G.S. 163-292. Except 17 as otherwise provided by this act, the election shall be conducted in accordance with the uniform 18 municipal election laws in Chapter 163 of the General Statutes. 19 SECTION 3.6.(b) No municipal elections shall be conducted in the Town of Ruth 20 in 2023. The terms of the Mayor and all commissioners serving on the effective date of this act 21 whose terms are set to expire in 2023 shall be extended by one year. Regular municipal elections 22 shall be conducted in the Town of Ruth in even-numbered years beginning in 2024. 23 SECTION 3.7.(a) Article II of the Charter of the Town of Rutherfordton, as 24 amended, being Chapter 350 of the 1979 Session Laws, reads as rewritten: 25 "ARTICLE II. MAYOR AND COUNCIL. 26 27 "Section 2.2. Council; Composition; Terms of Office. The Town Council shall be composed 28 of four members, each of whom shall be elected by and from the qualified voters of the Town 29 for staggered terms of two-four years each in the manner provided by Article III of this Charter, 30 provided they shall serve until their successors are elected and qualified. 31 "Section 2.3. Mayor; Term of Office; Duties. The Mayor shall be elected by and from the 32 qualified voters of the Town in the manner provided by Article III of this Charter to serve for a 33 term of two-four years, or until his-a successor is elected and qualified. ELECTIONS. 43 "Section 3.1. Regular Municipal Elections; Conduct and Method of Election. Regular 44 municipal elections shall be held in the Town every two years in odd numbered years and at the 45 time of the general election in each even-numbered year. Except as otherwise provided by this 46 act, the election shall be conducted in accordance with the uniform municipal election laws of 47 North Carolina. The Mayor and members of the Council shall be elected according to the 48 nonpartisan plurality method.method in accordance with G.S. 163-292. 49 "Section 3.2. Election of the Mayor. At the regular municipal election in 1979, and biennially 50 thereafter, there shall be elected a Mayor to serve a term of two years. The Mayor shall be elected 51 by all the voters of the Town voting at large."

1 **SECTION 3.7.(c)** No municipal elections shall be conducted in the Town of 2 Rutherfordton in 2023. The terms of the two Council members serving on the effective date of 3 this act whose terms are set to expire in 2023 shall be extended by one year. The terms of the 4 Mayor and the two Council members serving on the effective date of this act whose terms are set 5 to expire in 2025 shall be extended by one year. Regular municipal elections shall be conducted 6 in the Town of Rutherfordton in even-numbered years beginning in 2024. 7 SECTION 3.7.(d) In 2024 and quadrennially thereafter, two Council members shall 8 be elected to serve four-year terms. In 2026 and quadrennially thereafter, a mayor and two 9 Council members shall be elected to serve four-year terms. 10 **SECTION 3.8.(a)** Article IV of the Charter of the Town of Spindale, being Chapter 11 378 of the 1975 Session Laws, as amended by Town Ordinance adopted on April 15, 1996, reads 12 as rewritten: 13 "ARTICLE IV. Elections. 14 "Sec. 4.1. Regular municipal elections. Regular municipal elections shall be held biennially 15 in odd-numbered years on the day set by general law for municipal elections. In the 1997 regular municipal election and quadrennially thereafter, there at the time of the general election in each 16 17 even-numbered year. The mayor shall be elected a mayor for a term of four years. In the 1997 18 regular municipal election and quadrennially thereafter there shall be elected two Town 19 Commissioners for terms of four years each. Except 27 as otherwise provided by this act, town elections shall be conducted in accordance with the 28 general laws of North Carolina relating to municipal elections." 29 **SECTION 3.8.(b)** No municipal elections shall be conducted in the Town of 30 Spindale in 2023. The terms of the three Commissioners serving on the effective date of this act 31 whose terms are set to expire in 2023 shall be extended by one year. The terms of the Mayor and 32 the two Commissioners serving on the effective date of this act whose terms are set to expire in 33 2025 shall be extended by one year. Regular municipal elections shall be conducted in the Town 34 of Spindale in even-numbered years beginning in 2024. 35 SECTION 3.8.(c) In 2024 and quadrennially thereafter, three Commissioners shall 36 be elected to serve four-year terms. In 2026 and quadrennially thereafter, a mayor and two 37 Commissioners shall be elected to serve four-year terms. 38 39 PART IV. POLK COUNTY BOARD OF COMMISSIONERS 40 SECTION 4. Notwithstanding Chapter 976 of the 1983 Session Laws, all members 41 of the Polk County Board of Commissioners shall serve four-year terms, beginning the first 42 Monday in December following the 2024 general election. In 2024 and quadrennially thereafter, 43 three members shall be elected; in 2026 and quadrennially thereafter, two members shall be 44 elected. 45 46 PART V. EFFECTIVE DATE 47 **SECTION 5.** This act is effective when it becomes law and applies to elections held
