3 "AN ACT TO DECREASE THE SIZE OF THE NASH BOARD OF EDUCATION TO SEVEN
4 MEMBERS; TO ALIGN THE DISTRICTS FOR THE NASH BOARD OF EDUCATION
5 WITH THE DISTRICTS OF NASH COUNTY BOARD OF COMMISSIONERS; AND TO
6 PROVIDE FOR THE BOUNDARIES OF THE NASH SCHOOL ADMINISTRATIVE
7 UNIT TO BE IDENTICAL TO THE BOUNDARIES OF NASH COUNTY EFFECTIVE
8 JULY 1, 2024.";

11 and on page 1, line 7, through page 2, line 5, by rewriting the lines to read:

13 "SECTION 1.(a) Except as provided in this section, the Nash Board of Education
14 shall consist of seven members elected to staggered four-year terms.

15 "SECTION 1.(b) Members of the Nash Board of Education shall be elected on a
16 nonpartisan basis at the time of the general election in even-numbered years as terms expire. The
17 election shall be conducted by the nonpartisan plurality method, and the results determined in
18 accordance with G.S. 163-292. The filing period shall be from noon on the first Friday in July
19 until noon on the third Friday in July of the even-numbered year. Except as otherwise provided
20 by this act, elections shall be conducted in accordance with Chapters 115C and 163 of the General
21 Statutes.

22 "SECTION 1.(c) Members of the Nash Board of Education shall be elected from
23 seven single-member electoral districts. The electoral districts shall be the same electoral districts
24 as those for the Nash County Board of Commissioners. No person shall be eligible to file for, be
25 elected to, or serve on the Nash Board of Education unless the person is a qualified voter and
26 resident of the district from which the person seeks to be elected. Candidates shall be voted on
27 by the voters residing in the district from which that candidate seeks election.

28 "SECTION 1.(d) The Nash Board of Education shall organize in accordance with
29 G.S. 115C-41. Vacancies on the Nash Board of Education shall be filled in accordance with G.S.
30 115C-37(f). To be eligible to fill a vacancy, the member shall reside in the district in which the
31 vacating member was elected to serve.

1 **SECTION 1.(e)** All members who were elected to the Nash Board of Education in
2 2022 shall continue to serve on the Nash Board of Education until the end of the elected term. If
3 a Nash Board of Education member elected in 2022 vacates office for any reason prior to the end
4 of the elected term, the vacancy shall not be filled.

5 **SECTION 1.(f)** In addition to the members serving on the Nash Board of Education
6 in accordance with subsection (e) of this section, seven members of the Nash Board of Education
7 shall be elected in 2024. In order to implement staggered terms, members shall be elected to the
8 Nash Board of Education as follows:

- 9 (1) In 2024, and every four years thereafter, members from Districts 1, 3, and 4
10 shall be elected to serve a four-year term.
11 (2) In 2024, members from Districts 2, 5, 6, and 7 shall be elected to serve a
12 two-year term. In 2026, and every four years thereafter, members from
13 Districts 2, 5, 6, and 7 shall be elected to serve a four-year term.

14 **SECTION 1.(g)** This section is effective when it becomes law and applies to
15 elections held on or after that date.

16 **SECTION 2.(a)** Effective July 1, 2024, the boundaries of the Nash School
17 Administrative Unit shall be identical to the boundaries of Nash County. Any territory that was
18 previously part of the Nash School Administrative Unit that is located outside of the boundaries
19 of Nash County shall be annexed to the school administrative unit of the county in which the
20 territory is located. Any local board of education gaining territory annexed into the school
21 administrative unit under this section shall revise electoral districts in accordance with G.S.
22 115C-37(i).

23 **SECTION 2.(b)** Effective July 1, 2024, the Nash Board of Education shall operate
24 and administer all of the public schools located in the Nash School Administrative Unit.

25 **SECTION 3.(a)** S.L. 2016-14 is repealed. The "Nash-Rocky Mount School
26 Administrative Unit" shall continue to be renamed the "Nash School Administrative Unit" and
27 the "Nash-Rocky Mount Board of Education" shall continue to be renamed the "Nash Board of
28 Education."

29 **SECTION 3.(b)** No later than November 15, 2023, the boards of the school
30 administrative units of Nash and Edgecombe, in consultation with the boards of county
31 commissioners of Nash and Edgecombe Counties, shall submit a written plan of transfer to the
32 State Board of Education setting forth the agreement of all four boards as to the transfer of that
33 portion of the Nash School Administrative Unit located in Edgecombe County to the Edgecombe
34 County Public School System. The provisions of the written plan of transfer shall be consistent
35 with the General Statutes and shall contain at least the following:

- 36 (1) The power, authority, and duties of the Nash Board of Education and
37 Edgecombe County Board of Education with respect to the employment of
38 personnel, the preparation of budgets, student assignment, and any other
39 related matters relevant to the area to be transferred effective July 1, 2024, not
40 inconsistent with the General Statutes.
41 (2) Notwithstanding G.S. 115C-518, the transfer of all funds, contracts,
42 obligations, assets, and liabilities relevant to the area to be transferred
43 effective July 1, 2024, from the Nash Board of Education to the Edgecombe

1 County Board of Education, including consideration of real property,
2 furnishings and improvements, encumbered and unencumbered property,
3 equipment, buses, band and sports equipment, textbooks, other instructional
4 materials, and library resources, computers, and supplies.

- 5 (3) Any other appropriate subject or function that may be necessary for the
6 orderly transfer of the portion of the Nash School Administrative Unit located
7 in Edgecombe County to be transferred to the Edgecombe County Public
8 School System effective July 1, 2024.

9 **SECTION 3.(c)** If a written plan of transfer is not submitted to the State Board of
10 Education pursuant to subsection (b) of this section by November 15, 2023, the State Board of
11 Education shall prepare a written plan of transfer for the July 1, 2024, transition no later than
12 December 31, 2023.

13 **SECTION 3.(d)** Unless agreed on by both of the boards of the school administrative
14 units of Nash and Edgecombe and both of the boards of county commissioners of Nash and
15 Edgecombe Counties, the written plan of transfer prepared pursuant to subsection (b) or (c) of
16 this section shall become final and shall not be modified or amended except by an act of the
17 General Assembly. The written plan of transfer prepared pursuant to subsection (b) or (c) of this
18 section, along with any modifications to that written plan of transfer, shall be placed in the
19 custody of the Nash Board of Education and Edgecombe County Board of Education, and shall
20 be filed with the Secretary of State.

21 **SECTION 3.(e)** Except as otherwise provided for in the written plan of transfer
22 prepared pursuant to subsection (b) or (c) of this section and notwithstanding G.S. 115C-518, the
23 title to and ownership of all property of the Nash Board of Education located in Edgecombe
24 County, both real and personal of every kind and description, shall be vested in the Edgecombe
25 County Board of Education, and both boards of education shall execute all deeds and other
26 instruments of conveyance as may be necessary and appropriate to vest record title to and
27 ownership of any property located in Edgecombe County held by the Nash Board of Education
28 in and to the Edgecombe County Board of Education on the transfer date of July 1, 2024.

29 **SECTION 3.(f)** Except as otherwise provided for in the written plan of transfer
30 prepared pursuant to subsection (b) or (c) of this section, the following shall apply:

- 31 (1) All claims and demands of every kind related to the public schools of the Nash
32 School Administrative Unit located in Edgecombe County as of July 1, 2024,
33 shall pass and be transferred to the Edgecombe County Public School System,
34 and the Edgecombe County Public School System shall have the same powers
35 and authority to enforce said claims and demands as the Nash School
36 Administrative Unit would have had in the event of the continued control of
37 those public schools.

- 38 (2) Any obligations and liabilities related to the public schools of the Nash School
39 Administrative Unit located in Edgecombe County existing as of July 1, 2024,
40 shall become the obligations and liabilities of the Edgecombe County Board
41 of Education as of July 1, 2024, and such obligations and liabilities may be
42 enforced against the Edgecombe County Board of Education thereafter to the

4 **SECTION 4.(b)** Section 4 of S.L. 2003-346 is repealed.
5 **SECTION 4.(c)** Section 1 of S.L. 2006-87 is repealed.
6 **SECTION 4.(d)** S.L. 2007-316 is repealed.
7 **SECTION 4.(e)** This section becomes effective July 1, 2024.
8 **SECTION 5.** Except as otherwise provided, this act is effective when it becomes
