8	The General Assembly of North Carolina enacts:					
9	<b>SECTION 1.</b> This act shall be known as the "Protect Those Who Serve and Protect					
10	Act."					
11	SECTION 2. Article 8 of Chapter 14 of the General Statutes is amended by adding					
12	a new section to read:					
13	"§ 14-34.1A. Discharging certain barreled weapons or a firearm at or into certain					
14	unoccupied emergency vehicles.					
15	(a) <u>Definition. – For purposes of this section, the term "emergency vehicle" means any</u>					
16	of the following:					
17	(1) <u>A law enforcement vehicle.</u>					
18	(2) <u>A fire department vehicle.</u>					
19	(3) <u>A public or private ambulance.</u>					
20	(4) <u>A rescue squad emergency service vehicle.</u>					
21	(5) <u>A State or local emergency management vehicle.</u>					
22	(6) <u>A vehicle owned or operated by the North Carolina National Guard.</u>					
23	$(7) \qquad \underline{\text{A vehicle owned or operated by any branch of the Armed Forces of the United}}$					
24	States.					
25	(8) <u>A vehicle owned or operated by the Department of Adult Correction.</u>					
26	(9) <u>A vehicle owned or operated by the Division of Juvenile Justice of the</u>					
27	Department of Public Safety.					
28	(b) Offense. – It is unlawful to willfully or wantonly discharge or attempt to discharge					
29	any firearm or barreled weapon capable of discharging shot, bullets, pellets, or other missiles at					
30	a muzzle velocity of at least 600 feet per second at or into any unoccupied emergency vehicle.					
31	(c) <u>Punishment. – Unless the conduct is covered under some other provision of law</u>					
32	providing greater punishment, any person who violates subsection (b) of this section is guilty of					
33	<u>a Class H felony.</u> "

practice of that professional nor to any other person who is licensed or authorized by law to use						
a laser device or uses it in the performance of the person's official duties.						
(e)	This	section	does not apply to laser tag, paintball guns, and other s	imilar games and		
devices using light emitting diode (LED) technology."
