The joint subcommittee shall have the authority to adopt, amend, and repeal rules ''(f)necessary to administer the provisions of this Article."

"(a3) Planned home births attended by a Certified Nurse Midwife shall be limited to

low-risk pregnancies. Pregnancies deemed inadvisable for home births by the American College of Obstetricians and Gynecologists Committee on Obstetric Practice shall be prohibited. The

joint subcommittee of the North Carolina Medical Board and the Board of Nursing created under

G.S. 90-18.2 G.S. 90-18.2, including the four additional members required by subsection (a) of this section, shall adopt rules governing the safety of home births attended by a Certified Nurse

SECTION 3. Except as otherwise provided, this act is effective when it becomes law.
