Senator Marcus

1 moves to amend the bill on page 2, line 31, through page 3, line 13, by rewriting the lines to read:

3 "(a) Notwithstanding any provision of law to the contrary, an individual who is qualified
4 to register to vote may register in person and then vote at a one-stop voting site in the individual's
5 county of residence during the period for one-stop voting provided under G.S. 163-227.2.

6 (b) For purposes of this section, an individual shall be offered a ballot as defined under
7 G.S. 163-165(1) by presenting to the election official, in addition to a photo voter identification
8 as required under G.S. 163-166.16, a different HAVA document that shows the individual's name
9 and address as attested to on the voter registration application submitted at the one-stop voting
10 site.

11 (c) For purposes of this section, an individual unable to provide a HAVA document as
12 required under subsection (b) of this section shall be offered the opportunity to cast a provisional
13 official ballot. A provisional official ballot shall be counted if the voter's county board of
14 elections receives via hand-delivery, electronic mail, fax, or mail to the county board of elections
15 prior to the close of business on the business day before canvass either of the following:

16 (1) A copy of (i) the photo identification required under G.S. 163-166.16 and (ii)
17 a HAVA document. The name and address on both forms of identification
18 must match the name and address provided on the voter registration
19 application.

20 (2) A copy of two different HAVA documents. The name and address on both
21 forms of identification must match the name and address provided on the voter
22 registration application.

23 (d) For purposes of subsections (b) and (c) of this section, the documents may be
24 presented in electronic, photocopy, or hard copy format.

25 (e) For purposes of this section, a "HAVA document" includes any of the following:

26 (1) Unexpired North Carolina driver's license or state identification card.

27 (2) Current residential lease or mortgage statement.

28 (3) Current utility bill.

29 (4) Current bank statement.

30 (5) Current paycheck.

31 (6) Any other government-issued document.
