18		electronic transfer of funds between a merchant and a customer using a			
19		payment card. This term does not include the following:			
20		<u>a.</u> <u>A bank holding federally insured deposits from individuals.</u>			
21		b. <u>A credit union holding federally insured deposits from individuals</u>			
22	<u>(3)</u>	Payment code Any code or other indicator that identifies to a payment card			
23		network, merchant, or bank whether a purchase was made for emergency			
24		contraception.
