17		Upon completion of the training program, each civilian

3		G.S. 20-166.1. A report completed by a civilian investigator shall be treated		
4		the same as if it were completed by a law enforcement officer for purposes of		
5		G.S. 20-166.1(i). A law enforcement officer shall investigate any crash		
6		involving personal injury or a fatality.		
7	<u>(9)</u>	Civilian investigators shall have the same authority as law enforcement		
8		officers to tow or remove a vehicle that is obstructing a public street or		
9		highway and shall use the city's existing police towing rotation system if one		
10		has been established."
