11 "SECTION 34.(c) Article 18 of Chapter 163 of the General Statutes is amended by  
12 adding a new section to read:

13 "§ 163-212.5. Falsification of electors.

14 (a) No person shall do any of the following:

- 15 (1) Create a false slate of presidential electors.
- 16 (2) Serve in a false slate of presidential electors.
- 17 (3) Conspire to create or serve in a false slate of presidential electors.

18 (b) A violation of this section shall is a Class D felony.

19 (c) For purposes of this section, the following definitions shall apply:

- 20 (1) Conspire to create or serve in a false slate of presidential electors. – To  
21 knowingly enter into any agreement, including, without limitation, a written  
22 agreement, oral agreement or agreement using electronic communications,  
23 with one or more persons to create a false slate of presidential electors or serve  
24 in a false slate of presidential electors.
- 25 (2) Create a false slate of presidential electors. – To knowingly sign, file, transmit  
26 or record with the Secretary of State, the Archivist of the United States, the  
27 Vice President of the United States or the Congress of the United States a list  
28 of presidential electors whose candidates for President and Vice President of  
29 the United States were not certified as receiving the highest number of votes  
30 in this State for that general election.
- 31 (3) Serve on a false slate of presidential electors. – To knowingly agree to be  
32 included on a list of presidential electors whose candidates for President and
