moves to amend the bill on page 12, lines 10-16, by rewriting those lines to read:

"SECTION 5.3. G.S. 163-182.15 reads as rewritten:

## "§ 163-182.15. Certificate of nomination or election, or certificate of the results of a referendum.

6 Issued by County Board of Elections. – In ballot items within the jurisdiction of the (a) 7 county board of elections, the county board shall issue a certificate of nomination or election, or 8 a certificate of the results of the referendum, as appropriate. The certificate shall be issued by the 9 county board six days after the completion of the canvass pursuant to G.S. 163-182.5, unless there is an election protest pending, pending, or a majority of the county board of elections 10 11 determines that there is substantial evidence of a violation of election law or other irregularity or misconduct exists that affected a sufficient number of votes to change the outcome of the election 12 pursuant to G.S. 163-182.10. If there is an election protest, the certificate of nomination or 13 14 election or the certificate of the result of the referendum shall be issued in one of the following 15 ways as appropriate.

17			by the county board of elections, unless that decision has been appealed to the
18			State Board of Elections.
19		(2)	The certificate shall be issued on the tenth day after the final decision of the

21			of the certificate is stayed by the Superior Court of Wake County pursuant to
22			G.S. 163-182.14.
23		(3)	If the decision of the State Board has been appealed to the Superior Court of
