The conferees appointed to resolve the differences between the Senate and the House of Representatives on Senate Bill 409, A BILL TO BE ENTITLED AN ACT TO AMEND THE OFFENSE OF BREAKING OR ENTERING INTO OR BREAKING OUT OF RAILROAD CARS, MOTOR VEHICLES, TRAILERS, AIRCRAFT, BOATS, OR OTHER WATERCRAFT; TO PROVIDE THAT MULTIPLE ACTS OF CERTAIN FINANCIAL CRIME OFFENSES MAY BE AGGREGATED IN CERTAIN CIRCUMSTANCES WHEN DETERMINING THE LEVEL OF PUNISHMENT TO BE IMPOSED; TO PROVIDE THAT PROVING IT WAS THE REGULAR PRACTICE OF A BUSINESS ACTIVITY TO MAKE A MEMORANDUM, REPORT, OR DATA COMPILATION MAY BE MADE BY AN UNSWORN DECLARATION UNDER PENALTY OF PERJURY; TO ALLOW CIVIC YOUTH GROUPS TO ADDRESS STUDENTS IN PUBLIC SCHOOL UNITS DURING CIVIC FOCUS WEEKS; AND TO REQUIRE MONETARY COMPENSATION TO OWNERS OF ON-PREMISES ADVERTISEMENTS FOR THE REPLACEMENT OR UPGRADE OF NONCONFORMING SIGNS DUE TO A CHANGE IN LOCAL GOVERNMENT REGULATIONS, House Committee Substitute Favorable 9/19/23, submit the following report:
