1 A BILL TO BE ENTITLED  
2 AN ACT TO REMOVE CERTAIN DESCRIBED PROPERTY FROM THE CORPORATE  
3 LIMITS OF THE TOWN OF FUQUAY-VARINA.  
4 The General Assembly of North Carolina enacts:  
5 **SECTION 1.** The following described property is removed from the corporate limits  
6 of the Town of Fuquay-Varina:  
7 TRACT I  
8 BEING all of Lot 1, Minor Subdivision and Recombination, Black Creek Estates, as shown  
9 on that map recorded in Book of Maps 2019, Page 1300, Wake County Registry, reference to  
10 which is hereby made for a more complete and accurate description of same. See Deed Book  
11 17535, Page 1659, Wake County Registry.

13 BEING all of Recombined Lot 2, Black Creek Estates, according to a plat entitled LOT  
14 RECOMBINATION, BLACK CREEK ESTATES, OWNED BY, SURVEY AND MAPPED  
15 FOR MORGAN DEVELOPMENT COMPANY, LLC, TOWN OF FUQUAY VARINA,  
16 MIDDLE CREEK TOWNSHIP, WAKE COUNTY, NORTH CAROLINA, according to plat

6 **SECTION 2.** This act has no effect upon the validity of any liens of the Town of  
7 Fuquay-Varina for ad valorem taxes or special assessments outstanding before the effective date  
8 of this act. Such liens may be collected or foreclosed upon after the effective date of this act as  
9 though the property were still within the corporate limits of the Town of Fuquay-Varina.

10 **SECTION 3.** This act becomes effective June 30, 2024. Property in the territory  
11 described in Section 1 of this act as of January 1, 2024, is no longer subject to municipal taxes  
12 for taxes imposed for taxable years beginning on or after July 1, 2024.
