(2)	Consumer Goods or Services. – Goods or services purchased, leased, or rented primarily for personal, family, or household purposes, including <u>residential roof replacement and repair services and courses</u> of instruction or training regardless of the purpose for which they are taken.  Seller. – Any person, partnership, corporation, or association engaged in the off-premises sale of consumer goods or <u>services</u> . <u>services</u> , including <u>residential roof replacement and repair services</u> . However, a nonprofit corporation or association, or member or employee thereof acting on behalf
 <u>(7)</u>	of such an association or corporation, shall not be a seller within the meaning of this section.  Residential Roof Replacement and Repair Services. – Reconstruction or repair of any part of an existing roof of a residential home for the purpose of its maintenance, including the total replacement of an existing roofing system, except when performed by a licensed general contractor or a person or subcontractor working under the supervision of a licensed general contractor. This definition does not include a person engaged in the retail sale of materials
