1 moves to amend the bill on page 177, lines 37 to 38, by inserting between the lines a new section  
2 to read:

4 **"FUNDS TO UPGRADE FUELING AND VEHICLE MAINTENANCE AT THE STATE**  
5 **HIGHWAY PATROL STATION IN HUNTERSVILLE, NORTH CAROLINA**

6 **SECTION 19G.1A(a)** Notwithstanding the Committee Report described in Section  
7 43.2 of this act or any other provision of law to the contrary, six hundred forty-three thousand  
8 one hundred fifty dollars (\$643,150) of the funds appropriated from the General Fund to the State  
9 Highway Patrol for the 2024-2025 fiscal year to support operating expenses shall instead be  
10 allocated to the State Highway Patrol Station in Huntersville, North Carolina to be used for the  
11 following purposes:

- 12 (1) Six hundred forty thousand dollars (\$640,000) for fuel infrastructure to  
13 include an above-ground storage tank, fuel dispenser, FuelMaster Live  
14 functionality, and a concrete island with an awning, lights, and electrical  
15 outlets.
- 16 (2) Three thousand dollars (\$3,000) for an air compressor for filling tires to be  
17 located on the concrete island funded in subdivision (1) of this section.
- 18 (3) One hundred fifty dollars (\$150.00) for a vehicle vacuum to be located on the  
19 concrete island funded in subdivision (1) of this section.

20 **SECTION 19G.1A(b)** The State Highway Patrol shall enter into a memorandum of  
21 agreement with the Department of Transportation for the creation, use, and maintenance of the  
22 items funded by this section.";
