5 (a) Commission Established. – The Medical Cannabis Production Commission is
6 established and shall consist of 13 members as follows:

7 (1) The Governor shall appoint members to the Medical Cannabis Production
8 Commission as follows:

9 a. A qualified patient representative.

10 b. Two industry representatives, subject to the limitation that, although
11 the industry representatives may participate in assisting with the
12 process of adopting rules, the industry representatives must not
13 participate in the license selection process if the industry
14 representatives have applied for or have an affiliation with a medical
15 cannabis supplier license applicant through family or business.

16 (2) The Secretary of the Department, or designee.

17 (3) The Director of the North Carolina State Bureau of Investigation, or designee.

18 (4) The Agriculture Commissioner, or designee.

19 (5) A sheriff designated by the North Carolina Sheriffs' Association.

20 (6) A chief of police designated by the North Carolina Association of Chiefs of
21 Police.

22 (7) A member of the Compassionate Use Advisory Board appointed pursuant to
23 G.S. 90-113.113(a)(1).

24 (8) A member appointed by the General Assembly upon recommendation of the
25 Speaker of the House of Representatives in accordance with G.S. 120-121.

26 (9) A member appointed by the General Assembly upon recommendation of the
27 President Pro Tempore of the Senate in accordance with G.S. 120-121.

28 (10) A member who shall be a pharmacist licensed in the State and appointed by
29 the General Assembly upon recommendation of the Speaker of the House of
30 Representatives in accordance with G.S. 120-121.

31 (11) A member who shall be a medical doctor licensed in the State with five years
32 of experience practicing in an emergency room appointed by the General

1 Assembly upon recommendation of the President Pro Tempore of the Senate
2 in accordance with G.S. 120-121.
3 (b) Terms. – Members of the Commission shall serve terms of four years, beginning
4 effective July 1 of the year of appointment, and may be reappointed to a second four-year term.
5 The terms of members designated by subdivisions (a)(1), (a)(2), (a)(4), and (a)(10) of this section
6 shall expire on June 30 of any year evenly divisible by four. The terms of the remaining members
7 shall expire on June 30 of any year that follows by two years a year evenly divisible by four."
