| 4  | The General Assembly of North Carolina enacts:   |
| 5  | <b>SECTION 1.</b> G.S. 115C-84.2(d) reads as rewritten:  |
| 6  | "(d) Opening and Closing Dates. – Local boards of education shall determine the dates of           |
| 7  | opening and closing the public schools under subdivision (a)(1) of this section. Except for        |
| 8  | year round schools, the opening date for students shall be no earlier than the Monday closest to   |
| 9  | August 26, and the closing date for students shall be no later than the Friday closest to June 11. |
| 10 | On a showing of good cause, the State Board of Education may waive the requirement that the        |
| 11 | opening date for students be no earlier than the Monday closest to August 26 and may allow the     |
| 12 | local board of education to set an opening date no earlier than the Monday closest to August 19,   |
| 13 | to the extent that school calendars are able to provide sufficient days to accommodate anticipated |
| 14 | makeup days due to school closings. A local board may revise the scheduled closing date if         |
| 15 | necessary in order to comply with the minimum requirements for instructional days or               |
| 16 | instructional time. For purposes of this subsection, the term "good cause" means that schools in   |
| 17 | any local school administrative unit in a county have been closed eight days per year during any   |
| 18 | four of the last 10 years because of severe weather conditions, energy shortages, power failures,  |
| 19 | or other emergency situations.   |
| 20 | The required opening and closing dates under this subsection shall not apply to any school         |
| 21 | that a local board designated as having a modified calendar for the 2003-2004 school year or to    |
| 22 | any school that was part of a planned program in the 2003-2004 school year for a system of         |
| 23 | modified calendar schools, so long as the school operates under a modified calendar."              |
| 24 | <b>SECTION 2.</b> This act applies only to Franklin County Schools.                                |
| 25 | <b>SECTION 3.</b> This act is effective when it becomes law and applies beginning with             |
| 26 | the 2025-2026 school year.   |
