1 **SECTION 4.** Part 3 of Article 1 of Chapter 116 of the General Statutes is amended
2 by adding a new section to read:
3 **"§ 116-40.14. Adoption of sanctuary status prohibited.**
4 **(a) A constituent institution shall not have any policy or regulation that limits or restricts**
5 **the enforcement of federal immigration laws to less than the full extent permitted by federal law.**
6 **(b) To the extent permitted by federal law, a constituent institution shall not do any of the**
7 **following related to information regarding the immigration status of any individual:**
8 **(1) Prevent law enforcement officials or agencies from gathering the information.**
9 **(2) Prevent communication of the information to federal law enforcement**
10 **agencies."**
