6	<b>SECTION 1.(c)</b> Stakeholder Engagement. – The LRC shall engage stakeholders,		
7	including fire chiefs and firefighters from rural departments, representatives of statewide		
8	organizations for firefighters and fire departments, rural community leaders, and the Office of		
9	State Fire Marshal. The LRC shall conduct at least three public hearings, one in each geographic		
10	region of the State (Western, Central, and Eastern North Carolina), to gather public input and		
11	recommendations. The LRC shall open a public comment period of at least 90 days during which		
12	individuals, fire departments, and organizations may submit feedback.		
13	<b>SECTION 1.(d)</b> Report and Legislative Action. – The LRC shall submit an interim		
14	report on the results of the study authorized by this section, including any recommended		
15	legislation, to the 2025 General Assembly when it reconvenes for the 2026 session. The LRC		
16	shall submit a final report to the 2027 General Assembly.
