1 moves to amend the bill on page 3, lines 32-33, by inserting the following between the lines:

3 "SECTION 2.5.(a) G.S. 115C-47 reads as rewritten:

4 "§ 115C-47. Powers and duties generally.

5 In addition to the powers and duties designated in G.S. 115C-36, local boards of education
6 shall have the power or duty:

7 ...

8 (18) To Make Rules Concerning the Conduct and Duties of Personnel. – Local
9 boards of education, upon the recommendation of the superintendent, shall
10 ~~have full power to make all just and needful rules and regulations~~ adopt
11 policies governing the conduct of ~~teachers, principals, and~~
12 ~~supervisors, employees,~~ the kind of reports they shall make, and their duties in
13 the care of school property. The policies governing the conduct of employees
14 shall prohibit discrimination based on an individual's protected classification
15 under federal law, including antisemitism as defined in G.S. 12-3.2.

16 Prior to the beginning of each school year, each local board of education
17 shall identify all reports, including local school required reports, that are
18 required at the local level for the school year and shall, to the maximum extent
19 possible, eliminate any duplicate or obsolete reporting requirements and
20 consolidate remaining reporting requirements. No additional reports shall be
21 required at the local level after the beginning of the school year without the
22 prior approval of the local board of education.

23 Prior to the beginning of each school year, each local board of education
24 shall also identify software protocols such as NC Wise that could be used to
25 minimize repetitious data entry by teachers and shall make them available to
26 teachers.

27 Each local board of education shall appoint a person or establish a local
28 paperwork control committee to monitor all reports and other paperwork
29 required of teachers by the central office and to monitor teachers' access to
30 software protocols that minimize repetitious data entry.

1 "(b) Governing body policies shall include or provide for the development of a Code of
2 Student Conduct that notifies students of the standards of behavior expected of them, conduct
3 that may subject them to discipline, and the range of disciplinary measures that may be used by
4 school officials. The Code of Student Conduct shall prohibit discrimination based on an
5 individual's protected classification under federal law, including antisemitism as defined in
6 G.S. 12-3.2."
