Publication and inspection of certain Each local board of education shall maintain a record of each of its employees, (a) showing the following information with respect to each employee: Name. (1) (2) Age. (3) Date of original employment or appointment. The terms of any contract by which the employee is employed whether written (4) or oral, past and current, to the extent that the board has the written contract or a record of the oral contract in its possession. Current position. (5) Title. (6) Current salary.total compensation, as defined in sub-subdivision a. of (7) subdivision (1) of subsection (b1) of this section. Date and amount of each increase or decrease in salary total compensation, as (8) defined in sub-subdivision a. of subdivision (1) of subsection (b1) of this section, with that local board of education. Date and type of each promotion, demotion, transfer, suspension, separation, (9) or other change in position classification with that local board of education. Date and general description of the reasons for each promotion with that local (10)board of education. Date and type of each dismissal, suspension, or demotion for disciplinary (11)reasons taken by the local board of education. If the disciplinary action was a dismissal, a copy of the written notice of the final decision of the local board education setting forth the specific acts or omissions that are the basis of the dismissal.
