

49 October 1 of each year. A late fee shall be charged for the renewal of licenses after that date. Any
50 license not renewed shall expire on October 1 of that year.

1 (d) Teacher licenses shall be renewed every two years on or before October 1. A late fee 2 shall be charged for the renewal of licenses after that date. Any license not renewed shall expire 3 on October 1 of that year.

4 (e) Prior to renewal of a license, license or certificate, a teacher, cosmetologist, 5 esthetician, certified natural hair care specialist, or manicurist shall annually complete eight hours 6 of Board-approved continuing education for each year of the licensing cycle. A cosmetologist 7 may complete up to 24 hours of required continuing education at any time within the 8 cosmetologist's three-year licensing cycle. Licensees shall submit written documentation to the 9 Board showing that they have satisfied the requirements of this subsection. A licensee or 10 certificate holder, if applicable, who is in active practice as a cosmetologist, esthetician, certified natural hair care specialist, or manicurist, has practiced for at least 10 consecutive years in that 11 12 profession, and is 60 years of age or older does not have to meet the continuing education 13 requirements of this subsection. A licensee who is in active practice as a cosmetologist and has 14 at least 20 consecutive years of experience as a cosmetologist, does not have to meet the 15 continuing education requirements of this subsection, but shall report any continuing education 16 classes completed to the Board, whether the continuing education classes are Board-approved or 17 not. Promotion of products and systems shall be allowed at continuing education given in-house 18 or at trade shows. Continuing education classes may also be offered in secondary languages as 19 needed. No member of the Board may offer continuing education courses as required by this 20 section.

(f) If an apprentice, cosmetologist, esthetician, manicurist, <u>certified</u> natural hair care specialist, or teacher fails to renew his or her license <u>or certificate</u>, as <u>applicable</u>, within five years following the expiration date, the licensee <u>or certificate holder</u> shall be required to pass an examination as prescribed by the Board before the license <u>or certificate</u> will be reinstated.

(g) Cosmetic art school licenses shall be renewed on or before October 1 of each year. A
late fee shall be charged for licenses renewed after that date. Any license not renewed by
November 1 of that year shall expire. A cosmetic art school whose license has been expired for
one year or less shall have its license reinstated upon payment of the reinstatement fee, the late
fee, and all unpaid license fees.

30 Upon request by a licensee or certificate holder for inactive status, the Board may (h) 31 place the licensee's or certificate holder's name on the inactive list so long as the licensee or 32 certificate holder is in good standing with the Board. An inactive licensee or certificate holder is 33 not required to complete continuing education requirements. An inactive licensee shall not 34 practice cosmetic art for consideration. An inactive certificate holder shall not hold themselves 35 out or advertise as a certified natural hair care specialist while on inactive status but may continue 36 to practice natural hair care. However, the inactive licensee or certificate holder may continue to 37 purchase supplies as accorded an active licensee. licensee or certificate holder. When the inactive 38 licensee or certificate holder desires to be removed from the inactive list and return to active 39 practice, the inactive licensee or certificate holder shall notify the Board of his or her desire to 40 return to active status and pay the required fee as determined by the Board. As a condition of returning to active status, the Board may require the licensee or certificate holder to complete 41 42 eight to 24 hours of continuing education pursuant to subsection (e) of this section."
