

2	AN ACT ALLOWING LAW ENFORCEMENT OFFICERS WHO ARE MEMBERS OF THE
3	TEACHERS' AND STATE EMPLOYEES' RETIREMENT SYSTEM OR THE LOCAL
4	GOVERNMENTAL EMPLOYEES' RETIREMENT SYSTEM TO RETIRE WITH
5	UNREDUCED BENEFITS AFTER ACHIEVING TWENTY-FIVE YEARS OF
6	CREDITABLE SERVICE AND MAKING CONFORMING CHANGES TO THE
7	RELATED LAWS.
8	The General Assembly of North Carolina enacts:

10	PART I. ALLOW LAW ENFORCEMENT OFFICERS TO RETIRE WITH
11	UNREDUCED BENEFITS AFTER TWENTY-FIVE YEARS OF CREDITABLE
