1	(d) Report. – Before February 15 of each year, the Agency shall report to the Joint
2	Legislative Oversight Committee on General Government and the Fiscal Research Division on
3	the number of loans made under this section in the previous calendar year, the amount of each
4	loan, and the recipient of each loan."
5	SECTION 2. The State Controller shall transfer the sum of forty million dollars
6	(\$40,000,000) in nonrecurring funds for the 2025-2026 fiscal year from funds available in the
7	Economic Development Project Reserve, established in Section 2.2 of S.L. 2021-180, to the
8	North Carolina Housing Trust Fund; such funds are hereby appropriated for the purposes outlined
9	in this act.
10	SECTION 3. This act becomes effective July 1, 2025.
