SECTION 1.(b) The Task Force established under subsection (a) of this section shall e the following duties: Research ways to increase collaboration among State, federal, and private entities involved in the promotion of science, technology, and innovation in the State. (2) Research ways to streamline State, federal, and private resources to promote the science and technology industries in the State. (3) Develop short-, mid-, and long-term economic development-related strategies and recommendations to increase the patronage and prevalence of the science and technology industries in the State. (4) Perform any other studies, evaluations, or determinations the Task Force considers necessary.
