2 AN ACT TO REMOVE TESTING REQUIREMENTS FOR ADMISSION TO AN
3 EDUCATOR PREPARATION PROGRAM, TO MODIFY THE TEACHER LICENSURE
4 EXAMINATION REQUIREMENTS, AND TO MODIFY TEACHER LICENSURE
5 REQUIREMENTS FOR OUT-OF-STATE APPLICANTS.

6 The General Assembly of North Carolina enacts:

7 SECTION 1. G.S. 115C-269.15(a) is repealed.

8 SECTION 2. G.S. 115C-270.15 reads as rewritten:

9 "§ 115C-270.15. Examination requirements.

10 ...

11 (c) Time Line for Completion of Examinations. – The State Board of Education shall
12 permit an applicant to fulfill any such examination requirement before or during the third year of
13 licensure, ~~provided the applicant took the examination at least once during the first year of~~
14 ~~licensure.licensure.~~

15 ...

16 (e) Conversion to Continuing Professional License. – ~~The~~ Except as provided in
17 subsection (f) of this section, the State Board shall not convert an ~~IPL or RL~~ IPL, RL, or limited
18 license to a continuing professional license for a teacher who has not fulfilled the examination
19 requirements of this section.

20 (f) Waiver of Examination Requirements for Certain Individuals with Limited Licenses.
21 – The State Board shall convert a limited license to a continuing professional license for a teacher
22 who has available growth data under the Education Value-Added Assessment System (EVAAS)
23 and has a positive growth score for two of the three most recent years for which growth scores
24 are available."

25 SECTION 3. G.S. 115C-270.25 reads as rewritten:

26 "§ 115C-270.25. Out-of-state license applicants.

27 The State Board of Education shall grant a CPL to a teacher licensed in another state ~~with~~
28 ~~substantially similar licensure requirements~~ who has at least three years of teaching experience
29 and is in good standing with the other state."

30 SECTION 4.(a) There is appropriated from the General Fund to the Department of
31 Public Instruction the sum of fifty thousand dollars (\$50,000) in nonrecurring funds for the
32 2026-2027 fiscal year for the purpose of implementing the requirements of this act.

33 SECTION 4.(b) This section becomes effective July 1, 2026.

34 SECTION 5. Except as otherwise provided, this act is effective when it becomes
35 law.
