"SECTION 1.1. Subdivision (5) of Section 6.2 of S.L. 2026-1 reads as rewritten:

"(5) Funds allocated to the Office of State Budget and Management by Section
10 12.2(f)(2) of S.L. 2023-134 to provide a grant to the Burke Partnership for
11 Economic Development, Inc., a nonprofit corporation, (Partnership) to install
12 water and wastewater at the Western NC Megasite ~~shall, and remaining~~
13 ~~unspent and unencumbered as of the effective date of this section, shall,~~
14 notwithstanding that subdivision or any provision of law to the contrary, be
15 ~~reallocated to Burke County to be used for water and wastewater projects in~~
16 ~~Burke County identified in an application as, and used as, matching funds for~~
17 a grant applied for and awarded by the United States Department of
18 Commerce, Economic Development Administration. The Partnership shall
19 not expend or encumber funds identified in the application until a
20 determination regarding the grant is made. In the event the grant is not
21 awarded on or before October 1, 2026, the Partnership shall distribute the
22 funds, including any interest earned thereon, as follows: eighty percent (80%)
23 to Burke County and twenty percent (20%) to McDowell County. The
24 recipient counties shall use the funds distributed pursuant to this subdivision
25 to construct or improve water infrastructure, sewer infrastructure, or both."
