2 AN ACT TO MAKE VARIOUS CHANGES REGARDING ELECTION LAWS.
3 The General Assembly of North Carolina enacts:

4
5 **PART I. REVISIONS TO BALLOT COUNTING PROCEDURE**

6 **SECTION 1.1.(a)** G.S. 163-182.2(a)(4) is recodified as G.S. 163-182.2(a2).

7 **SECTION 1.1.(b)** G.S. 163-182.2(a)(6) is recodified as G.S. 163-182.2(a3).

8 **SECTION 1.1.(c)** G.S. 163-182.2, as amended by this section, reads as rewritten:

9 **"§ 163-182.2. Initial counting of official ballots.**

10 (a) The initial counting of official ballots cast at the precinct on election day ~~and under~~
11 ~~Part 5 of Article 14A of this Chapter~~ shall be conducted according to the following principles:

12 (1) ~~Vote counting of ballots cast at the precinct on election day shall occur~~
13 ~~immediately after the polls close and shall be continuous until completed. If~~
14 ~~ballots cast under Part 5 of Article 14A of this Chapter are counted~~
15 ~~electronically, that count shall commence at the time the polls close. If ballots~~
16 ~~cast under Part 5 of Article 14A of this Chapter are paper ballots counted~~
17 ~~manually, that count shall commence at the same time as mail-in absentee~~
18 ~~ballots cast under Article 20 or Article 21A of this Chapter are counted.~~

19 (2) ~~Vote counting at the precinct shall be conducted with the participation of~~
20 ~~precinct officials of all political parties then present. Vote counting at the~~
21 ~~county board of elections shall be conducted in the presence or under the~~
22 ~~supervision of board members of all political parties then present.~~

23 (3) Any member of the public wishing to witness the vote count at any level shall
24 be allowed to do so. No witness shall interfere with the orderly counting of
25 the official ballots. Witnesses shall not participate in the official counting of
26 official ballots.

27 (4) Recodified.

28 (5) Precinct officials shall provide a preliminary report of the vote counting ~~on~~
29 ~~election day~~ to the county board of elections as quickly as possible. The
30 preliminary report shall be unofficial, has no binding effect upon the official
31 county canvass to follow, and shall include the number of provisional ballots
32 cast in that precinct.

33 (6) Recodified.



1 (a1) The initial counting of official ballots cast under Part 5 of Article 14A of this Chapter
2 shall be conducted according to the following principles:

3 (1) Vote counting shall occur at the time and place stated in a resolution adopted
4 by the county board at least two weeks prior to election day, provided that the
5 time stated in the resolution is between 9:00 A.M. and 5:00 P.M. on election
6 day. The county board shall not reveal the result of the count prior to the close
7 of polls on election day.

8 (2) Vote counting shall be conducted in the presence or under the supervision of
9 county board members of all political parties then present.

10 (3) Any member of the public wishing to witness the vote count shall be allowed
11 to do so. No witness shall interfere with the orderly counting of the official
12 ballots. Witnesses shall not participate in the counting of official ballots.

13 (4) County boards may review for approval any provisional official ballots and
14 may take preparatory steps for the count of such ballots at a meeting held by
15 the county board prior to election day, pursuant to a resolution adopted by the
16 county board at least two weeks in advance of the meeting, as long as the
17 preparatory steps do not reveal the result of the count prior to the close of polls
18 on election day.

19 (a2) If the county board finds that an individual voting a provisional official ballot (i) was
20 registered in the county as provided in 163-82.1, (ii) voted in the proper precinct under
21 G.S. 163-55 and G.S. 163-57, and (iii) was otherwise eligible to vote, the provisional official
22 ballots shall be counted by the county board no later than ~~5:00 P.M. on the third-fifth~~ business
23 day after the election. Except as provided in G.S. 163-82.15(e), if the county board finds that an
24 individual voting a provisional official ballot (i) did not vote in the proper precinct under
25 G.S. 163-55 and G.S. 163-57, (ii) is not registered in the county as provided in G.S. 163-82.1, or
26 (iii) is otherwise not eligible to vote, the ballot shall not be counted. If a voter was properly
27 registered to vote in the election by the county board, no mistake of an election official in giving
28 the voter a ballot or in failing to comply with G.S. 163-82.15 or G.S. 163-166.11 shall serve to
29 prevent the counting of the vote on any ballot item the voter was eligible by registration and
30 qualified by residency to vote. When an individual has voted a provisional official ballot after
31 completing an affidavit under G.S. 163-166.16(d), and the county board has determined that there
32 are grounds to believe the affidavit is false within five business days after the election, the county
33 board shall determine whether to count the provisional official ballot by the date of the county
34 canvass.

35 (a3) In counties that use any certified mechanical or electronic voting system, subject to
36 the sample counts under G.S. 163-182.1 and subdivision (2) of subsection (b) of this section, and
37 of a hand-to-eye recount under G.S. 163-182.7 and G.S. 163-182.7A, a county board of elections
38 shall rely in its canvass on the mechanical or electronic count of the vote rather than the full
39 hand-to-eye count of the paper ballots or records. In the event of a material discrepancy between
40 the electronic or mechanical count and a hand-to-eye count or recount, the hand-to-eye count or
41 recount shall control, except where paper ballots or records have been lost or destroyed or where
42 there is another reasonable basis to conclude that the hand-to-eye count is not the true count.

43 (a4) Any resolution required by this section shall be published once a week for two weeks
44 prior to the election in a newspaper having general circulation in the county. Notice may
45 additionally be made on a radio or television station or both, but the notice shall be in addition to
46 the newspaper and other required notice.

47 (b) The State Board shall promulgate rules for the initial counting of all official ballots.
48 All election officials shall be governed by those rules. In promulgating those rules, the State
49 Board shall adhere to the following guidelines:

- 1 (1) For each voting system used, the rules shall specify the role of precinct
2 officials and of the county board of ~~elections~~ in the initial counting of official
3 ballots.
- 4 (2) For optical scan and direct record electronic voting systems, and for any other
5 voting systems in which ballots are counted other than on paper by hand and
6 eye, those rules shall provide for a sample hand-to-eye count of the paper
7 ballots of a sampling of a statewide ballot item in every county. The
8 presidential ballot item shall be the subject of the sampling in a presidential
9 election. If there is no statewide ballot item, the State Board shall provide a
10 process for selecting district or local ballot items to adequately sample the
11 electorate. The State Board shall approve in an open meeting the procedure
12 for random sampling for each election. The random sampling for any county
13 shall be done publicly after the initial count of election returns for that county
14 is publicly released or 24 hours after the polls close on election day, whichever
15 is earlier. The sample chosen by the State Board shall be of one or more full
16 precincts, full counts of mailed absentee ballots, and full counts of one or more
17 early voting sites. The size of the sample of each category shall be chosen to
18 produce a statistically significant result and shall be chosen after consultation
19 with a statistician. The actual units shall be chosen at random. In the event of
20 a material discrepancy between the electronic or mechanical count and a
21 hand-to-eye count, the hand-to-eye count shall control, except where paper
22 ballots have been lost or destroyed or where there is another reasonable basis
23 to conclude that the hand-to-eye count is not the true count. If the discrepancy
24 between the hand-to-eye count and the mechanical or electronic count is
25 significant, a complete hand-to-eye count shall be conducted. The sample
26 count need not be done on election night.
- 27 (3) The rules shall provide for accurate unofficial reporting of the results from the
28 precinct to the county board of ~~elections~~ with reasonable speed on the night
29 of the election.
- 30 (4) The rules shall provide for the prompt and secure transmission of official
31 ballots from the voting place to the county ~~board of elections~~ board.

32 (c) The State Board shall direct the county boards of ~~elections~~ in the application of the
33 principles and rules in individual circumstances."

34 **SECTION 1.2.(a)** G.S. 163-82.4(f) reads as rewritten:

35 "(f) Correcting Registration Forms. – If the voter fails to complete any required item on
36 the voter registration form but provides enough information on the form to enable the county
37 board to identify and contact the voter, the voter shall be notified of the omission and given the
38 opportunity to complete the form at least by 12:00 P.M. on the ~~third~~ fifth business day after the
39 election. If the voter corrects that omission within that time and is determined by the county
40 board to be eligible to vote, the county board shall permit the voter to vote. If the information is
41 not corrected by election day, the voter shall be allowed to vote a provisional official ballot. If
42 the correct information is provided to the county board by at least 12:00 P.M. on the ~~third~~ fifth
43 business day after the election, the county board shall count any portion of the provisional official
44 ballot that the voter is eligible to vote."

45 **SECTION 1.2.(b)** G.S. 163-166.12(d) reads as rewritten:

46 "(d) Voting When Identification Numbers Do Not Match. – Regardless of whether an
47 individual has registered by mail or by another method, if the individual has provided with the
48 registration form a drivers license number or last four digits of a Social Security number but the
49 computer validation of the number as required by G.S. 163-82.12 did not result in a match, and
50 the number has not been otherwise validated by the county board, in the first election in which
51 the individual votes that individual shall submit with the ballot the form of identification

1 described in subsection (a) or subsection (b) of this section, depending upon whether the ballot
2 is voted in person or absentee. If that identification is provided no later than 12:00 P.M. on the
3 ~~third-fifth~~ business day after the election and the county board does not determine that the
4 individual is otherwise ineligible to vote a ballot, the failure of identification numbers to match
5 shall not prevent that individual from registering to vote and having that individual's vote
6 counted."

7 **SECTION 1.2.(c)** G.S. 163-166.16(c) reads as rewritten:

8 "(c) Provisional Ballot Required Without Photo Identification. – If the registered voter
9 cannot produce the identification as required in subsection (a) of this section, the registered voter
10 may cast a provisional ballot that is counted only if the registered voter brings an acceptable form
11 of photograph identification listed in subsection (a) of this section to the county board no later
12 than 12:00 P.M. on the ~~third-fifth~~ business day after the election. The State Board shall provide
13 the registered voter casting a provisional ballot due to failure to provide photo identification an
14 information sheet on the deadline to return to the county board to present photo identification,
15 and what forms of photo identification are acceptable, in order for the voter's provisional ballot
16 to be counted."

17 **SECTION 1.2.(d)** G.S. 163-230.1(e1) reads as rewritten:

18 "(e1) Curable Deficiencies. – If a container-return envelope contains a curable deficiency,
19 the county board shall ~~promptly~~ notify the voter of the deficiency and the manner in which the
20 voter may cure the deficiency. Curable deficiencies are deficiencies that can be cured with
21 supplemental documentation or attestation provided by the voter, including when any of the
22 following occurs:

- 23 (1) The voter did not sign the voter certification as required by
24 G.S. 163-231(a)(4).
- 25 (2) The voter signed the application in the wrong place on the application.
- 26 (3) The voter failed to include with the container-return envelope a photocopy of
27 identification described in G.S. 163-166.16(a) or an affidavit as described in
28 G.S. 163-166.16(d)(1), (d)(2), or (d)(3), as required by subsection (f1) of this
29 section.

30 The identification of the two persons witnessing the casting of the absentee ballot in
31 accordance with G.S. 163-231(a) is not a curable deficiency. Any container-return envelope with
32 a curable deficiency that is transmitted to the county board shall be considered timely if cure
33 documentation is received no later than 12:00 P.M. on the ~~third-fifth~~ business day after the
34 election. Cure documentation may be transmitted via email to the county board if the deficiency
35 is one described in subdivision (3) of this subsection. The notification of voters regarding curable
36 deficiencies is an administrative task that may be performed by county board staff and is not
37 required to be performed at an absentee meeting as provided for in subsection (f) of this section.
38 The voter shall be notified of curable deficiencies no later than the close of business on the next
39 business day following the county boards' review of the ballot by mail, and by telephone or ~~email~~
40 email, if the telephone number or email address was provided by the voter on the request form
41 for absentee ballots."

42 **SECTION 1.3.** G.S. 163-231 reads as rewritten:

43 **"§ 163-231. Voting absentee ballots and transmitting them to the county board of elections.**

44 (a) Procedure for Voting Absentee Ballots. – In the presence of two persons who are at
45 least 18 years of age, and who are not disqualified by G.S. 163-226.3(a)(4) or G.S. 163-237(c),
46 the voter shall do all of the following:

- 47 (1) Mark the voter's ballots, or cause them to be marked by that person in the
48 voter's presence according to the voter's instruction.
- 49 (2) Fold each ballot separately, or cause each of them to be folded in the voter's
50 presence.

- 1 (3) Place the folded ballots in the container-return envelope and securely seal it,
2 or have this done in the voter's presence.
- 3 (4) Make the application printed on the container-return envelope according to
4 the provisions of G.S. 163-229(b) and make the certificate printed on the
5 container-return envelope according to the provisions of G.S. 163-229(b).
- 6 (5) Require those two persons in whose presence the voter marked that voter's
7 ballots to sign and print their names on the application and certificate as
8 witnesses and to indicate those persons' addresses. Failure to list a ZIP code
9 does not invalidate the application and certificate. Failure to include a printed
10 witness name does not invalidate the application and certificate if the identity
11 of an individual can solely be ascertained by the witness's signature.
- 12 (6) Do one of the following:
- 13 a. Have the application notarized. The notary public may be the person
14 in whose presence the voter marked that voter's ballot.
- 15 b. Have the two persons in whose presence the voter marked that voter's
16 ballots to certify that the voter is the registered voter submitting the
17 marked ballots.

18 Alternatively to the prior paragraph of this subsection, any requirement for two witnesses
19 shall be satisfied if witnessed by one notary public, who shall comply with all the other
20 requirements of that paragraph. The notary shall affix a valid notarial seal to the envelope, and
21 include the word "Notary Public" below his or her signature.

22 The persons in whose presence the ballot is marked shall at all times respect the secrecy of
23 the ballot and the privacy of the absentee voter, unless the voter requests assistance and that
24 person is otherwise authorized by law to give assistance. When thus executed, the sealed
25 container-return envelope, with the ballots enclosed, shall be transmitted in accordance with the
26 provisions of subsection (b) of this section to the county board of elections which issued the
27 ballots.

28 (b) ~~Transmitting Executed Absentee Ballots to County Board of Elections.~~ Board. – The
29 sealed container-return envelope in which executed absentee ballots have been placed shall be
30 transmitted to the county board of elections who issued those ballots as follows:

- 31 (1) All ballots issued under the provisions of this Article and Article 21A of this
32 Chapter shall be transmitted by one of the following means:
- 33 a. Mail or commercial courier service, at the voter's expense, and
34 received by the county board not later than 7:30 P.M. on the day of the
35 statewide primary or general election or county bond election.
- 36 b. Delivered in person, by the voter or the voter's near relative or
37 verifiable legal guardian, to the county board not later than 7:30 P.M.
38 on the day of the statewide primary or general election or county bond
39 election.
- 40 c. Electronically transmitted to the county board, if the ballot was issued
41 under the provisions of Article 21A of this Chapter.
- 42 d. Submitted through the accessible absentee portal, if the ballot was
43 issued to a visually impaired voter who requested an accessible ballot.
- 44 (2) If ballots are received later than the hour stated in subdivision (1) of this
45 subsection, those ballots shall not be accepted unless required by federal law
46 or the ballots are received in accordance with Article 21A of this Chapter or
47 the State Board or court order extended the closing time of the polls for every
48 poll in the county in accordance with G.S. 163-166.25. If the State Board or
49 court order so extended the closing time of the polls, the ballots shall be
50 received by the closing time as extended by the State Board or court order in
51 order to be counted.

1 (c) Delivering Executed Absentee Ballots in Person. – For purposes of this section,
2 "Delivered in person" includes physically handing the voted absentee ballot to an election official
3 at an early voting site under Part 5 of Article 14A of this Chapter during any time that early
4 voting site is open for voting, but does not include depositing the voted absentee ballot in a drop
5 box or other location designated for the return of voted absentee ballots. The voted absentee
6 ballots delivered to the early voting site shall be kept securely and delivered by election officials
7 at that early voting site to the county board of elections office for processing.

8 (d) Counting of Executed Absentee Ballots. – Only those voted absentee ballots
9 transmitted to a county board in accordance with this section shall be counted."

10 **SECTION 1.4.** G.S. 163-234 reads as rewritten:

11 **"§ 163-234. Counting absentee ballots by county board.**

12 All absentee ballots returned to the county board in the container-return envelopes shall be
13 retained by the county board to be counted by the county board as follows:

14 ...

15 (2) The county board shall meet at ~~5:00 P.M. on election day~~ in the county board
16 office or other public location in the county courthouse at the hour stated in a
17 resolution adopted by the county board at least two weeks prior to the time the
18 voting place opens in accordance with G.S. 163-166.25, provided that the time
19 stated in the resolution is between 9:00 A.M. and 5:00 P.M., for the purpose
20 of counting all absentee ballots except those which have been challenged
21 before 5:00 P.M.–9:00 A.M. on election day and those received pursuant to
22 G.S. 163-231(b)(2). Any elector of the county shall be permitted to attend the
23 meeting and allowed to observe the counting process, so long as the elector
24 does not in any manner interfere with the election officials in the discharge of
25 their duties. ~~The count of these absentee ballots shall be continuous until~~
26 ~~completed, and the members shall not separate or leave the counting place~~
27 ~~except for unavoidable necessity.~~

28 ~~The county board may begin counting absentee ballots issued under~~
29 ~~Article 21A of this Chapter between the hours of 9:00 A.M. and 5:00 P.M.~~
30 ~~and may begin counting all absentee ballots between the hours of 2:00 P.M.~~
31 ~~and 5:00 P.M. upon the adoption of a resolution at least two weeks prior to the~~
32 ~~election in which the hour and place of counting absentee ballots shall be~~
33 ~~stated. A copy of the resolution shall be published once a week for two weeks~~
34 ~~prior to the election, in a newspaper having general circulation in the county.~~
35 ~~Notice may additionally be made on a radio or television station or both, but~~
36 ~~the notice shall be in addition to the newspaper and other required notice. The~~
37 ~~count shall be continuous until completed and the members shall not separate~~
38 ~~or leave the counting place except for unavoidable necessity. The county~~
39 board may recess the meeting prior to completing the count of these absentee
40 ballots but shall not adjourn the meeting until the count of these absentee
41 ballots is complete, except that if the count has been completed prior to the
42 time the polls close, it shall be suspended until that time pending receipt of
43 any additional ballots. Nothing in this section prohibits a county board from
44 taking preparatory steps for the count earlier than the times specified in this
45 section, as long as the preparatory steps do not reveal to any individual not
46 engaged in the actual count election results before the times specified in this
47 subdivision for the count to begin. By way of illustration and not limitation, a
48 preparatory step for the count would be the entry of tally cards from direct
49 record electronic voting units into a computer for processing. The county
50 board shall not announce the result of the count ~~before 7:30 P.M. prior to the~~
51 close of polls on election day.

- 1 ...
- 2 (11) The county board ~~shall~~may meet after the day of the election and prior to the
- 3 day of canvass to count absentee ballots received pursuant to
- 4 G.S. 163-231(b)(2) upon the adoption of a resolution pursuant to subdivision
- 5 (2) of this section. The county board shall comply with all other requirements
- 6 of this section and G.S. 163-230.1 for the counting of these absentee ballots.
- 7 (12) No later than ~~5:00 P.M. on the third~~fifth business day after the election, the
- 8 county board shall announce the tally of all absentee ballots, except those
- 9 subject to a challenge or those cast in accordance with Article 21A of this
- 10 Chapter."

11 **SECTION 1.5.** G.S. 163-275 is amended by adding a new subdivision to read:

12 "(15) For any person to reveal the result of any count of ballots prior to the close of

13 polls on election day in accordance with G.S. 163-182.2 or G.S. 163-234."

14 **SECTION 1.6.** Section 1.5 of this Part is effective when it becomes law and applies

15 to offenses committed on or after that date. The remainder of this Part is effective when it

16 becomes law and applies to elections held on or after that date.

18 PART II. VARIOUS ELECTION ADMINISTRATION CHANGES

20 PARTY DESIGNATIONS ON BALLOT

21 **SECTION 2.1.(a)** G.S. 163-165.5(a)(4) reads as rewritten:

22 "(4) Party designations in partisan ballot items. Party designations shall be printed

23 in the same font type and size as the name of the candidate."

24 **SECTION 2.1.(b)** This section becomes effective January 1, 2027, and applies to

25 elections held on or after that date.

26

27 SUSPENSION AND TRAINING OF PRECINCT OFFICIALS

28 **SECTION 2.2.(a)** Article 5 of Chapter 163 of the General Statutes is amended by

29 adding a new section to read:

30 "**§ 163-41.3. Suspension or removal of precinct officials; vacancies.**"

31 **SECTION 2.2.(b)** G.S. 163-41(d) is recodified as G.S. 163-41.3.

32 **SECTION 2.2.(c)** G.S. 163-41, as amended by this section, reads as rewritten:

33 "**§ 163-41. Precinct chief judges and judges of election; appointment; terms of office;**

34 **qualifications; ~~vacancies~~; oaths of office.**

35 (a) Appointment of Chief Judge and Judges. – At the meeting required by G.S. 163-31 to

36 be held on the Tuesday following the third Monday in August of the year in which they are

37 appointed, the county board ~~of elections~~ shall appoint one person to act as chief judge and two

38 other persons to act as judges of election for each precinct in the county. Their terms of office

39 shall continue for two years from the specified date of appointment and until their successors are

40 appointed and qualified, except that if a nonresident of the precinct is appointed as chief judge

41 or judge for a precinct, that person's term of office shall end if the county board of elections

42 appoints a qualified resident of the precinct of the same party to replace the nonresident chief

43 judge or judge. It shall be ~~their~~the duty of the precinct officials to conduct the primaries and

44 elections within their respective precincts. Persons appointed to these offices must be registered

45 voters and residents of the county in which the precinct is located, of good repute, and able to

46 read and write. Not more than one judge in each precinct shall belong to the same political party

47 as the chief judge.

48 (b) ~~The~~As used in this Article, the term "precinct official" shall mean chief judges and

49 judges appointed pursuant to this section, and all assistants appointed pursuant to G.S. 163-42,

50 unless the context of a statute clearly indicates a more restrictive meaning.

1 ~~(b1) No person shall be eligible to serve as a precinct official, as that term is defined above,~~
 2 ~~who holds official if any of the following apply:~~

3 (1) The person holds any elective office under the government of the United
 4 States, or of the State of North Carolina or any political subdivision thereof.

5 ~~(2) No person shall be eligible to serve as a precinct official who is~~ The person is
 6 a candidate for nomination or election.

7 ~~(3) No person shall be eligible to serve as a precinct official who holds~~ The person
 8 holds any office in a state, congressional district, county, or precinct political
 9 party or political organization, or who is a manager or treasurer for any
 10 candidate or political party, provided however that the position of delegate to
 11 a political party convention shall not be considered an office for the purpose
 12 of this subsection-subdivision.

13 (4) The person has been prohibited from serving as a precinct official in any
 14 subsequent election in accordance with G.S. 163-41.3(a).

15 "

16 **SECTION 2.2.(d)** G.S. 163-41.3, as enacted by this section, reads as rewritten:

17 "**§ 163-41.3. Suspension or removal of precinct officials; vacancies.**

18 (a) Any precinct official may be suspended or removed, including on the day of the
 19 election or primary, for incompetency or failure to discharge the duties of office by the county
 20 board in accordance with G.S. 163-33. The county board may prohibit a precinct official who
 21 has been suspended or removed from serving as a precinct official in any subsequent election.

22 (b)

23 "

24 **SECTION 2.2.(e)** G.S. 163-33(2) reads as rewritten:

25 "(2) To appoint all chief judges, judges, assistants, and other officers of elections,
 26 and designate the precinct in which each shall serve; and, after notice and
 27 hearing, to suspend or remove any chief judge, judge of elections, assistant,
 28 or other officer of election appointed by it for incompetency, failure to
 29 discharge the duties of office, failure to qualify within the time prescribed by
 30 law, fraud, or for any other satisfactory cause.—cause, as provided in
 31 G.S. 163-41.3. In exercising the powers and duties of this subdivision, the
 32 board may act only when a majority of its members are present at any meeting
 33 at which such powers or duties are exercised."

34 **SECTION 2.2.(f)** G.S. 163-42(c) reads as rewritten:

35 "(c) In addition, a county board ~~of elections~~ by unanimous vote of all of its members may
 36 appoint any registered voter in the county as an emergency election-day assistant, as long as that

 48 controlled by the State, any subdivision of the State, any other public agency,
 49 or any private institution or agency of a charitable, educational, or

2 concerned with public recreation, cultural activities, and other events of a

- c. Contains or is accompanied by information as to how the registrant may continue to be eligible to vote if the registrant has moved outside the county.
- d. Contains a pre-printed space which can be marked to indicate that the registrant does not reside at the address given by the registrant and that the mailing should be returned to the appropriate sender.

"(9) To the State Board of Elections for the purpose of voter registration and list maintenance on a routine schedule of no later than the fifteenth day of each month."

SECTION 2.8.(c) If the State Board of Elections received information regarding potential ineligible voters appearing on the State's voter registration records from a federal database on or after January 1, 2026, and a challenge has not been entered against a voter appearing on the information from the federal database and the voter has not otherwise been removed from the list of eligible voters in the State, then the State Board of Elections shall create a process for removing such voters from the State's voter registration records by August 1, 2026.

The process created by the State Board of Elections pursuant to this subsection for removing any potential ineligible voters from the State's voter registration records shall comply with the following:

- (1) The Executive Director of the State Board of Elections shall distribute to each county board of elections the names of the individuals registered to vote in that county whose name appears on the information received from a federal database as a potential ineligible voter.
- (2) Upon receipt of the names from the Executive Director of the State Board, the chair of the county board of elections shall initiate a challenge proceeding under G.S. 163-85, with the burden of proof remaining on the challenger pursuant to G.S. 163-90.1.
- (3) The registered voter shall be sent notice that the chair of the county board of elections initiated a challenge proceeding on the registered voter's eligibility due to the fact that the State Board of Elections received information from a federal database calling into question the eligibility of the registered voter.
- (4) Any hearing on the challenge shall be conducted pursuant to G.S. 163-86.

- 9 (b1) No person may be compensated based on the number of signatures collected for a

- 11 (c) Any person who willfully violates this section is guilty of a Class 2 misdemeanor."
 12 **SECTION 2.9.(b)** This section becomes effective December 1, 2026, and applies to

27 **SECTION 2.11.(a)** During the time period that a Class C drivers license expiration
28 date is extended in accordance with Section 18 of S.L. 2025-47, that Class C drivers license shall
29 be deemed valid and unexpired for the purposes of G.S. 163-166.16.

30 **SECTION 2.11.(b)** This section is effective when it becomes law and shall expire
31 December 31, 2027.

32
33 **VOTER REGISTRATION APPLICATIONS INDICATING LACK OF CITIZENSHIP**

34 **SECTION 2.12.(a)** G.S. 163-82.19(a) reads as rewritten:

35 "(a) Voter Registration at Drivers License Offices. – The Division of Motor Vehicles
36 shall, pursuant to the rules adopted by the State ~~Board of Elections, Board,~~ modify its forms so
37 that any eligible person who applies for original issuance, renewal or correction of a drivers
38 license, or special identification card issued under G.S. 20-37.7 may, on a part of the form,
39 complete an application to register to vote, or to update the voter's registration if the voter has
40 changed his or her address or moved from one precinct to another or from one county to another.
41 The person taking the application shall ask if the applicant is a citizen of the United States. If the
42 applicant states that the applicant is not a citizen of the United States, or declines to answer the
43 question, the person taking the application shall inform the applicant that it is a felony for a
44 person who is not a citizen of the United States to apply to register to vote. The application shall
45 state in clear language the penalty for violation of this section. The person taking an application
46 to register to vote or to update the voter's registration shall not proceed with the application if the
47 applicant states that the applicant is not a citizen of the United States or declines to answer the
48 question. The necessary forms shall be prescribed by the State ~~Board of Elections, Board.~~ The
49 form must ask for the previous voter registration address of the voter, if any. If a previous address
50 is listed, and it is not in the county of residence of the applicant, the appropriate county board of
51 elections shall treat the application as an authorization to cancel the previous registration and also

1 process it as such under the procedures of G.S. 163-82.9. If a previous address is listed and that
2 address is in the county where the voter applies to register, the application shall be processed as
3 if it had been submitted under G.S. 163-82.9.

4 Registration shall become effective as provided in G.S. 163-82.7. Applications to register to
5 vote accepted at a drivers license office under this section until the deadline established in
6 G.S. 163-82.6(d)(2) shall be treated as timely made for an election, and no person who completes
7 an application at that drivers license office shall be denied the vote in that election for failure to
8 apply earlier than that deadline.

9 All applications shall be forwarded by the Department of Transportation to the appropriate
10 board of elections not later than five business days after the date of acceptance, according to rules
11 which shall be promulgated by the State ~~Board of Elections.~~ Board. Those rules shall provide for
12 a paperless, instant, electronic transfer of applications to the appropriate board of elections."

13 **SECTION 2.12.(b)** G.S. 163-82.20(e) reads as rewritten:

14 "(e) Prohibitions. – Any person providing any service under subsection (b) of this section

- 21 (3) Make any statement to an applicant or take any action the purpose or effect of
22 which is to discourage the applicant from registering to ~~vote;~~ or vote.

24 which is to lead the applicant to believe that a decision to register or not to
25 register has any bearing on the availability of services or benefits.
- 26 (5) Proceed with any voter registration application if the applicant indicates that
27 the applicant is not a citizen of the United States or declines to answer the
28 question of whether the applicant is a citizen of the United States."

29 **SECTION 2.12.(c)** Article 7A of Chapter 163 of the General Statutes is amended by
30 adding a new section to read:

31 **"§ 163-83. Denial of application for lack of citizenship.**

32 (a) If the county board receives a voter registration application indicating that the
33 applicant is not a citizen of the United States, then the county board shall deny the voter
34 registration application and shall not add the individual to the list of registered voters of the State.
35 The county board shall send notice to the applicant of the denial of the voter registration
36 application and the reason for the denial.

37 (b) If the county board receives a voter registration application in which no answer is
38 indicated for the question of whether the applicant is a citizen of the United States, then the
39 county board shall send notice to the applicant that the voter registration application cannot be
40 processed without a statement from the applicant made under penalty of perjury concerning
41 whether the applicant is a citizen of the United States. The notice sent from the county board
42 shall include a form for the applicant to fill out answering the question of whether the applicant
43 is a citizen of the United States, and shall indicate that the form must be mailed or hand-delivered
44 to the county board within 30 days from the date the notice was sent in order for the applicant's
45 voter registration application to be processed. If the form is received by the county board within
46 30 days from the date the notice was mailed, the county board shall proceed with the voter
47 registration application accordingly. If the form is not received by the county board within 30
48 days from the date the notice was mailed, the county board shall deny the voter registration
49 application and shall not add the individual to the list of registered voters of the State."

50 **SECTION 2.12.(d)** This section becomes effective January 1, 2027, and applies to
51 voter registration applications processed on or after that date.

2 **POST-ELECTION AUDITS BY STATE AUDITOR**

3 **SECTION 2.13.** Article 5A of Chapter 147 of the General Statutes is amended by
4 adding a new section to read:

5 **"§ 147-64.6Q. Audit of general elections.**

6 (a) After the certification of each general election under Chapter 163 of the General
7 Statutes, the Auditor shall select counties of the State in which to conduct post-election audits of
8 election system and controls. The number of audits to be conducted and the selection of counties
9 to be audited is at the discretion of the Auditor, but all county boards of elections must be audited
10 within a reasonable time frame. No county audit under this section shall occur until after the
11 election is certified pursuant to G.S. 163-182.15. Nothing in this section supersedes, overrides,
12 or replaces any procedures in Article 15A of Chapter 163 of the General Statutes. No findings in
13 audits under this section shall be used as grounds to challenge the final result of an election.
14 Audits under this section are in addition to audits conducted under G.S. 163-182.12A.

15 (b) In conducting audits under this section, the Auditor may examine all of the following
16 areas:

- 17 (1) The accuracy of voter rolls and compliance with list maintenance
18 requirements in State and federal law.
19 (2) Procedures for testing voting equipment before counting ballots, including the
20 ballots used for testing the equipment and the storage and maintenance of the
21 equipment.
22 (3) Records of ballots distributed, ballots voted, poll book records, and ballots
23 tabulated.
24 (4) Chain of custody and seal documentation.
25 (5) Absentee ballots, absentee ballot applications, absentee ballot envelopes,
26 registrar records regarding absentee ballots, and records created and used by
27 the ballot board to ensure appropriate processing and counting of absentee
28 ballots.
29 (6) Provisional ballots, provisional ballot envelopes, and records regarding
30 provisional ballots.
31 (7) Compliance with all State and federal laws regarding contact with voters and
32 voter assistance.
33 (8) Any areas of concern regarding election accuracy, security, or credibility
34 uncovered over the course of the audit.

35 (c) The State Board of Elections, each county board of elections, and the Division of
36 Motor Vehicles of the Department of Transportation shall provide ready access to materials,
37 equipment, personnel, or software necessary for audits under this section in accordance with
38 G.S. 147-64.7. Election officials may be present during portions of an audit under this section as
39 necessary to preserve chain of custody, when applicable.

40 (d) The Auditor shall produce periodic reports of the audits conducted under this section
41 and shall submit the reports to the Governor, Lieutenant Governor, Speaker of the House of
42 Representatives, President Pro Tempore of the Senate, State Board of Elections, Joint Legislative
43 Elections Oversight Committee, and Fiscal Research Division. The report shall include details of
44 which areas listed in subsection (b) of this section were examined and the Auditor's findings
45 related to those areas. Before submitting the report, the Auditor shall allow a board of elections
46 for any county discussed in the report to review the report and provide comments to be submitted
47 along with it in accordance with G.S. 147-64.6(c)(13). The reports shall be prominently located
48 on the Office of the State Auditor's website with any appropriate supplementary materials. The
49 reports shall not violate any applicable confidentiality laws.

1 (e) If the Auditor receives or collects information during an audit under this section that
 2 the Auditor believes may be evidence of a violation of State or federal law, the Auditor shall
 3 refer this evidence in accordance with G.S. 147-64.6B.

4 (f) If an error, inefficiency, or vulnerability in a county's election system or controls is
 5 uncovered in an audit under this section, the county board of elections shall submit a report to
 6 the Auditor, the State Board of Elections, and the county board of commissioners outlining its
 7 plan to fix the error, inefficiency, or vulnerability.

8 (g) The Auditor, in collaboration with the State Board of Elections, shall develop an audit
 9 manual that details the policies and procedures guiding audits under this section. This manual
 10 will not have the force of law. The manual shall not be altered within the 90 days preceding an
 11 election in which the manual is utilized to conduct an audit under this section."

13 CHANGE DATE FOR WHEN CERTAIN MUNICIPAL ELECTIONS HELD

14 **SECTION 2.14.(a)** G.S. 163-279(a) reads as rewritten:

15 "(a) Primaries and elections for offices filled by election of the people in cities, towns,
 16 incorporated villages, and special districts shall be held in 1973 and every two or four years
 17 thereafter as provided by municipal charter on the following days:

- 18 (1) If the election is nonpartisan and decided by simple plurality, the election shall
 19 be held on Tuesday after the first Monday in November.
- 20 (2) If the election is partisan, the election shall be held on Tuesday after the first
 21 Monday in November, the first primary shall be held on the second Tuesday
 22 after Labor Day, and the second primary, if required, shall be held on the
 23 fourth Tuesday before the election.
- 24 (3) If the election is nonpartisan and the nonpartisan primary method of election
 25 is used, the election shall be held on Tuesday after the first Monday in
 26 November and the nonpartisan primary shall be held on the ~~fourth Tuesday~~
 27 ~~before the election.~~ second Tuesday after Labor Day.
- 28 (4) If the election is nonpartisan and the election and runoff election method of
 29 election is used, the election shall be held on the ~~fourth Tuesday before the~~
 30 ~~Tuesday after the first Monday in November,~~ second Tuesday after Labor
 31 Day, and the runoff election, if required, shall be held on Tuesday after the
 32 first Monday in November."

33 **SECTION 2.14.(b)** This section becomes effective January 1, 2027, and applies to
 34 elections held on or after that date.

36 ELIGIBILITY TO FILE AS CANDIDATE IN PARTY PRIMARY

37 **SECTION 2.15.(a)** G.S. 163-106.1 reads as rewritten:

38 "**§ 163-106.1. Eligibility to file.**

39 (a) No person shall be permitted to file as a candidate in a party primary unless that person
 40 has been affiliated with that party for at least ~~90~~ 365 days as of the date of that person filing such
 41 notice of candidacy. A person registered as "unaffiliated" shall be ineligible to file as a candidate
 42 in a party primary election.

43 (b) Notwithstanding subsection (a) of this section, a person who has been affiliated with
 44 a party for less than 365 days may file as a candidate in that party's primary if the State executive
 45 committee of the political party with which the candidate is affiliated grants the person a waiver.

 47 waiver request. The waiver must be submitted to the board of elections which has jurisdiction
 48 over the ballot item under G.S. 163-182.4 by the close of the filing period for that office.

49 (c) This section shall not apply to any of the following:

- 50 (1) Candidates selected by party convention or political party caucus.
- 51 (2) Political parties that have been in existence for two years or less."

1 **SECTION 2.15.(b)** This section becomes effective January 1, 2027, and applies to
2 candidates filing in a party primary on or after that date.

4 **CURABLE DEFICIENCY FOR LACK OF SIGNATURE ON PROVISIONAL BALLOTS**

5 **SECTION 2.16.(a)** G.S. 163-166.11 reads as rewritten:

6 **"§ 163-166.11. Provisional voting requirements.**

7 **(a)** If an individual seeking to vote claims to be a registered voter in a jurisdiction as
8 provided in G.S. 163-82.1 and though eligible to vote in the election does not appear on the
9 official list of eligible registered voters in the voting place, that individual may cast a provisional
10 official ballot as follows:

- 11 (1) An election official at the voting place shall notify the individual that the
12 individual may cast a provisional official ballot in that election.
- 13 (2) The individual may cast a provisional official ballot at that voting place upon
14 executing a written affirmation before an election official at the voting place,
15 stating that the individual is a registered voter in the jurisdiction as provided
16 in G.S. 163-82.1 in which the individual seeks to vote and is eligible to vote
17 in that election.
- 18 (3) A voter who has moved within the county more than 30 days before election
19 day but has not reported the move to the county board ~~of elections~~ shall not
20 be required to vote a provisional ballot at the early voting site, as long as the
21 early voting site has available all the information necessary to determine
22 whether a voter is registered to vote in the county and which ballot the voter
23 is eligible to vote based on the voter's proper residence address. The voter with
24 that kind of unreported move shall be allowed to vote the same kind of
25 absentee ballot as other early voters as provided in G.S. 163-166.40.
- 26 (4) At the time the individual casts the provisional official ballot, the election
27 officials shall provide the individual written information stating that anyone
28 casting a provisional official ballot can ascertain whether and to what extent
29 the ballot was counted and, if the ballot was not counted in whole or in part,
30 the reason it was not counted. The State Board or the county board ~~of elections~~
31 available to every provisional voter without charge and contain reasonable
32 procedures to protect the security, confidentiality, and integrity of the voter's
33 personal information and vote.
- 34 (5) The cast provisional official ballot and the written affirmation shall be secured
35 by election officials at the voting place according to guidelines and procedures
36 adopted by the State Board. At the close of the polls, election officials shall
37 transmit the provisional official ballots cast at that voting place to the county
38 board ~~of elections~~ for prompt verification according to guidelines and
39 procedures adopted by the State Board. No later than 12:00 P.M. two days
40 after the close of the polls, the county board ~~of elections~~ shall publish the
41 number of provisional ballots cast on election day, cast by early voting, cast
42 by mail-in absentee ballots received as of election day, and cast by military
43 and overseas absentee ballots cast under Article 21A of this Chapter and
44 received as of election day.

45 **(b)** If a provisional official ballot cast under this section fails to contain the voter's
46 signature on the affidavit to certify the voter's identity and eligibility to vote, the county board
47 shall notify the voter of the lack of signature on the provisional official ballot no later than the
48 close of business on the next business day following review of the ballot and shall provide the
49 voter an opportunity to cure the lack of signature on the affidavit. The voter shall be notified by
50 mail and by telephone or email, if the telephone number or email address was provided by the
51 voter. The notification of voters regarding curing the lack of signature is an administrative task

1 that may be performed by county board staff and is not required to be performed at a meeting of
2 the county board."

3 **SECTION 2.16.(b)** G.S. 163-166.16, as amended by Section 1.2 of this act, is
4 amended by adding a new subsection to read:

5 "(e1) If any provisional ballot cast under this section fails to contain the signature of the
6 registered voter casting a ballot on the affidavit, the county board shall notify the voter of the
7 lack of signature on the provisional ballot no later than the close of business on the next business
8 day following review of the ballot and shall provide the voter an opportunity to cure the lack of
9 signature on the affidavit. The voter shall be notified by mail and by telephone or email, if the
10 telephone number or email address was provided by the voter. The notification of voters

23 the State Board would have jurisdiction or authority.
- 24 (2) Register as a lobbyist under Chapter 120C of the General Statutes.
- 25 (3) Make written or oral statements intended for general distribution or
26 dissemination to the public at large supporting or opposing the nomination or
27 election of one or more clearly identified candidates for public ~~office~~ office,
28 supporting any political party over another, or influencing voter turnout for a
29 particular political party.
- 30 (4) Make written or oral statements intended for general distribution or
31 dissemination to the public at large supporting or opposing the passage of one
32 or more clearly identified referendum or ballot issue proposals.
- 33 (5) Solicit contributions for a candidate, political committee, or referendum
34 committee.
- 35 (6) Serve as a member of any other State board, as defined in G.S. 138A-3.
- 36 (7) Make written or oral statements intended for general distribution or
37 dissemination to the public at large encouraging or promoting voter turnout in
38 any election."

39 **SECTION 3.1.(b)** G.S. 163-30 is amended by adding a new subsection to read:

40 "(g) No person while serving on a county board shall do any of the following:

- 41 (1) Make written or oral statements intended for general distribution or
42 dissemination to the public at large supporting or opposing the nomination or
43 election of one or more clearly identified candidates for public office,
44 supporting any political party over another, or influencing voter turnout for a
45 particular political party.
- 46 (2) Make written or oral statements intended for general distribution or
47 dissemination to the public at large supporting or opposing the passage of one
48 or more clearly identified referendum or ballot issue proposals.

11 resolution, for such assistance from the State Board and, provided further, that
12 the Board.

16 under this provision to enter into any litigation in assistance to counties, any

20 ~~of its authority under this section or, in the Attorney General's discretion, recommend that may~~

employ staff counsel or retain private counsel to provide legal services. Private
counsel may be retained for any of the following matters:

23 (1) Any matter in which litigation is contemplated or has been initiated.

24 (2) Any matter in which the State Board is assisting in litigation in accordance
25 with subsection (a) of this section.

26 (3) Any matter arising in connection with the State Board's actions under this
27 Chapter.

28 (4) Any matter arising in connection with the Executive Director's actions under
29 this Chapter.

30 (c) ~~If the Attorney General recommends employment~~ State Board determines retention
31 of private counsel, counsel is necessary, the State Board may employ counsel with the approval
32 ~~of the General Assembly.~~ use funds available to the State Board to retain private counsel under
33 this section. The State Board shall supervise and manage counsel retained under this section.

34 (d) G.S. 114-2.3 and G.S. 147-17 shall not apply to counsel employed or retained under

36 (e) All communications or documents made or used in connection with the provision of
37 legal services by counsel employed or retained under this section are not "public records" as
38 defined by G.S. 132-1 and shall not be open to public inspection, examination, or copying."

41 42 **VENUE FOR JUDICIAL REVIEW OF DECISIONS OF THE STATE BOARD OF** 43 **ELECTIONS**

44 **SECTION 3.3.(a)** G.S. 163-22(*l*) reads as rewritten:

45 "*l*) Notwithstanding any other provision of law, in order to obtain judicial review of any
46 decision of the State Board rendered in the performance of its duties or in the exercise of its
47 powers under this Chapter, the person seeking review must file a petition in either the Superior
48 Court of Wake County, County or the superior court of the county in which the person seeking
49 review resides."

50 **SECTION 3.3.(b)** This section is effective when it becomes law and applies to
51 actions filed on or after that date.

INCREASE COMPENSATION OF MEMBERS OF COUNTY BOARD OF ELECTIONS

SECTION 3.4.(a) G.S. 163-32 reads as rewritten:

"§ 163-32. Compensation of members of ~~county boards of elections~~ county boards.

In full compensation of their services, members of the county board ~~of elections~~ (including the ~~chairman~~ chair) shall be paid by the county ~~twenty-five dollars (\$25.00)~~ one hundred dollars (\$100.00) per meeting for the time they are actually engaged in the discharge of their duties, together with reimbursement of expenditures necessary and incidental to the discharge of their duties; provided that members are not entitled to be compensated for more than one meeting held in any one 24-hour period. In its discretion, the board of county commissioners of any county may pay the ~~chairman~~ chair and members of the county board ~~of elections~~ compensation in addition to the per meeting and expense allowance provided in this paragraph.

In all counties the county board ~~of elections~~ shall pay its clerk, assistant clerks, and other employees such compensation as it shall fix within budget appropriations. Counties which adopt full-time and permanent registration shall have authority to pay directors of elections whatever compensation they may fix within budget appropriations."

SECTION 3.4.(b) This section becomes effective July 1, 2027.

EXEMPT POSITIONS AT THE STATE BOARD OF ELECTIONS

SECTION 3.5.(a) Section 2E.3(a) of S.L. 2025-89 reads as rewritten:

"SECTION 2E.3.(a) There is appropriated from the General Fund to the State Board of Elections the sum of one million one hundred ninety-three thousand nine hundred seventy-nine dollars (\$1,193,979) in recurring funds for each fiscal year of the 2025-2027 fiscal biennium to provide funds for the following ~~seven new exempt~~ positions, including salaries, benefits, and operating costs:

- (1) Administrative Officer III.
- (2) Agency General Counsel II.
- (3) Agency HR Director II.
- (4) Assistant General Counsel II.
- (5) Internal Auditor.
- (6) Legislative Affairs Manager.
- (7) Public Information Manager."

SECTION 3.5.(b) G.S. 126-5(c1) is amended by adding the following new subdivisions to read:

"(43) The Executive Director of the State Board of Elections.

(44) Employees of the State Board of Elections, that the Executive Director of the State Board of Elections, at any time, in the Executive Director of the State Board of Elections' discretion, exempts from the application of this Chapter by means of a letter to the Director of the Office of State Human Resources designating these employees. The Executive Director of the State Board of Elections may exempt no more than seven employees under the authorization set forth in this subdivision. Any exemptions under this subdivision shall not affect, or be counted against, the number of exempt positions the Auditor may designate in accordance with subdivision (2) of subsection (d) of this section."

SECTION 3.5.(c) G.S. 126-5(c14) reads as rewritten:

"(c14) Notwithstanding any provision of this Chapter to the contrary, each Council of State ~~agency, agency and the Office of the State Controller, and the Executive Director of the State Board of Elections~~ Controller has the sole authority to set the salary of its exempt policymaking and exempt managerial positions within the minimum rates, and the maximum rates plus ten percent (10%), established by the State Human Resources Commission under G.S. 126-4(2)."

SECTION 3.5.(d) G.S. 126-5(d)(2) reads as rewritten:

"(2) Exempt Positions in Council of State Departments and Offices, the Office of the State Controller, and the State Board of Elections. – The Secretary of State, the Auditor, the Treasurer, the Attorney General, the Superintendent of Public Instruction, the Commissioner of Agriculture, the Commissioner of Insurance, the Labor Commissioner, and the State Controller, and the Executive Director of the State Board of Elections Controller may designate exempt positions. The number of exempt policymaking positions in each department headed by an elected department head listed in this subdivision is limited to 25 exempt policymaking positions or two percent (2%) of the total number of full-time positions in the department, whichever is greater. The number of exempt policymaking positions designated by the Superintendent of Public Instruction is limited to 70 exempt policymaking positions or two percent (2%) of the total number of full-time positions in the department, whichever is greater. The number of exempt managerial positions designated by the Superintendent of Public Instruction is limited to 70 exempt managerial positions or two percent (2%) of the total number of full-time positions in the department, whichever is greater. The total number of exempt positions, policymaking and managerial, designated by the Office of the State Controller is limited to 10. ~~The total number of exempt positions designated by the Executive Director of the State Board of Elections is limited to the following seven positions: Agency Human Relations Director II, Agency General Counsel II, Assistant General Counsel II, Public Information Manager, Legislative Affairs Manager, Internal Auditor, and Administrative Officer III.~~"

SECTION 3.5.(e) G.S. 126-5(d)(4) reads as rewritten:

"(4) Vacancies. – In the event of a vacancy in the Office of Governor, the office of a member of the Council of State, or the Office of the State Controller, or the Executive Director of the State Board of Elections, the person who succeeds to or is appointed or elected to fill the unexpired term shall make designations in a letter to the Director of the Office of State Human Resources, the Speaker of the House of Representatives, and the President of the Senate within 180 days after the oath of office is administered to that person."

PART IV. REVISIONS TO UNIFORM MILITARY AND OVERSEAS VOTERS ACT

SECTION 4.1. G.S. 163-258.2 reads as rewritten:

14 (2) "Dependent" means an individual recognized as a dependent by a uniformed
 15 service.

16 (3) "Military-overseas ballot" means any of the following:

17 a. A federal write-in absentee ballot described in the Uniformed and
 18 Overseas Citizens Absentee Voting Act, section 103, 42 U.S.C. §
 19 1973ff-2.

20 b. A ballot specifically prepared or distributed for use by a covered voter
 21 in accordance with this Article.

22 c. A ballot cast by a covered voter in accordance with this Article.

23 (4) "Overseas voter" means a United States citizen who is outside the United
 24 States.

25 (5) "State" means a state of the United States, the District of Columbia, Puerto
 26 Rico, the United States Virgin Islands, or any territory or insular possession
 27 subject to the jurisdiction of the United States.

28 (6) "Uniformed service" means any of the following:

29 a. Active and reserve components of the United States Army, Navy, Air
 30 Force, Marine Corps, Space Force, and Coast Guard.

31 b. The Merchant Marine, the commissioned corps of the Public Health
 32 Service, and the commissioned corps of the National Oceanic and
 33 Atmospheric Administration of the United States.

34 c. The National Guard and state militia units.

35 (7) "Uniformed-service voter" means an individual who is qualified to vote and
 36 is one of the following:

37 a. A member of the active or reserve components of the United States
 38 Army, Navy, Air Force, Marine Corps, Space Force, or Coast Guard
 39 who is on active duty.

40 b. A member of the Merchant Marine, the commissioned corps of the
 41 Public Health Service, or the commissioned corps of the National
 42 Oceanic and Atmospheric Administration of the United States.

43 c. A member of the National Guard or State militia unit who is on
 44 activated status.

45 d. A spouse or dependent of a member referred to in this subdivision.

46 (8) "United States," used in the territorial sense, means the several states, the
 47 District of Columbia, Puerto Rico, the United States Virgin Islands, and any
 48 territory or insular possession subject to the jurisdiction of the United States."

49 **SECTION 4.2.** G.S. 163-258.5 reads as rewritten:

50 **"§ 163-258.5. Overseas voter's registration address.**

1 In registering to vote, an overseas voter who is eligible to vote in this State shall use and shall
2 be assigned to the precinct of the address of the last place of residence of the voter in this State,

4 ~~residence in this State of the parent or legal guardian of the voter.~~ State. If that address is no
5 longer a recognized residential address, the voter shall be assigned an address for voting

19 than 12:01 A.M., at the place where the voter completes the ballot, on the date of the election.

20 (b) Overseas voters shall submit the military-overseas ballot with either an affidavit as
21 described in G.S. 163-166.16(d)(1), (d)(2), (d)(3), if the overseas voter does not have a copy of
22 photographic identification, or a copy of one of the following forms of photographic
23 identification:

- 24 (1) An unexpired military identification card issued by the United States
25 government.
- 26 (2) An unexpired United States passport card or the photo page of an unexpired
27 United States passport.
- 28 (3) An unexpired North Carolina drivers license.
- 29 (4) An unexpired special identification card for nonoperators issued under
30 G.S. 20-37.7 or other form of nontemporary identification issued by the
31 Division of Motor Vehicles of the Department of Transportation.
- 32 (5) An unexpired Veterans Identification Card issued by the United States
33 Department of Veterans Affairs for use at Veterans Administration medical
34 facilities.
- 35 (6) An unexpired tribal enrollment card issued by a State or federally recognized
36 tribe.
- 37 (7) An unexpired identification card issued by a department, agency, or entity of
38 the United States government or this State for a government program of public
39 assistance.

40 (c) The State Board shall provide the means for any photographic identification
41 electronically submitted in accordance with this section to be submitted in a secure manner."

42 **SECTION 4.5.** Article 21A of Chapter 163 of the General Statutes is amended by

2 county board through any of the following methods:

- 3 (1) Mailing cure documentation to the appropriate county board.
- 4 (2) Transmitting cure documentation through the electronic transmission system
5 developed by the State Board.
- 6 (3) Transmitting cure documentation via email to the county board."

8 applies to covered voters registering to vote on or after that date. The remainder of this Part
9 becomes effective January 1, 2027, and applies to elections held on or after that date.

11 **INCREASE THRESHOLD FOR REPORTING CERTAIN CONTRIBUTIONS**

12 **SECTION 5.1.(a)** G.S. 163-278.10A reads as rewritten:

13 **"§ 163-278.10A. Threshold of ~~\$1,000~~ \$3,000 for financial reports for certain candidates.**

14 (a) Notwithstanding any other provision of this Chapter, a candidate for a county office,
15 municipal office, local school board office, soil and water conservation district board of
16 supervisors, or sanitary district board shall be exempted from the reports of contributions, loans,
17 and expenditures required in G.S. 163-278.9(a), 163-278.40B, 163-278.40C, 163-278.40D, and
18 163-278.40E if to further the candidate's campaign that ~~candidate~~ candidate complies with all of
19 the following:

- 20 (1) Does not receive more than ~~one thousand dollars (\$1,000)~~ three thousand
21 dollars (\$3,000) in contributions, and contributions.
- 22 (2) Does not receive more than ~~one thousand dollars (\$1,000)~~ three thousand
23 dollars (\$3,000) in loans, and loans.
- 24 (3) Does not spend more than ~~one thousand dollars (\$1,000)~~ three thousand
25 dollars (\$3,000).

26 To qualify for the exemption from those reports, the candidate's treasurer shall file a certification
27 that the candidate does not intend to receive in contributions or loans or expend more than ~~one~~
28 ~~thousand dollars (\$1,000)~~ three thousand dollars (\$3,000) to further the candidate's campaign.
29 The certification shall be filed with the Board at the same time the candidate files the candidate's
30 Organizational Report as required in G.S. 163-278.7, G.S. 163-278.9, and G.S. 163-278.40A. If
31 the candidate's campaign is being conducted by a political committee which is handling all
32 contributions, loans, and expenditures for the candidate's campaign, the treasurer of the political
33 committee shall file a certification of intent to stay within the threshold amount. If the intent to
34 stay within the threshold changes, or if the ~~one thousand dollar (\$1,000)~~ three thousand dollar
35 (\$3,000) threshold is exceeded, the treasurer shall immediately notify the Board and shall be
36 responsible for filing all reports required in G.S. 163-278.9 and 163-278.40B, 163-278.40C,
37 163-278.40D, and 163-278.40E; provided that any contribution, loan, or expenditure which
38 would have been required to be reported on an earlier report but for this section shall be included
39 on the next report required after the intent changes or the threshold is exceeded.

41 **SECTION 5.1.(b)** G.S. 163-278.12 reads as rewritten:

42 **"§ 163-278.12. Special reporting of contributions and independent expenditures.**

43 (a) Subject to G.S. 163-278.39 and G.S. 163-278.14, individuals and other entities not
44 otherwise prohibited from doing so may make independent expenditures. In the event an
45 individual, person, or other entity making independent expenditures but not otherwise required
46 to report them makes independent expenditures in excess of one ~~hundred dollars (\$100.00),~~

48 independent expenditure with the appropriate board of elections in the manner prescribed by the
49 State ~~Board of Elections.~~ Board.

5 (c) In assuring compliance with subsections (a) and (b) of this section, the State Board of
 6 ~~Elections~~ shall require the identification of each person or entity making a donation of more than
 7 one ~~hundred dollars (\$100.00)~~ thousand dollars (\$1,000) to the entity filing the report if the
 8 donation was made to further the reported independent expenditure or contribution. If the donor
 9 is an individual, the statement shall also contain the principal occupation of the donor. The
 10 "principal occupation of the donor" shall mean the same as the "principal occupation of the
 11 contributor" in G.S. 163-278.11.

12 (d) Contributions or independent expenditures required to be reported under this section
 13 shall be reported within 30 days after they exceed one ~~hundred dollars (\$100.00)~~ thousand dollars
 14 (\$1,000) or 10 days before an election the contributions or independent expenditures affect,
 15 whichever occurs earlier.

16 ...

17 (h) Statements filed under this section in connection with an independent expenditure or
 18 contribution regarding a referendum shall include a certification by the filer that it has not
 19 knowingly or willfully accepted funds aggregating in excess of ten thousand dollars (\$10,000)
 20 from one or more foreign nationals within the four-year period immediately preceding the date
 21 on which the expenditure or contribution was made and that it will not do so through the date of
 22 the election in which the referendum will appear on the ballot."

23 **SECTION 5.1.(c)** This section becomes effective January 1, 2027.

 25 **48-HOUR REPORT REQUIREMENTS**

26 **SECTION 5.2.(a)** G.S. 163-278.9 reads as rewritten:

27 **"§ 163-278.9. Statements filed with Board.**

28 (a) Except as provided in G.S. 163-278.10A, the treasurer of each candidate and of each
 29 political committee shall file with the Board under certification of the treasurer as true and correct
 30 to the best of the knowledge of that officer the following reports:

32 (2) 48-Hour Report. – A political committee, political party or affiliated party
 33 committee that receives a contribution or transfer of funds shall disclose
 34 within 48 hours of receipt a contribution or transfer of ~~one two~~ two thousand

 36 period covered by the last report due before that election. The disclosure shall
 37 be by report to the ~~State Board~~ identifying the source and amount of the funds.

 40 increase the dollar amount of the reporting threshold effective each election
 41 cycle beginning on the period from January 1 of an odd-numbered year

 44 revised threshold in October of the even-numbered year, publish the revised
 45 threshold in the North Carolina Register, and notify the Revisor of Statutes

48 (a1) Subdivision (a)(2) of this section shall not apply to any candidate campaign
 49 committee, as defined by G.S. 163-278.38Z, in a primary election in which the candidate is
 50 unopposed on that ballot.

6 referendum. The disclosure shall be by report to the ~~State Board of Elections~~

41 **SECTION 5.3.(b)** G.S. 163-278.9A, as amended by Section 5.2 of this act, reads as
42 rewritten:

43 "**§ 163-278.9A. Statements filed by referendum committees.**

44 (a) The treasurer of each referendum committee shall file under verification with the
45 Board the following reports:

- 46 ...
47 (1a) Organizational Funding Certification. – The treasurer shall file a signed
48 statement with the Board no later than the tenth day following the organization
49 of a referendum committee affirming that no preliminary activity was funded
50 by one or more foreign nationals and that the committee has not and will not
51 knowingly or willfully receive, solicit, or accept contributions, directly or

1 indirectly, from one or more foreign nationals. Preliminary activity includes
2 conducting a poll, public opinion survey, or focus group; drafting referendum
3 language; telephone calls; and travel.

6 days prior to the date the report is due and shall list all contributions received and expenditures
7 made which have not been previously reported.

8 (c) Any report disclosing contributions required by this section shall include an
9 affirmation by the treasurer that the donor associated with each contribution is not a foreign
10 national and the donor has not knowingly or willfully received, solicited, or accepted
11 contributions, directly or indirectly, from one or more foreign nationals aggregating in excess of
12 ten thousand dollars (\$10,000) within the four-year period immediately preceding the date of the
13 contribution.

14 (d) For purposes of this section, "directly or indirectly" means acting either alone or
15 jointly with, through, or on behalf of any other referendum committee, political committee,
16 organization, person, individual, or other entity."

17 **SECTION 5.3.(c)** G.S. 163-278.15(a) reads as rewritten:

18 "(a) No candidate, political committee, political party, affiliated party committee, or
19 treasurer shall solicit or accept any contribution made by any of the following:

20 (1) A corporation, foreign or domestic, regardless of whether such corporation
21 does business in the State of North Carolina, or made by any Carolina.

22 (2) Any business entity, labor union, professional association, or insurance
23 company.

24 (3) Any foreign national.

25 (a1) This section does not apply with regard to entities permitted to make contributions by
26 G.S. 163-278.19(h)."

27 **SECTION 5.3.(d)** G.S. 163-278.19 reads as rewritten:

28 "**§ 163-278.19. Violations by foreign nationals, corporations, business entities, labor unions,**
29 **professional associations and insurance companies.**

30 (a) Except as provided in subsections (c), (d), (f), (g), (h), and (i) of this section it shall
31 be unlawful for any foreign national, corporation, business entity, labor union, professional
32 association or insurance company directly or indirectly do any of the following:

33 (1) To make any contribution to a candidate or political committee.

34 (2) To pay or use or offer, consent or agree to pay or use any of its money or
35 property for any contribution to a candidate or political committee.

36 (3) To compensate, reimburse, or indemnify any person or individual for money
37 or property so used or for any contribution or expenditure so made.

38 (a1) It shall also be unlawful for any officer, director, stockholder, attorney, agent or
39 member of any foreign national, corporation, business entity, labor union, professional
40 association or insurance company to aid, abet, advise or consent to any such contribution, or for
41 any person or individual to solicit or knowingly receive any such contribution. Supporting or
42 opposing the election of clearly identified candidates includes supporting or opposing the
43 candidates of a clearly identified political party. Any officer, director, stockholder, attorney,
44 agent or member of any foreign national, corporation, business entity, labor union, professional
45 association or insurance company aiding or abetting in any contribution made in violation of this
46 section shall be guilty of a Class 2 misdemeanor, and shall in addition be liable to such foreign
47 national, corporation, business entity, labor union, professional association or insurance company
48 for the amount of such contribution and the same may be recovered ~~of him~~ upon suit by any
49 stockholder or member ~~thereof~~ thereof against the aiding or abetting officer, director,
50 stockholder, attorney, agent, or member.

1 (b) A transfer of funds shall be deemed to have been a contribution made indirectly if it
2 is made to any committee, affiliated party committee, or political party account, whether inside
3 or outside this State, with the intent or purpose of being exchanged in whole or in part for any
4 other funds to be contributed or expended in an election for North Carolina office or to offset any
5 other funds contributed or expended in an election for North Carolina office.

6 (c) Proceeds of loans made in the ordinary course of business by financial institutions
7 may be used for contributions made in compliance with this Subchapter. Financial institutions
8 may also grant revolving credit to political committees and referendum committees in the
9 ordinary course of business.

10 (d) It shall, however, be lawful for any corporation, business entity, labor union,
11 professional association or insurance company to ~~communicate~~ do any of the following:

12 (1) ~~Communicate~~ with its employees, stockholders or members and their families
13 ~~on any subject; to conduct~~ subject.

14 (2) Conduct nonpartisan registration and get-out-the-vote campaigns aimed at
15 their employees, stockholders, or members and their ~~families; or for~~ families.

16 (3) For officials and employees of any corporation, insurance company or
17 business entity or the officials and members of any labor union or professional
18 association to establish, administer, contribute to, and to receive and solicit
19 contributions to a separate segregated fund to be utilized for political
20 purposes, and those individuals shall be deemed to become and be a political
21 committee as that term is defined in G.S. 163-278.6(74) or a referendum
22 committee as defined in G.S. 163-278.6(84); provided, however, that it shall
23 be unlawful for any such fund to make a contribution or expenditure by
24 utilizing contributions secured by physical force, job discrimination, financial
25 reprisals or the threat of force, job discrimination or financial reprisals, or by
26 dues, fees, or other moneys required as a condition of membership or
27 employment or as a requirement with respect to any terms or conditions of
28 employment, including, without limitation, hiring, firing, transferring,
29 promoting, demoting, or granting seniority or employment-related benefits of
30 any kind, or by moneys obtained in any commercial transaction whatsoever.

31 (e) A violation of this section is a Class 2 misdemeanor. In addition, the acceptance of
32 any contribution, reimbursement, or indemnification under subsection (a) shall be a Class 2
33 misdemeanor.

34 (f) Whenever a candidate or treasurer is an officer, director, stockholder, attorney, agent,
35 or employee of any corporation, business entity, labor union, professional association or
36 insurance company, and by virtue of ~~his~~ the position therewith uses office space and
37 communication facilities of the corporation, business entity, labor union, professional association
38 or insurance company in the normal and usual scope of ~~his~~ employment, the fact that the
39 candidate or treasurer receives telephone calls, mail, or visits in such office which relates to
40 activities prohibited by this Article shall not be considered a violation under this section.

41 (g) Notwithstanding the prohibitions specified in this Article and Article 22 of this
42 Chapter, a political committee organized under provisions of this Article shall be entitled to
43 receive and the corporation, business entity, labor union, professional association, or insurance
44 company designated on the political committee's organizational report as the parent entity of the
45 employees or members who organized the political committee is authorized to give reasonable
46 administrative support that shall include record keeping, computer services, billings, mailings to
47 members of the political committee, membership development, fund-raising activities, office
48 supplies, office space, and such other support as is reasonably necessary for the administration
49 of the political committee.

50 The approximate cost of any reasonable administrative support shall be submitted to the
51 political committee, in writing, and the political committee shall include that cost on the report

1 required by G.S. 163-278.9(a)(4). Also included in the report shall be the approximate allocable
2 portion of the compensation of any officer or employee of the corporation, business entity, labor
3 union, professional association, or insurance company who has devoted more than thirty-five
4 percent (35%) of ~~his~~ that employee's time during normal business hours of the corporation,
5 business entity, labor union, professional association, or insurance company during the period
6 covered by the required report. The approximate cost submitted by the parent corporation,
7 business entity, labor union, professional association, or insurance company shall be entered on
8 the political committee's report as the final entry on its list of "contributions" and a copy of the
9 written approximate cost received by it shall be attached.

10 The reasonable administrative support given by a corporation, business entity, labor union,
11 professional association, or insurance company shall be designated on the books of the
12 corporation, business entity, labor union, professional association, or insurance company as such
13 and may not be treated by it as a business deduction for State income tax purposes.

14 (h) This section does not prohibit a contribution by ~~an [a]~~ a person or entity ~~that~~ that
15 meets all of the following criteria:

16 (1) Has as an express purpose promoting social, educational, or political ideas and
17 not to generate business ~~income;~~ income.

18 (2) Does not have shareholders or other persons which have an economic interest
19 in its assets and ~~earnings;~~ and earnings.

20 (3) Was not established by a business corporation, by an insurance company, by
21 a business entity, including, but not limited to, those chartered under Chapter
22 55, Chapter 55A, Chapter 55B, or Chapter 58 of the General Statutes, by a
23 professional association, or by a labor union and does not receive substantial
24 revenue from such entities. Substantial revenue is rebuttably presumed to be
25 more than ten percent (10%) of total revenues in a calendar year.

26 (4) Is not a foreign national.

27 (i) If a political committee has as its only purpose accepting contributions and making
28 expenditures to influence elections, and that political committee incorporates as a nonprofit
29 corporation to shield its participants from liability created outside this Subchapter, that political
30 committee is not considered to be a corporation for purposes of this section. Incorporation of a
31 political committee does not relieve any individual, person, or other entity of any liability, duty,
32 or obligation created pursuant to any provision of this Subchapter. To obtain the benefits of this
33 subsection, an incorporating political committee must state exactly the following language as the
34 only purpose for which the corporation can be organized: "to accept contributions and make
35 expenditures to influence elections as a political committee pursuant to G.S. 163-278.6(74)
36 only." No political committee shall do business as a political committee after incorporation unless
37 it has been certified by the State Board as being in compliance with this subsection.

38 (j) For purposes of this section, "directly or indirectly" means acting either alone or
39 jointly with, through, or on behalf of any other referendum committee, political committee,
40 organization, person, individual, or other entity."

41 **SECTION 5.3.(e)** G.S. 163-278.19B(a) reads as rewritten:

42 "(a) Notwithstanding the provisions of ~~G.S. 163-278.19,~~ G.S. 163-278.19 and except for
43 a foreign national, a person prohibited by that section from making a contribution may donate to
44 political parties, and affiliated party committees and political parties and affiliated party
45 committees may accept from such a person, money and other things of value donated to a political
46 party headquarters building fund. A foreign national shall not make any contribution or donation
47 to a political party or affiliated party committee."

48 **SECTION 5.3.(f)** Article 22A of Chapter 163 of the General Statutes is amended by
49 adding a new section to read:

50 **"§ 163-278.19C. Contributions by foreign nationals.**

1 (a) A foreign national shall not direct, dictate, control, or directly or indirectly participate
2 in the decision-making process of any individual's, person's, or referendum committee's activities
3 to influence a referendum, including the making of contributions or independent expenditures. A
4 foreign national shall not coordinate with any individual, person, or referendum committee to
5 influence a referendum.

6 (b) A foreign national may not solicit, directly or indirectly, the making of a contribution,
7 expenditure, or other monetary or in-kind donation by another individual or person to influence
8 a referendum.

9 (c) A referendum committee shall not knowingly receive, solicit, or accept any
10 contribution from a foreign national, whether directly or indirectly.

11 (d) Upon a referendum committee receiving a contribution, the treasurer of such
12 committee shall obtain from the donor an affirmation that the donor is not a foreign national and
13 the donor has not knowingly or willfully accepted funds aggregating in excess of ten thousand
14 dollars (\$10,000) from one or more foreign national within the four-year period immediately
15 preceding the date the contribution is made. The treasurer of a referendum committee shall
16 include records of such donor affirmations in the detailed account records required by
17 G.S. 163-278.8.

18 (e) Any investigation and enforcement proceeding for alleged violations of this section
19 shall strictly comply with the confidentiality procedures and requirements laid out in this
20 Chapter, including, but not limited to, G.S. 163-278.22 and G.S. 163-278.27.

21 (f) Nothing in this section shall create or eliminate any donor disclosure rights or duties
22 except as provided in this Chapter.

23 (g) Any individual or person who makes an intentional disclosure of confidential
24 materials or information related to any investigation or enforcement action under this section
25 when such disclosure is not authorized by this Chapter shall be guilty of a Class 2 misdemeanor.
26 The statute of limitations, as stated in G.S. 15-1, for a violation of this subsection shall run from
27 the date that the unauthorized disclosure first occurred.

28 (h) For purposes of this section, "directly or indirectly" means acting either alone or
29 jointly with, through, or on behalf of any other referendum committee, political committee,
30 organization, person, individual, or other entity."

31 **SECTION 5.3.(g)** G.S. 163-278.19A reads as rewritten:

32 **"§ 163-278.19A. Contributions allowed.**

33 ~~Notwithstanding any other provision of this Chapter, Except as provided in~~
34 G.S. 163-278.19C, it is lawful for any person as defined in G.S. 163-278.6(72) to contribute to a
35 referendum committee."

36 **SECTION 5.3.(h)** G.S. 163-278.27(a) reads as rewritten:

37 "(a) Any individual, candidate, political committee, referendum committee, treasurer,
38 person or media who intentionally violates the applicable provisions of G.S. 163-278.7,
39 163-278.8, 163-278.9, 163-278.10, 163-278.11, 163-278.12, 163-278.13, 163-278.13B,
40 163-278.14, 163-278.16, 163-278.16B, 163-278.17, 163-278.18, 163-278.19, 163-278.19C,
41 163-278.20, 163-278.39, 163-278.40A, 163-278.40B, 163-278.40C, 163-278.40D, 163-278.40E,
42 or 163-278.40J is guilty of a Class 2 misdemeanor. The statute of limitations as stated in
43 G.S. 15-1 shall run from the day the last report is due to be filed with the appropriate board of
44 elections for the election cycle for which the violation occurred."

45 **SECTION 5.3.(i)** Subsection (f) of this section becomes effective December 1, 2026,
46 and applies to offenses committed on or after that date. The remainder of this section becomes
47 effective January 1, 2027.

49 **EXEMPT POLITICAL PARTY COMMITTEES FROM CAMPAIGN SALES** 50 **REPORTING REQUIREMENTS**

51 **SECTION 5.4.(a)** G.S. 163-278.8A reads as rewritten:

1 **"§ 163-278.8A. Campaign sales by political party executive ~~committees~~committees, and**
 2 **affiliated party committees, and other political party committees.**

3 (a) Exempt Purchase Price Not Treated as "Contribution." – Notwithstanding the
 4 provisions of G.S. 163-278.6(13), the purchase price of goods or services sold by a political party
 5 executive ~~committee or affiliated party committee~~ committee, an affiliated party committee, or
 6 other political party committees as provided in subsection (b) of this section shall not be treated
 7 as a "contribution" for purposes of account-keeping under G.S. 163-278.8, for purposes of the
 8 reporting of contributions under G.S. 163-278.11, or for the purpose of the limit on contributions
 9 under G.S. 163-278.13. The treasurer is not required to obtain, maintain, or report the name or
 10 other identifying information of the purchaser of the goods or services, as long as the
 11 requirements of subsection (b) of this section are satisfied. However, the proceeds from the sales
 12 of those goods and services shall be treated as contributions for other purposes, and expenditures
 13 of those proceeds shall be reported as expenditures under this Article. For purposes of this
 14 section, "political party committees" includes, but is not limited to, men, women, college, teen,
 15 senior, young, African American, or Hispanic clubs or organizations.

16 (b) Exempt Purchase Price. – A purchase price for goods or services sold by a political
 17 party executive ~~committee or affiliated party committee~~ committee, an affiliated party
 18 committee, or other political party committees qualifies for the exemption provided in subsection
 19 (a) of this section as long as the sale of the goods or services adheres to a plan that the treasurer
 20 has submitted to and that has been approved in writing by the Executive Director of the State
 21 Board of Elections. The Executive Director shall approve the treasurer's plan upon and only upon
 22 finding that all the following requirements are satisfied:

- 23 (1) That the price to be charged for the goods or services is reasonably close to
- 24 the market price for the goods or services.
- 25 (2) That the total amount to be raised from sales under all plans by the committee
- 26 does not exceed twenty thousand dollars (\$20,000) per election cycle.
- 27 (3) That no purchaser makes total purchases under the plan that exceed fifty
- 28 dollars (\$50.00).
- 29 (4) That the treasurer include in the report under G.S. 163-278.11, covering the
- 30 relevant time period, all of the following:
 - 31 a. A description of the plan.
 - 32 b. The amount raised from sales under the plan.
 - 33 c. The number of purchases made.
- 34 (5) That the treasurer shall include in the appropriate report under
- 35 G.S. 163-278.11 any in-kind contribution made to the political party in
- 36 providing the goods or services sold under the plan and that no in-kind
- 37 contribution accepted as part of the plan violates any provision of this Article.

38 The Executive Director may require a format for submission of a plan, but that format shall
 39 not place undue paperwork burdens upon the treasurer. As used in this subdivision, the term
 40 "election cycle" has the same meaning as in G.S. 163-278.6(32)."

41 **SECTION 5.4.(b)** This section becomes effective January 1, 2027.

42
 43 **INCREASE THRESHOLD FOR NONCASH REPORTING REQUIREMENTS**

44 **SECTION 5.5.(a)** G.S. 163-278.8(d) reads as rewritten:

45 "(d) All expenditures for nonmedia expenses (except postage) of more than ~~fifty dollars~~
 46 ~~(\$50.00)~~ one hundred dollars (\$100.00) shall be made by a verifiable form of payment. The State
 47 Board of Elections shall prescribe methods to ensure an audit trail for every expenditure so that
 48 the identity of each payee can be determined. All expenditures for nonmedia expenses of ~~fifty~~
 49 ~~dollars (\$50.00)~~ one hundred dollars (\$100.00) or less may be made by check or by cash payment.
 50 All nonmedia expenditures of more than ~~fifty dollars (\$50.00)~~ one hundred dollars (\$100.00)
 51 shall be accounted for and reported individually and separately with a specific description to

1 provide a reasonable understanding of the expenditure, but expenditures of ~~fifty dollars (\$50.00)~~
2 one hundred dollars (\$100.00) or less may be accounted for and reported in an aggregated
3 amount, but in that case the treasurer shall account for and report that the treasurer made
4 expenditures of ~~fifty dollars (\$50.00)~~ one hundred dollars (\$100.00) or less each, the amounts,
5 dates, and the purposes for which made. In the case of a nonmedia expenditure required to be
6 accounted for individually and separately with a specific description to provide a reasonable
7 understanding of the expenditure by this subsection, if the expenditure was to an individual, the
8 report shall list the name and address of the individual."

9 **SECTION 5.5.(b)** G.S. 163-278.11(b) reads as rewritten:

10 "(b) Threshold for Reporting Identity of Contributor. – A treasurer shall not be required
11 to report the name, address, or principal occupation of any individual who contributes ~~fifty dollars~~
12 ~~(\$50.00)~~ one hundred dollars (\$100.00) or less to the treasurer's committee during an election as
13 defined in G.S. 163-278.13. The State Board of Elections shall provide on its reporting forms for
14 the reporting of contributions below that threshold. On those reporting forms, the State Board
15 may require date and amount of contributions below the threshold, but may treat differently for
16 reporting purposes contributions below the threshold that are made in different modes and in
17 different settings."

18 **SECTION 5.5.(c)** G.S. 163-278.14(b) reads as rewritten:

19 "(b) No entity shall make, and no candidate, committee or treasurer shall accept, any
20 monetary contribution in excess of ~~fifty dollars (\$50.00)~~ one hundred dollars (\$100.00) unless
21 such contribution is in the form of a check, draft, money order, credit card charge, debit, or other
22 noncash method that can be subject to written verification. No contribution in the form of check,
23 draft, money order, credit card charge, debits, or other noncash method may be made or accepted
24 unless it contains a specific designation of the intended contributee chosen by the contributor.
25 The State Board may prescribe guidelines as to the reporting and verification of any method of
26 contribution payment allowed under this Article. For contributions by money order, the State
27 Board of Elections shall prescribe methods to ensure an audit trail for every contribution so that
28 the identity of the contributor can be determined. For a contribution made by credit card, the
29 credit card account number of a contributor is not a public record."

30 **SECTION 5.5.(d)** This section becomes effective January 1, 2027, and applies to
31 monetary contributions and expenditures made, reported, or accepted on or after that date.
32

33 **PART VI. REQUIRE USE OF FEDERAL DECENNIAL CENSUS DATA WHEN** 34 **ESTABLISHING DISTRICT BOUNDARIES**

35 **SECTION 6.(a)** G.S. 153A-22 is amended by adding a new subsection to read:

36 "(h) In establishing district boundaries, the board of commissioners shall use data derived
37 from the most recent federal decennial census and shall not use any other population estimates."

38 **SECTION 6.(b)** G.S. 160A-23 is amended by adding a new subsection to read:

39 **"§ 160A-23. District map; reapportionment.**

40 (a) If the city is divided into electoral districts for the purpose of electing the members of
41 the council, the map or description required by G.S. 160A-22 shall also show the boundaries of
42 the several districts.

43 (b) The council shall have authority to revise electoral district boundaries from time to
44 time. If district boundaries are set out in the city charter and the charter does not provide a method
45 for revising them, the council may revise them only for the purpose of (i) accounting for territory
46 annexed to or excluded from the city, and (ii) correcting population imbalances among the
47 districts shown by a new federal decennial census or caused by exclusions or annexations. When
48 district boundaries have been established in conformity with the federal Constitution, the council
49 shall not be required to revise them again until a new federal decennial census ~~of population~~
50 is taken or territory is annexed to or excluded from the city, whichever event first occurs.

1 (c) In establishing district boundaries, the council ~~may~~shall use data derived from the
2 most recent federal decennial census and shall not ~~be required to~~ use any other population
3 estimates."

4 **SECTION 6.(c)** G.S. 115C-37(i) reads as rewritten:

5 "(i) The local board of education shall revise electoral district boundaries from time to
6 time as provided by this subsection. If district boundaries are set by local act or court order and
7 the act or order does not provide a method for revising them, the local board of education shall
8 revise them only for the purpose of (i) accounting for territory annexed to or excluded from the
9 school administrative unit, and (ii) correcting population imbalances among the districts shown
10 by a new federal decennial census or caused by exclusions or annexations. After the General
11 Assembly has ratified an act establishing district boundaries, the local board of education shall
12 not revise them again until a new federal decennial census of population is taken or territory is
13 annexed to or excluded from the school administrative unit, whichever event first occurs. After
14 the local board of education has revised district boundaries in conformity with this ~~act,~~
15 subsection, the local board of education shall not revise them again until a new federal decennial
16 census of population is taken or territory is annexed to or excluded from the school administrative
17 unit, whichever event occurs first, except that the board may make an earlier revision of district
18 boundaries it has drawn if it must do so to comply with a court order or to gain approval of a
19 district-revision plan by the U.S. Justice Department under Section 5 of the Voting Rights Act.
20 In establishing district boundaries, the local board of education shall use data derived from the
21 most recent federal ~~census.~~decennial census and shall not use any other population estimates."

22 **SECTION 6.(d)** This section is effective when it becomes law and applies to the
23 establishment of district boundaries by a county, city, or local board of education on or after that
24 date.
25

26 **PART VII. SIGNATURE VERIFICATION PILOT PROGRAM**

27 **SECTION 7.(a)** The State Board of Elections shall study and report on the
28 feasibility, costs, and technical considerations of using signature verification technology. The
29 State Board of Elections may seek feedback from other stakeholders, including the county boards
30 of elections, and the study shall evaluate all of the following:

- 31 (1) The use of signature verification software in other states for the purposes of
32 voter registration, absentee ballot signatures, and other uses in elections
33 administration. This may include information about error rates in other states
34 across potential vendors, any discontinuation of vendor contracts in other
35 states, and any cost-saving measures implemented by other states.
- 36 (2) The cost and logistics of implementing a signature verification component for
37 absentee ballot verification, including any training requirements, equipment
38 needs, or costs incurred by county boards of elections.
- 39 (3) Any foreseen challenges related to voter signature retention under the current
40 elections management infrastructure and possible technology solutions to
41 minimize error rates under a statewide signature verification program.

42 **SECTION 7.(b)** The State Board of Elections shall report its findings, including any
43 recommendations or proposed legislation, to the Joint Legislative Elections Oversight Committee
44 on or before May 1, 2027.
45

46 **PART VIII. TRAINING FOR COUNTY BOARDS OF ELECTIONS**

47 **SECTION 8.1.** The School of Government at the University of North Carolina at
48 Chapel Hill shall work jointly with the State Board of Elections to develop a uniform curriculum
49 to provide trainings for county directors of elections and employees of county boards of elections
50 on the election laws and procedures as provided for in Chapter 163 of the General Statutes.

1 **SECTION 8.2.** The State Board of Elections shall partner with local community
2 colleges to provide a location in which any training conducted by the State Board of Elections or
3 a county board of elections may be held.

5 **PART IX. EFFECTIVE DATE**

6 **SECTION 9.** Except as otherwise provided, this act is effective when it becomes
7 law.
