2 "the director of the regional social services department." and substituting the phrase "regional  
3 safety manager.";

5 and on page 2, line 25, by rewriting the line to read:

6 "a. Extensive child welfare history.";

8 and on page 2, line 50, through page 3, line 4 by rewriting the lines to read:

9 "(c) Information Sharing. – The assigned escalation specialist shall coordinate with the county  
10 department of social services to obtain access to the entirety of each case record for a high-risk  
11 home to address immediate safety of the juvenile. Upon request, the county department of social  
12 services shall provide any records in their possession related to the high-risk home in which the  
13 juvenile is placed, including the juvenile's case, and identified in the escalation notification form.  
14 Pursuant to G.S. 7B-302, the escalation specialist may also demand, in writing, records in  
15 possession of State or local law enforcement.";

17 and on page 13, lines 1-2, by rewriting the lines to read:

18 "disclosures required under this section and coordination with the local teams established under  
19 G.S. 7B-1406.5.";

21 and on page 13, lines 32-36 by rewriting the lines to read:

23 "**SECTION 15.** Subsection (a) of Section 1, subsection (b) of Section 2, Part VI,  
24 subsection (a) of Section 10, and subsection (a) of Section 11 of this act become effective October  
25 1, 2026. Subsection (b) of Section 1, Part III, subsection (b) of Section 10, and subsection (b) of  
26 Section 11 of this act become effective July 1, 2026. Part XIII of this act becomes effective  
27 January 1, 2027. The remainder of this act is effective when it becomes law."
