A BILL TO BE ENTITLED

AN ACT TO IMPROVE THE INVOLUNTARY COMMITMENT PROCESS AND INCREASE PUBLIC SAFETY AND TO IMPLEMENT AN INPATIENT CAPACITY RESTORATION PROGRAM.

Whereas, the House Select Committee on Involuntary Commitment and Public Safety met six times during the 2025 to 2026 biennium, conducted meaningful work and engaged in productive discussion; and

Whereas, the House Select Committee on Involuntary Commitment and Public Safety identified several areas needing further study and has made recommendations; Now, therefore, The General Assembly of North Carolina enacts:

IMPROVE DATA COLLECTION AND FURTHER STUDY

SECTION 1.(a) The North Carolina Collaboratory (Collaboratory) shall study relevant statutes, judicial and clinical practices, and available technological resources to identify areas for systemic improvement in the involuntary commitment (IVC) process in the State. This study shall identify existing gaps in the State's current IVC process and shall provide specific recommendations to address or eliminate those gaps and ensure that individuals subject to involuntary commitment receive timely, data-driven, and accessible support. No later than December 1, 2026, the Collaboratory shall submit a progress report on the study, and no later than March 1, 2027, the Collaboratory shall submit a final report on the study, to the Joint Legislative Committee on Health and Human Services on the results of the study, which shall include, at a minimum, all of the following:

- (1) A comprehensive evaluation of the legal and operational frameworks governing involuntary commitment in the State to provide formal recommendations for systemic improvement. This evaluation shall focus on the following:
 - a. Ensuring that judicial officers receive timely clinical data from examiners to make informed, legally sound decisions regarding an individual's safety and treatment needs.
 - b. Parameters for training judges and magistrates on community-based services, such as Treatment Accountability for Safer Communities (TASC), "Community Treatment" teams, and Forensic Assertive Community Treatment (FACT) teams, to bolster treatment compliance and reduce recidivism.

- 1 c. Collaborating with the University of North Carolina School of
2 Government to develop proposed clinical workflows, transport
3 guidance, and bench cards that ensure successful referrals across all
4 agencies.
5 d. The update of electronic examination forms, affidavits, and petitions
6 to capture consistent, high-quality data statewide.
7 e. Strategies to increase data sharing between DHHS and the eCourts
8 system regarding IVC exams and court proceedings, including the
9 feasibility of a public-facing dashboard and necessary State statutory
10 changes.
11 f. The feasibility and potential benefits of granting law enforcement
12 access to IVC court records for the purpose of better informing law
13 enforcement procedures and operations.
14 (2) Any additional information deemed relevant by the Collaboratory to ensure
15 high-quality data collection and data-driven decision making across the
16 involuntary commitment system.

17 **SECTION 1.(b)** This section is effective when it becomes law.
18

19 **PILOT PROGRAM TO USE TELEHEALTH IN JAILS TO COMPLETE IVC FIRST** 20 **EXAMINATION**

21 **SECTION 2.(a)** The North Carolina Sheriffs' Association (Sheriffs' Association)
22 shall create a proposal for the implementation of a pilot program to utilize telehealth services to
23 conduct first examinations for individuals in custody of county jails. The proposal shall identify
24 jails willing to participate in the program and determine any State funding needed to operate the
25 program.

26 **SECTION 2.(b)** No later than March 1, 2027, the Sheriffs' Association shall submit
27 the proposal required by subsection (a) of this section to the Joint Legislative Oversight
28 Committee on Justice and Public Safety and the Joint Legislative Oversight Committee on Health
29 and Human Services.
30

31 **PLAN TO UTILIZE MOBILE CRISIS UNITS TO COMPLETE IVC FIRST** 32 **EXAMINATIONS**

33 **SECTION 3.(a)** The Local Management Entities/Managed Care Organizations
34 (LME/MCOs) and the Department of Health and Human Services (DHHS) are directed to
35 develop a plan to use mobile crisis units to enhance the efficiency of the involuntary commitment
36 process. In developing this plan, the LME/MCOs and DHHS shall consult with relevant
37 stakeholders. The plan shall include at least all of the following:

- 38 (1) The development of a statewide coverage model that uses in-person clinicians
39 or on-call licensed clinicians in mobile crisis units to complete the first
40 examination for involuntary commitment.
41 (2) Recommendations to improve mobile crisis response.
42 (3) An analysis of the funding necessary to implement the plan, including costs
43 associated with training and technology.
44 (4) Any additional information that the LME/MCOs and DHHS deem relevant to
45 improving mobile crisis units.

46 **SECTION 3.(b)** No later than October 1, 2026, the LME/MCOs and DHHS shall
47 submit a report on the plan as required in subsection (a) of this section to the Joint Legislative
48 Oversight Committee on Health and Human Services and the Fiscal Research Division.
49

50 **INCREASED TRAINING FOR INVOLUNTARY COMMITMENT EXAMINERS**

1 **SECTION 4.(a)** The Department of Health and Human Services (DHHS) is directed
2 to evaluate the standardized training program for involuntary commitment examiners for
3 necessary improvements, and to incorporate additional training into the standardized training
4 program for providers who conduct first examinations of individuals in custody of county jails.

5 **SECTION 4.(b)** No later than December 1, 2026, DHHS shall submit a report on
6 the standardized training program as required in subsection (a) of this section to the Joint
7 Legislative Oversight Committee on Health and Human Services and the Fiscal Research
8 Division.

9 10 **PLAN TO ADDRESS STAFFING AND BED SHORTAGES IN STATE-OPERATED** 11 **FACILITIES**

12 **SECTION 5.(a)** The Department of Health and Human Services (DHHS) is directed
13 to develop a plan to address (i) the ongoing shortage of staffed and available behavioral health
14 beds in State-operated facilities for individuals in crisis, (ii) the staffing deficiencies that limit
15 the use of existing behavioral health bed capacity, (iii) potential use of non-State-operated entities
16 or facilities to provide staffing for or leasing to State-operated facilities, and (iv) contracting for
17 behavioral health beds or staffing as supplementary or alternative to State-operated or staffed
18 beds. In developing this plan, DHHS shall consult with interested parties. The plan shall include
19 at least all of the following:

- 20 (1) An evaluation of current staffing models, hiring and recruitment practices,
21 employee retention strategies, and the use of incentive pools.
- 22 (2) A review of staffing requirements required by State statute and Joint
23 Commission standards.
- 24 (3) Any grant opportunities and other funding mechanisms to support behavioral
25 health bed capacity.
- 26 (4) An assessment of opportunities to utilize nongovernmental facilities or
27 entities, whether nonprofit or for-profit.
- 28 (5) Any additional information, suggestion, or initiative, DHHS deems relevant
29 to address staffing shortages and the ongoing shortage of available behavioral
30 health beds.

31 **SECTION 5.(b)** No later than December 1, 2026, DHHS shall submit a report on
32 the plan as required in subsection (a) of this section to the Joint Legislative Oversight Committee
33 on Health and Human Services and the Fiscal Research Division.

34 35 **STUDY LACK OF USE OF OUTPATIENT COMMITMENT**

36 **SECTION 6.(a)** The North Carolina Collaboratory (Collaboratory) shall conduct a
37 study on how outpatient commitment may be more effectively used and implemented in the State.
38 In developing this study, the Collaboratory shall consult with relevant stakeholders. The study
39 shall include at least all of the following:

- 40 (1) A review of State statutes governing outpatient commitment and the
41 identification of any statutory revisions needed to align the State with best
42 practices in other states.
- 43 (2) An examination of barriers that limit the use or effectiveness of outpatient
44 commitment, including the availability of outpatient commitment services
45 statewide.
- 46 (3) An assessment of mechanisms currently available to track adherence and
47 monitor compliance, along with proposed methods to strengthen and enhance
48 tracking and monitoring processes.
- 49 (4) Any additional issues the Collaboratory determines to be relevant to
50 improving the use and effectiveness of outpatient commitment.

1 **SECTION 6.(b)** No later than December 1, 2026, the Collaboratory shall submit a
2 progress report on the study as required in subsection (a) of this section to the Joint Legislative
3 Oversight Committee on Health and Human Services. No later than March 1, 2027, the
4 Collaboratory shall submit a final report on the study as required in subsection (a) of this section
5 to the Joint Legislative Oversight Committee on Health and Human Services.

6
7 **BEHAVIORAL HEALTH STATEWIDE CENTRAL AVAILABILITY NAVIGATOR**
8 **UPDATES (BH SCAN)**

9 **SECTION 6.5.(a)** The Department of Health and Human Services (DHHS), in
10 consultation with the NC Healthcare Association and the North Carolina Sheriffs' Association
11 (Sheriffs' Association), is directed to study the practicality of granting law enforcement access to
12 BH SCAN. DHHS shall report to the Joint Legislative Oversight Committee on Health and
13 Human Services when the study is complete.

14 **SECTION 6.5.(b)** DHHS is directed to study the practicality of development and
15 implementation of real-time data availability within BH SCAN.

16 **SECTION 6.5.(c)** DHHS shall study the development of a functionality within BH
17 SCAN that would allow authorized users to reserve an available behavioral health bed in real
18 time.

19 **SECTION 6.5.(d)** No later than March 1, 2027, DHHS shall submit a report on the
20 study as required in this section to the Joint Legislative Oversight Committee on Health and
21 Human Services.

22
23 **STUDY LEGAL STANDARDS FOR INVOLUNTARY COMMITMENT AND**
24 **INCAPACITY TO PROCEED**

25 **SECTION 7.(a)** The North Carolina Collaboratory (Collaboratory) shall conduct a
26 comprehensive study of the differing legal standards governing involuntary commitment and
27 incapacity to proceed to identify statutory revisions that would enhance each system's
28 effectiveness and advance public safety for all individuals involved. In developing this study, the
29 Collaboratory shall consult with relevant stakeholders. This study shall include recommendations
30 for statutory changes to address inconsistent terminology in the governing statutes and clarify
31 procedures for the transition of individuals between systems.

32 **SECTION 7.(b)** No later than December 1, 2026, the Collaboratory shall submit a
33 progress report on the study as required in subsection (a) of this section to the Joint Legislative
34 Oversight Committee on Health and Human Services. No later than March 1, 2027, the
35 Collaboratory shall submit a final report on the study as required in subsection (a) of this section
36 to the Joint Legislative Oversight Committee on Health and Human Services.

37
38 **WORKING GROUP TO ADDRESS MENTAL HEALTH AND CRIMINAL JUSTICE**
39 **SYSTEMS OPERATING AS A "REVOLVING DOOR"**

40 **SECTION 8.(a)** The North Carolina Department of Health and Human Services
41 (DHHS) shall establish a working group composed of representatives from the Administrative
42 Office of the Courts (AOC), and other stakeholders, to examine the systemic factors contributing
43 to the prevalent "revolving door" pattern in which individuals cycle repeatedly through arrest,
44 detention, or involuntary commitment, only to be released back into the community without
45 sustained stabilization or support. The purpose of the working group is to identify gaps, evaluate
46 current practices, and recommend strategies to interrupt repeated crises and reduce avoidable
47 recidivism, in addition to what has previously been examined and reported pursuant to Section
48 6.1 of S.L. 2025-27.

49 **SECTION 8.(b)** Beginning on January 1, 2027, and quarterly thereafter, DHHS shall
50 report on the findings and recommendations of the working group to the Joint Legislative
51 Oversight Committee on Health and Human Services and the Fiscal Research Division.

1
2 **STUDY THE PROVISION OF MEDICAL AND BEHAVIORAL HEALTH CARE IN**
3 **JAILS**

4 **SECTION 9.(a)** The North Carolina Collaboratory (Collaboratory) shall study the
5 provision of medical and behavioral health care delivered in county jails in the State and make
6 recommendations to improve the health care provided to individuals in custody. The
7 Collaboratory shall consult with relevant stakeholders, including local partners, the Sheriffs'
8 Association, and the Department of Health and Human Services. The study shall include at least
9 all of the following:

- 10 (1) A review of intake screening procedures used in county jails for identifying
11 medical and behavioral health conditions.
12 (2) An examination of current health care provider arrangements, including
13 in-house services, contracted services, hybrid models, or other recommended
14 approaches for delivering care in county jails.
15 (3) An assessment of policies and practices for responding to behavioral health
16 crises within jail settings.
17 (4) An evaluation of existing staffing models for medical and behavioral health
18 services in county jails.
19 (5) The development of recommendations for potential expansion of the North
20 Carolina Safekeeper Program.
21 (6) Any other information deemed relevant by the Collaboratory to improve the
22 provision of medical and behavioral health care in jails.

23 **SECTION 9.(b)** No later than December 1, 2026, the Collaboratory shall submit a
24 progress report on the study as required in subsection (a) of this section to the Joint Legislative
25 Oversight Committee on Health and Human Services. No later than March 1, 2027, the
26 Collaboratory shall submit a final report on the study as required in subsection (a) of this section
27 to the Joint Legislative Oversight Committee on Health and Human Services.
28

29 **THE NORTH CAROLINA COLLABORATORY TO STUDY FEASIBILITY OF THE**
30 **CHANGE OF OPERATION OR ADMINISTRATION OF STATE-OPERATED**
31 **PSYCHIATRIC HOSPITALS**

32 **SECTION 10.(a)** The North Carolina Collaboratory (Collaboratory) is directed to
33 explore the feasibility of improving the provision of services at Broughton Hospital, Central
34 Regional Hospital, and Cherry Hospital (collectively, the Hospitals). The Collaboratory is
35 directed to study and offer recommendations about the following:

- 36 (1) The feasibility of transferring full operation of the Hospitals from DHHS to
37 another entity.
38 (2) The feasibility of transferring certain operations of the Hospitals from DHHS
39 to another entity.
40 (3) Any services that another entity could provide to DHHS to assist DHHS in the
41 provision of services at the Hospitals.
42 (4) Any other operational or administrative initiatives relating to the provision of
43 services at the Hospitals.
44 (5) Reviewing and updating any previous studies or recommendations that may
45 be relevant or informative.
46 (6) Any financial impact (savings or additional costs), any impact on patient
47 outcomes, and any improvement in staffing to result from the implementation
48 of the recommendations provided according to this section.

49 **SECTION 10.(b)** The Department of Health and Human Services shall cooperate
50 fully with the Collaboratory in providing any data or assistance necessary for the Collaboratory
51 to complete the research required by subsection (a) of this section.

1 **SECTION 10.(c)** The Collaboratory shall seek the assistance of the University of
 2 North Carolina Health Care System (UNC Health) in conducting the studies required by
 3 subsection (a) of this section. UNC Health shall offer any assistance requested by the
 4 Collaboratory and shall make recommendations for the Collaboratory to include in the
 5 Collaboratory's reports.

6 **SECTION 10.(d)** No later than December 1, 2026, the Collaboratory shall submit a
 7 progress report on the study as required in subsection (a) of this section to the Joint Legislative
 8 Oversight Committee on Health and Human Services. No later than March 1, 2027, the
 9 Collaboratory shall submit a final report on the study as required in subsection (a) of this section
 10 to the Joint Legislative Oversight Committee on Health and Human Services.

11
 12 **MODIFY OUTPATIENT COMMITMENT**

13 **SECTION 11.(a)** G.S. 122C-261(d) reads as rewritten:

14 "(d) If the affiant is a commitment examiner, who is filing a petition and affidavit for an
 15 involuntary commitment in a county that has not implemented an electronic filing system
 16 approved by the Director of the Administrative Office of the Courts, all of the following apply:

17 ...

18 (3) If the commitment examiner recommends outpatient commitment according
 19 to the criteria for outpatient commitment set forth in G.S. 122C-263(d)(1) and
 20 the clerk or magistrate finds probable cause to believe that the respondent
 21 meets the criteria for outpatient commitment, the clerk or magistrate shall
 22 issue an order that a hearing before a district court judge be held to determine
 23 whether the respondent will be involuntarily committed. The commitment
 24 examiner shall contact the LME/MCO that serves the county where the
 25 respondent resides or the LME/MCO that coordinated services for the
 26 respondent to inform the LME/MCO that the respondent has been scheduled
 27 for an appointment with an outpatient treatment ~~physician or center provider.~~
 28 The commitment examiner shall provide the respondent with written notice of
 29 any scheduled appointment and the name, address, and telephone number of
 30 the proposed outpatient treatment ~~physician or center provider.~~

31 "

32 **SECTION 11.(b)** G.S. 122C-263 reads as rewritten:

33 **"§ 122C-263. Duties of law enforcement officer; first examination.**

34 ...

35 (d) After the conclusion of the examination the commitment examiner shall make the
 36 following determinations:

37 (1) If the commitment examiner finds all of the following, the commitment
 38 examiner shall so show on the examination report and shall recommend
 39 outpatient commitment:

- 40 a. The respondent has a mental illness.
 41 b. The respondent is reasonably determined to be capable of surviving
 42 safely in the community with available supervision from family,
 43 friends, or others community, without posing a danger to others, when
 44 engaged in treatment for the respondent's mental illness.
 45 c. Based on the respondent's psychiatric history, the respondent is in need
 46 of treatment in order to prevent further disability or deterioration that
 47 would predictably result in dangerousness as defined by
 48 G.S. 122C-3(11).
 49 d. The respondent's current mental status or the nature of the respondent's
 50 illness limits or negates the respondent's ability to make an informed
 51 decision to seek voluntarily or comply with recommended treatment.

- 1 e. The respondent has a history of declining or nonadherence to
 2 prescribed treatment by a licensed treatment provider and one or more
 3 of the following, occurring within the relevant past:
 4 1. A demonstrated history of prior violent convictions.
 5 2. Repeated violations of a civil protective order.
 6 3. Repeated incarcerations.
 7 4. Repeated involuntary inpatient psychiatric hospitalizations.
 8 f. The respondent is scheduled to be discharged from an inpatient
 9 hospital setting or released from a county jail or state prison. An
 10 individual residing in a noninstitutional setting that meets all other
 11 criteria set forth in sub-subdivisions a. through e. of this subdivision
 12 may be subject to outpatient commitment within the court's discretion.

13 In addition, the commitment examiner shall show the name, address, and
 14 telephone number of the proposed outpatient treatment ~~physician or center~~
 15 provider in accordance with subsection (f) of this section. The person
 16 designated in the order to provide transportation shall return the respondent to
 17 the respondent's regular residence or, with the respondent's consent, to the
 18 home of a consenting individual located in the originating county, and the
 19 respondent shall be released from custody.

20 ...

21 (e) The findings of the commitment examiner and the facts on which they are based shall
 22 be in writing in all cases. The commitment examiner shall send a copy of the findings to the clerk
 23 of superior court by the most reliable and expeditious means. If it cannot be reasonably
 24 anticipated that the clerk will receive the copy within 48 hours of the time that it was signed, the
 25 physician or eligible psychologist shall also communicate his findings to the clerk by telephone.

26 (f) When outpatient commitment is recommended, the commitment examiner, if
 27 different from the proposed outpatient treatment ~~physician or center,~~ provider, shall contact the
 28 LME/MCO that serves the county where the respondent resides or the LME/MCO that
 29 coordinated services for the respondent to inform the LME/MCO that the respondent is being
 30 recommended for outpatient commitment. The commitment examiner shall give the respondent
 31 a written notice listing the name, address, and telephone number of the proposed outpatient
 32 treatment ~~physician or center,~~ provider.

33 (g) The commitment examiner, at the completion of the examination, shall provide the
 34 respondent with specific information regarding the next steps that will occur."

35 **SECTION 11.(c)** G.S. 122C-265 reads as rewritten:

36 **"§ 122C-265. Outpatient commitment; examination and treatment pending hearing.**

37 (a) If a respondent, who has been recommended for outpatient commitment by [a]
 38 commitment examiner different from the proposed outpatient treatment physician or center, fails
 39 to appear for examination by the proposed outpatient treatment physician or center at the
 40 designated time, the physician or center shall notify the clerk of superior court who shall issue
 41 an order to a law enforcement officer to take the respondent into custody and take him
 42 immediately to the outpatient treatment physician or center for evaluation. The custody order is
 43 valid throughout the State. The law-enforcement officer may wait during the examination and
 44 return the respondent to his home after the examination.

45 (b) The examining commitment examiner or the proposed outpatient treatment ~~physician~~
 46 ~~or center,~~ provider may prescribe to the respondent reasonable and appropriate medication and
 47 treatment that are consistent with accepted medical standards pending the district court hearing.

48 (c) In no event may a respondent released on a recommendation that he or she meets the
 49 outpatient commitment criteria be physically forced to take medication or forcibly detained for
 50 treatment pending a district court hearing.

1 (c1) The outpatient treatment provider shall examine the respondent and develop an initial
2 outpatient treatment plan. The plan shall include, at a minimum, the specific services to be
3 provided, including medications as indicated, the recommended frequency of participation in
4 services, the name of the provider who has agreed to provide the services, the arrangements made
5 for the initial contact with each service provider, and any other relevant information.

6 (d) If at any time pending the district court hearing the outpatient treatment ~~physician or~~
7 ~~center-provider~~ determines that the respondent does not meet the criteria of G.S. 122C-263(d)(1),
8 the physician shall release the respondent and notify the clerk of court and the proceedings shall
9 be terminated.

10 "

11 **SECTION 11.(d)** G.S. 122C-267 reads as rewritten:

12 **"§ 122C-267. Outpatient commitment; district court hearing.**

13 (a) A hearing shall be held in district court within 10 days of the day the respondent is
14 taken into custody pursuant to G.S. 122C-261(e). Upon its own motion or upon motion of the
15 proposed outpatient treatment physician or the respondent, the court may grant a continuance of
16 not more than five days.

17 (b) The respondent shall be present at the hearing. A subpoena may be issued to compel
18 the respondent's presence at a hearing. The petitioner and the proposed outpatient treatment
19 physician or his designee may be present and may provide testimony.

20 (c) Certified copies of reports and findings of commitment examiners and medical
21 records of previous and current treatment are admissible in evidence. The initial treatment plan
22 required by G.S. 122C-265(c1) shall be admitted into evidence and incorporated into the order.

23 (d) At the hearing to determine the necessity and appropriateness of outpatient
24 commitment, the respondent need not, but may, be represented by counsel. However, if the court
25 determines that the legal or factual issues raised are of such complexity that the assistance of
26 counsel is necessary for an adequate presentation of the merits or that the respondent is unable
27 to speak for himself, the court may continue the case for not more than five days and order the
28 appointment of counsel for an indigent respondent. Appointment of counsel shall be in
29 accordance with rules adopted by the Office of Indigent Defense Services.

30 (e) Hearings may be held at the area facility in which the respondent is being treated, if
31 it is located within the judge's district court district as defined in G.S. 7A-133, or in the judge's
32 chambers. A hearing may not be held in a regular courtroom, over objection of the respondent,
33 if in the discretion of a judge a more suitable place is available.

34 (f) The hearing shall be closed to the public unless the respondent requests otherwise.

35 (g) A copy of all documents admitted into evidence and a transcript of the proceedings
36 shall be furnished to the respondent on request by the clerk upon the direction of a district court
37 judge. If the client is indigent, the copies shall be provided at State expense.

38 (h) To support an outpatient commitment order, the court is required to find by clear,
39 cogent, and convincing evidence that the respondent meets the criteria specified in
40 G.S. 122C-263(d)(1). The court shall record the facts which support its findings and shall show
41 on the order the ~~center or physician~~ outpatient treatment provider who is responsible for the care
42 and treatment of the respondent as well as the LME/MCO, or an alternative as determined by the
43 Department, responsible for the management and supervision of the respondent's outpatient
44 commitment."

45 **SECTION 11.(e)** G.S. 122C-271 reads as rewritten:

46 **"§ 122C-271. Disposition.**

47 (a) If a commitment examiner has recommended outpatient commitment and the
48 respondent has been released pending the district court hearing, the court may make one of the
49 following dispositions:

50 (1) If the court finds by clear, cogent, and convincing evidence that the respondent
51 ~~has a mental illness; that the respondent is capable of surviving safely in the~~

1 community with available supervision from family, friends, or others; that
2 based on respondent's treatment history, the respondent is in need of treatment
3 in order to prevent further disability or deterioration that would predictably
4 result in dangerousness as defined in G.S. 122C-3(11); and that the
5 respondent's current mental status or the nature of the respondent's illness
6 limits or negates the respondent's ability to make an informed decision to seek

18 (2) If the court does not find that the respondent meets the criteria of commitment
19 set out in subdivision (1) of this subsection, the respondent shall be discharged
20 and the proposed outpatient ~~physician-center~~ treatment provider shall be so
21 notified.

22 (3) Before ordering any outpatient commitment under this subsection, the court
23 shall make findings of fact as to the availability of outpatient treatment from
24 an outpatient treatment ~~physician or center~~ provider that has agreed to accept
25 the respondent as a client of outpatient treatment ~~services.~~ services, and the
26 availability and consent to accept the respondent as a client by all providers
27 of the services listed in the initial treatment plan. The court shall show on the
28 order the outpatient treatment ~~physician or center~~ provider and the
29 LME/MCO, or an alternative as determined by the Department, that is to be
30 responsible for the management and supervision of the respondent's outpatient
31 ~~commitment.~~ commitment, and provide instructions regarding their duties for
32 such monitoring and supervision under G.S. 122C-273. If the designated
33 outpatient treatment ~~physician or center~~ provider will be ~~monitoring and~~
34 supervising the respondent's outpatient commitment working pursuant to a
35 contract for services with an LME/MCO, the court shall show on the order the
36 identity of the LME/MCO. The clerk of court shall send a copy of the
37 outpatient commitment order to the designated outpatient treatment ~~physician~~
38 ~~or center~~ provider and to the respondent client or the legally responsible
39 person. The clerk of court shall also send a copy of the order to that
40 LME/MCO. Copies of outpatient commitment orders sent by the clerk of court
41 to an outpatient treatment ~~center or physician~~ provider under this section,

43 expeditious means, within 48 hours of the hearing.

9 show. The initial treatment plan required by G.S. 122C-265(c1) shall be
10 prepared by staff at the 24-hour facility in cooperation with the outpatient
11 treatment providers who will serve the respondent. The initial treatment plan
12 shall be admitted into evidence and shall be incorporated into the court's order.
13 The order shall state that the respondent is required to cooperate and comply
14 with the treatment plan including any subsequent updates made to the plan by
15 the outpatient provider in consultation with the patient, family members or
16 other natural supports with client consent, and any other relevant treatment
17 providers. The order shall include instructions to the responsible outpatient
18 treatment provider and the LME/MCO, or an alternative as determined by the
19 Department, regarding their monitoring and supervision duties under

21 (2) If the court finds by clear, cogent, and convincing evidence that the respondent
22 has a mental illness and is dangerous to self, as defined in G.S. 122C-3(11)a.,
23 or others, as defined in G.S. 122C-3(11)b., it may order inpatient commitment
24 at a 24-hour facility described in G.S. 122C-252 for a period not in excess of
25 90 days. However, no respondent found to have both an intellectual disability
26 and a mental illness may be committed to a State, area, or private facility for
27 individuals with intellectual disabilities. An individual who has a mental
28 illness and is dangerous to self, as defined in G.S. 122C-3(11)a., or others, as
29 defined in G.S. 122C-3(11)b., may also be committed to a combination of
30 inpatient and outpatient commitment at both a 24-hour facility and an
31 outpatient treatment ~~physician or center provider~~ for a period not in excess of
32 ~~90 days-180 days, however the inpatient stay cannot exceed 90 days.~~ If the
33 commitment proceedings were initiated as the result of the respondent's being
34 charged with a violent crime, including a crime involving an assault with a
35 deadly weapon, and the respondent was found incapable of proceeding, the
36 commitment order shall so show. If the court orders inpatient commitment for
37 a respondent who is under an outpatient commitment order, the outpatient
38 commitment is terminated; and the clerk of the superior court of the county
39 where the district court hearing is held shall send a notice of the inpatient
40 commitment to the clerk of superior court where the outpatient commitment
41 was being supervised. The clerk of court shall send a copy of the inpatient
42 commitment order to the designated inpatient treatment physician or center

4 fact as to the availability of outpatient treatment from an outpatient treatment

6 of outpatient treatment services. The court shall also show on the order the
7 outpatient treatment ~~physician or center provider~~ who is to be responsible for
8 the care of the respondent and the LME/MCO, or an alternative as determined

23 on the order the identity of the LME/MCO, or an alternative as determined by

26 LME/MCO. Copies of outpatient commitment orders sent by the clerk of court
27 to an outpatient treatment ~~center or physician provider~~ pursuant to this

30 outpatient commitment will be supervised in a county other than the county
31 where the commitment originated, the court shall order venue for further court

34 in the county where the commitment originated shall transfer the file to the
35 clerk of superior court in the county where the outpatient commitment is to be

37 (c) If the respondent was found not guilty by reason of insanity and has been held in a
38 24-hour facility pending the court hearing held pursuant to G.S. 122C-268.1, the court may make
39 one of the following dispositions:

- 40 (1) If the court finds that the respondent has not proved by a preponderance of the
41 evidence that the respondent no longer has a mental illness or that the
42 respondent is no longer dangerous to others, it shall order inpatient treatment
43 at a 24-hour facility for a period not to exceed 90 days.

45 evidence that the respondent no longer has a mental illness or that the

24 ~~alternative as determined by the Department, responsible for the monitoring~~
25 ~~and supervising of the respondent's outpatient commitment~~ may request the
26 court to order the respondent taken into custody for the purpose of
27 examination. Upon receipt of this request, the clerk shall issue an order to a
28 law-enforcement officer to take the respondent into custody and to take him

7 respondent is committed as an inpatient, the outpatient commitment shall be
8 terminated and notice sent by the clerk of court in the county where the
9 respondent is committed as an inpatient to the clerk of court of the county
10 where the outpatient commitment is being supervised.

11 (b) If the respondent on outpatient commitment intends to move or moves to another
12 county within the State, the designated ~~outpatient treatment physician or center~~ LME/MCO shall
13 request that the clerk of court in the county where the outpatient commitment is being supervised
14 calendar a supplemental hearing.

15 (c) If the respondent moves to another state or to an unknown location, the designated
16 outpatient treatment ~~physician or center provider or the LME/MCO, or an alternative as~~
17 determined by the Department, shall notify the clerk of superior court of the county where the
18 outpatient commitment is supervised and the outpatient commitment shall be terminated.

19 (d) If the commitment order directs inpatient treatment, the physician attending the
20 respondent may administer to the respondent reasonable and appropriate medication and
21 treatment that are consistent with accepted medical standards. The attending physician shall
22 release or discharge the respondent in accordance with G.S. 122C-277."

23 **SECTION 11.(g)** G.S. 122C-274 reads as rewritten:

24 "**§ 122C-274. Supplemental hearings.**

25 (a) Upon receipt of a request for a supplemental hearing, the clerk shall calendar a hearing
26 to be held within 14 days and notify, at least 72 hours before the hearing, the petitioner, the
27 respondent, ~~his~~ the respondent's attorney, if any, and the designated outpatient treatment
28 ~~physician or center provider and LME/MCO~~. The respondent shall be notified at least 72 hours
29 before the hearing by personally serving on him an order to appear. Other persons shall be
30 notified as provided in G.S. 122C-264(c).

31 (b) The procedures for the hearing shall follow G.S. 122C-267.

32 (c) In supplemental hearings for alleged noncompliance, the court shall determine
33 whether the respondent has failed to comply and, if so, the causes for noncompliance. If the court

- 35 (1) Upon finding probable cause to believe that the respondent is mentally ill and

- 43 (3) Discharge the respondent from the order and dismiss the case.
- 44 (4) Issue an order for inpatient commitment upon finding by clear, cogent, and
45 convincing evidence that the respondent is mentally ill and dangerous to
46 himself, as defined in G.S. 122C-3(11)a., or others, as defined in
47 G.S. 122C-3(11)b. A finding of noncompliance with an outpatient
48 commitment order pursuant to this section shall create a rebuttable
49 presumption that the respondent is dangerous to himself, as defined in
50 G.S. 122C-3(11)a., or others, as defined in G.S. 122C-3(11)b.

1 (d) At the supplemental hearing for a respondent who has moved or intends to move to
2 another county, the court shall determine if the respondent meets the criteria for outpatient
3 commitment set out in G.S. 122C-263(d)(1). If the court determines that the respondent no longer
4 meets the criteria for outpatient commitment, it shall discharge the respondent from the order and
5 dismiss the case. If the court determines that the respondent continues to meet the criteria for
6 outpatient commitment, it shall continue the outpatient commitment but shall designate a
7 ~~physician or center~~ an outpatient treatment provider at the respondent's new residence to be
8 responsible for the ~~management or supervision~~ care and treatment of the respondent's outpatient
9 ~~commitment~~ commitment and shall also designate the LME/MCO, or an alternative as

11 the respondent to appear for treatment at the address of the newly designated outpatient treatment

14 changing venue, the clerk of court in the county where the outpatient commitment has been

17 the outpatient commitment has been supervised shall send a copy of the court's order directing
18 the continuation of outpatient treatment under new supervision to the newly designated outpatient

21 (e) At any time during the term of an outpatient commitment order, a respondent may
22 apply to the court for a supplemental hearing for the purpose of discharge from the order. The

25 determine whether the respondent continues to meet the criteria specified in

2 G.S. 122C-263(d)(1), it shall unconditionally discharge ~~him—the respondent.~~ A copy of the
3 discharge order shall be furnished by the clerk to the designated outpatient treatment ~~physician~~
4 ~~or center.~~ provider and the LME/MCO. If the respondent continues to meet the criteria of
5 G.S. 122C-263(d)(1), the court may order outpatient commitment for an additional period not in
6 excess of 180 days. The court order shall comply with the requirements of G.S. 122C-271."

7 **SECTION 11.(i)** G.S. 122C-276 reads as rewritten:

8 "**§ 122C-276. Inpatient commitment; rehearings for respondents other than insanity**
9 **acquittees.**

10 (a) Fifteen days before the end of the initial inpatient commitment period if the attending
11 physician determines that commitment of a respondent beyond the initial period will be
12 necessary, he shall so notify the clerk of superior court of the county in which the facility is
13 located. The clerk, at least 10 days before the end of the initial period, on order of a district court
14 judge of the district court district as defined in G.S. 7A-133 in which the facility is located, shall
15 calendar the rehearing. If the respondent was initially committed as the result of conduct resulting
16 in his being charged with a violent crime, including a crime involving an assault with a deadly
17 weapon, and respondent was found incapable of proceeding, the clerk shall also notify the chief
18 district court judge, the clerk of superior court, and the district attorney in the county in which
19 the respondent was found incapable of proceeding of the time and place of the hearing.

20 (b) Fifteen days before the end of the initial treatment period of a respondent who was
21 initially committed as a result of conduct resulting in his being charged with a violent crime,
22 including a crime involving an assault with a deadly weapon, having been found incapable of
23 proceeding, if the attending physician determines that commitment of the respondent beyond the
24 initial period will not be necessary, he shall so notify the clerk of superior court who shall
25 schedule a rehearing as provided in subsection (a) of this section.

26 (c) Subject to the provisions of G.S. 122C-269(c), rehearings shall be held as authorized
27 in G.S. 122C-268(g). The judge is a ~~judge of the district court~~ district court judge of the district
28 court district as defined in G.S. 7A-133 in which the facility is located or a district court judge
29 temporarily assigned to that district.

30 (d) Notice and proceedings of rehearings are governed by the same procedures as initial
31 hearings and the respondent has the same rights he had at the initial hearing including the right
32 to appeal.

33 (e) At rehearings the court may make the same dispositions authorized in
34 G.S. 122C-271(b) except a second commitment order may be for an additional period not in
35 excess of 180 days.

36 (f) Fifteen days before the end of the second commitment period and annually thereafter,
37 the attending physician shall review and evaluate the condition of each respondent; and if he
38 determines that a respondent is in continued need of inpatient commitment or, in the alternative,
39 in need of outpatient commitment, or a combination of both, he shall so notify the respondent,
40 his counsel, and the clerk of superior court of the county, in which the facility is located. Unless
41 the respondent through his counsel files with the clerk a written waiver of his right to a rehearing,
42 the clerk, on order of a district court judge of the district in which the facility is located, shall
43 calendar a rehearing for not later than the end of the current commitment period. The procedures
44 and standards for the rehearing are the same as for the first rehearing. No third or subsequent
45 inpatient recommitment order shall be for a period longer than one year.

46 (g) At any rehearings the court has the option to order outpatient commitment for a period
47 not in excess of 180 days in accordance with the criteria specified in G.S. 122C-263(d)(1) and
48 following the procedures as specified in this Article. The court order shall comply with the
49 requirements of G.S. 122C-271."

50 **SECTION 11.(j)** G.S. 122C-54(d) reads as rewritten:

1 "(d) Except as otherwise provided in this section, any individual seeking confidential
2 information contained in the court files or the court records of a proceeding made pursuant to
3 Article 5 of this Chapter may file a written motion in the cause setting out why the information
4 is needed. A district court judge may issue an order to disclose the confidential information
5 sought if he finds the order is appropriate under the circumstances and if he finds that it is in the
6 best interest of the individual admitted or committed or of the public to have the information
7 disclosed.

8 Counsel for the respondent and counsel for the State in the commitment hearing may receive
9 access to the court file without filing a motion or obtaining a court order. A judge presiding over
10 a criminal case that initiated the Article 5 proceeding may have access to the file without filing a
11 motion.

12 The Department shall be granted access to all relevant data, court orders, records, or other
13 relevant information, including any confidential information, related to its duties and
14 responsibilities pursuant to Article 5 of this Chapter. The Department shall keep all information
15 collected under this subsection privileged, in accordance with applicable State law and federal
16 guidelines, and the information shall be confidential and shall not be a public record under
17 Chapter 132 of the General Statutes.

18 Judicial officials determining whether a criminal defendant may be released before trial
19 pursuant to G.S. 15A-533 may have access to the defendant's records of proceedings made
20 pursuant to Article 5 of this Chapter for the purposes of determining whether a criminal defendant
21 has been involuntarily committed within the previous three years."

22 **SECTION 11.(k)** This section becomes effective December 1, 2026, and applies to
23 proceedings that occur on or after that date.

30 **SECTION 13.(a)** G.S. 15A-532 reads as rewritten:

31 **"§ 15A-532. Persons authorized to determine conditions for release.**

32 Judicial officials may determine conditions for release of persons in proceedings over which
33 they are presiding, in accordance with this Article. Pretrial release of a defendant found to be
34 incapable to proceed is governed by this Article as well as Article 56 of this Chapter."

35 **SECTION 13.(b)** G.S. 15A-1001 reads as rewritten:

36 **"§ 15A-1001. No proceedings when defendant mentally incapacitated; ~~exception~~ exception;**
37 **State policy; capacity restoration services; immunity from liability.**

38 (a) No person may be tried, convicted, sentenced, or punished for a crime when by reason
39 of mental illness or defect he or she is unable to understand the nature and object of the
40 proceedings against ~~him~~ him or her, to comprehend his or her own situation in reference to the
41 proceedings, or to assist in his or her defense in a rational or reasonable manner. This condition
42 is hereinafter referred to as "incapacity to proceed."

43 (b) This section does not prevent the court from going forward with any motions which
44 can be handled by counsel without the assistance of the defendant.

45 (c) It is State policy that persons found incapable to proceed should be provided with
46 capacity restoration services whenever feasible and appropriate and that such services should be
47 carried out in as efficient and timely a manner as possible in order to meet the ends of justice for
48 victims, for the public, and for those persons who stand accused of crimes.

49 (d) Unless otherwise specified in this Article, capacity restoration services are directed
50 toward a defendant gaining capacity to stand trial and may include any or all of the following, as
51 applicable and based upon available resources:

- 1 (1) Educational instruction regarding the criminal justice system, to include
2 assisting the defendant in understanding his or her role in the proceedings.
3 (2) Psychoeducational instruction regarding the nature of a defendant's diagnosed
4 condition and the resources and coping skills necessary to mitigate capacity
5 deficits caused by the condition.
6 (3) Except as prohibited by G.S. 15A-1010, other mental health treatment or
7 counseling which is medically reasonable and appropriate.

8 (e) No individual, facility, agency, or entity, or officials, staff, and employees of these
9 individuals and entities, responsible for the custody, transportation, examination, admission,
10 management, supervision, instruction, treatment, or release of a defendant under this Article and
11 who is not grossly negligent, is civilly liable, personally or otherwise, for actions or omissions
12 arising from these responsibilities or for the actions or omissions of a defendant. This immunity
13 is in addition to any other legal immunity from liability to which these individuals, facilities,
14 agencies, or entities may be entitled and applies to actions performed in connection with, or
15 arising out of, the custody, transportation, examination, commitment, admission, management,
16 supervision, instruction, treatment, or release of any defendant pursuant to or under the authority
17 of this Article or otherwise."

18 **SECTION 13.(c)** G.S. 15A-1002 reads as rewritten:

19 **"§ 15A-1002. Determination of incapacity to proceed; evidence; temporary commitment;**
20 **temporary orders.**

21 (a) The question of the capacity of the defendant to proceed may be raised at any time on
22 motion by the prosecutor, the defendant, the defense counsel, or the court. The motion shall detail
23 the specific conduct that leads the moving party to question the defendant's capacity to proceed.

24 (b) (1) When the capacity of the defendant to proceed is questioned, the court shall
25 hold a hearing to determine the defendant's capacity to proceed. If an
26 examination is ordered pursuant to subdivision (1a) or (2) of this subsection,
27 the hearing shall be held after the examination. Reasonable notice shall be
28 given to the defendant and prosecutor, and the State and the defendant may
29 introduce evidence.

30 (1a) In the case of a defendant charged with a misdemeanor or felony, the court
31 may appoint one or more impartial medical experts, including forensic
32 evaluators approved under rules of the Commission for Mental Health,
33 Developmental Disabilities, and Substance Abuse Services, to examine the
34 defendant and return a written report describing the present state of the
35 defendant's mental health. Reports so prepared are admissible at the hearing.
36 The court may call any expert so appointed to testify at the hearing with or

38 (2) At any time in the case of a defendant charged with a felony, the court may
39 order the defendant to a State facility for the mentally ill for observation and
40 treatment for the period, not to exceed 60 days, necessary to determine the

42 without first having an examination pursuant to subsection (b)(1a) of this
43 section, the judge shall make a finding that an examination pursuant to this
44 subsection would be more appropriate to determine the defendant's capacity.
45 The sheriff shall return the defendant to the county when notified that the
46 evaluation has been completed. The director of the facility shall direct his
47 report on defendant's condition to the defense attorney and to the clerk of
48 superior court, who shall bring it to the attention of the court. The report is
49 admissible at the hearing.

1 (4) A presiding district or superior court judge of this State who orders an
2 examination pursuant to subdivision (1a) or (2) of this subsection shall order
3 the release of relevant confidential information to the examiner, including, but
4 not limited to, the warrant or indictment, arrest records, the law enforcement
5 incident report, the defendant's criminal record, jail records, any prior medical
6 and mental health records of the defendant, and any school records of the
7 defendant after providing the defendant with reasonable notice and an
8 opportunity to be heard and then determining that the information is relevant
9 and necessary to the hearing of the matter before the court and unavailable
10 from any other source. This subdivision shall not be construed to relieve any
11 court of its duty to conduct hearings and make findings required under
12 relevant federal law before ordering the release of any private medical or
13 mental health information or records related to substance abuse or HIV status
14 or treatment. The records may be surrendered to the court for in camera review
15 if surrender is necessary to make the required determinations. The records
16 shall be withheld from public inspection and, except as provided in this
17 subdivision, may be examined only by order of the court.

18 (b1) The order of the court shall contain findings of fact to support its determination of the
19 defendant's capacity to proceed. The parties may stipulate that the defendant is ~~capable of~~
20 ~~proceeding~~ capable to proceed but shall not be allowed to stipulate that the defendant lacks
21 capacity to proceed. If the court concludes that the defendant lacks capacity to ~~proceed,~~
22 ~~proceedings for involuntary civil commitment under Chapter 122C of the General Statutes may~~
23 ~~be instituted on the basis of the report in either the county where the criminal proceedings are~~
24 ~~pending or, if the defendant is hospitalized, in the county in which the defendant is~~

4 defendant gaining capacity. Local evaluators may not make a
5 recommendation of non-restorability.
6 (3) Any recommended treatment or education necessary for the defendant to gain
7 capacity, and the availability of such services, if known.
8 (4) A recommendation of the appropriate clinical setting in which the capacity
9 restoration services may be safely provided to the defendant and any specific
10 treatment needs of the defendant or other factors supporting this
11 recommendation.
12 (5) Any other opinions or recommendations specifically ordered by the court or
13 which the examiner believes necessary for the court's consideration of the
14 defendant's capacity or potential to gain capacity.

15 If the examiner is unable to provide any of the required opinions, recommendations, or
16 findings, the reasons therefore shall be clearly stated in the report. The forensic evaluation may
17 be conducted remotely using video-conference which permits two-way audio and video
18 transmission between the defendant and the evaluator, unless the evaluator determines there is a
19 clinical need for an in-person evaluation.

20 (c) The court may make appropriate temporary orders for the confinement or security of
21 the defendant pending the hearing or ruling of the court on the question of the capacity of the
22 defendant to proceed.

23 (d) Any report made to the court pursuant to this section shall be forwarded to the clerk
24 of superior court in a sealed envelope addressed to the attention of a presiding judge, with a
25 covering statement to the clerk of the fact of the examination of the defendant and any conclusion
26 as to whether the defendant has or lacks capacity to proceed. If the defendant is being held in the
27 custody of the sheriff, the clerk shall send a copy of the covering statement to the sheriff. The
28 sheriff and any persons employed by the sheriff shall maintain the copy of the covering statement
29 as a confidential record. A copy of the full report shall be forwarded to defense counsel or to the
30 defendant if he is not represented by counsel. If the question of the defendant's capacity to
31 proceed is raised at any time, a copy of the full report must be forwarded to the district attorney,
32 as provided in G.S. 122C-54(b). Until such report becomes a public record, the full report to the
33 court shall be kept under such conditions as are directed by the court, and its contents shall not
34 be revealed except the report and the relevant confidential information previously ordered
35 released under subdivision (b)(4) of this section shall be released as follows: (i) to clinicians at
36 the program where the defendant is receiving capacity restoration; (ii) to clinicians designated
37 by the Secretary of Health and Human Services, and (iii) as directed by the court. Any report
38 made to the court pursuant to this section shall not be a public record unless introduced into
39 evidence."

45 are reasonable grounds to believe the defendant meets the criteria for involuntary commitment
46 under Part 7 of Article 5 of Chapter 122C of the General Statutes. If the presiding judge finds
47 reasonable grounds to believe that the defendant meets the criteria, he shall make findings of fact
48 and issue a custody order in the same manner, upon the same grounds and with the same effect
49 as an order issued by a clerk or magistrate pursuant to G.S. 122C-261. Proceedings thereafter are
50 in accordance with Part 7 of Article 5 of Chapter 122C of the General Statutes. If the defendant
51 was charged with a violent crime, including a crime involving assault with a deadly weapon, the

1 judge's custody order shall require a law-enforcement officer to take the defendant directly to a
2 24-hour facility as described in ~~G.S. 122C-252~~; G.S. 122C-252, as space is available; and the
3 order must indicate that the defendant was charged with a violent crime and that he was found

9 ~~(b) The court may make appropriate orders for the temporary detention of the defendant~~

11 ~~(c) Evidence used at the hearing with regard to capacity to proceed is admissible in the~~
12 ~~involuntary civil commitment proceedings.~~

13 (b) When the court finds, pursuant to G.S. 15A-1002, that a defendant is incapable to
14 proceed to trial and that the defendant is reasonably likely to gain capacity to proceed within the
15 foreseeable future, the court shall order the defendant to enroll and participate in a capacity
16 restoration program, as defined in G.S. 122C-256, subject to the following conditions:

17 (1) If the defendant is eligible for pretrial release, enrollment and participation in
18 a community-based capacity restoration program shall be imposed as an
19 additional condition of release, so long as such program is reasonably
20 available based on geographic location, program capacity, and any other
21 relevant factor. Additional conditions may be imposed in the court's discretion
22 pursuant to Article 26 of this Chapter, specifically including the power to
23 place the defendant in the custody of a designated person or organization
24 agreeing to supervise the defendant.

25 (2) If the defendant is held in pretrial custody, the defendant shall be required to
26 enroll and participate in a detention center capacity restoration program, as
27 defined in G.S. 122C-256, if such program is reasonably available.

28 (3) If the court determines that the most clinically appropriate setting for a

30 than through civil involuntary commitment, then the court may instead order
31 the defendant to enroll in an inpatient-based capacity restoration program, if

33 (4) The court shall specify in its order the duration of the defendant's enrollment,
34 up to a maximum initial term of four months, taking into account the
35 defendant's mental condition, the prognosis for the defendant's ability to gain
36 capacity, the nature of the criminal charges, the nature of the capacity
37 restoration program, and any other relevant factor. The term of a defendant's
38 enrollment period does not include wait times for program entry. The initial
39 term of four months may be extended per G.S. 15A-1007(e).

40 (5) The court shall issue any other orders deemed appropriate to safeguard the
41 defendant and to protect the public, including orders to ensure and provide for
42 the defendant's return for trial in the event the defendant subsequently gains
43 capacity. The court may amend or supplement its orders from time to time as

45 (c) If no capacity restoration program is reasonably available to the defendant, or if the
46 court finds that the defendant is expected to gain capacity in the foreseeable future without the
47 need for capacity restoration services, or for other good cause shown, the requirement for referral
48 to such program may be waived, but the court shall issue any further orders as appropriate to
49 safeguard the defendant and to protect the public, including orders to ensure and provide for the
50 defendant's return for trial in the event the defendant subsequently gains capacity. The court may

1 review and modify the defendant's conditions of release. The court may also determine when a
2 supplemental hearing under G.S. 15A-1007 should be held.

3 (d) If the court finds that the defendant is not reasonably likely to gain capacity to proceed
4 in the foreseeable future, the court shall not order the defendant to receive capacity restoration
5 services but shall instead consider whether dismissal of the charges is required pursuant to
6 G.S. 15A-1008. The court may further determine when a supplemental hearing under
7 G.S. 15A-1007 should be held to review the defendant's condition. The court may review and
8 modify the defendant's conditions of release as appropriate pending further determination
9 pursuant to G.S. 15A-1008 or supplemental hearing.

10 (e) In addition to the requirement provided in subsection (a) of this section, the court at
11 any time after the defendant is found incapable to proceed may determine whether there are
12 reasonable grounds to believe the defendant probably has a mental illness and is either (i)
13 dangerous to self or others as defined under G.S. 122C-3 or (ii) in need of treatment in order to
14 prevent further disability or deterioration that would predictably result in dangerousness and
15 therefore meets the criteria for involuntary civil commitment. Based upon such findings, the court

30 (3) The court may make appropriate orders for the temporary detention of the

34 involuntary commitment, or is involuntarily committed on an outpatient basis.

43 proceed, standing alone, does not constitute an independent basis for

8 released. The court shall also order that the defendant shall be examined to determine whether
9 the defendant has the capacity to proceed prior to release from custody. A report of the
10 examination shall be provided pursuant to G.S. 15A-1002. If the defendant was charged with a
11 violent crime, including a crime involving assault with a deadly weapon, and that charge has not
12 been dismissed, the order must require that if the defendant is to be released from the custody of
13 the hospital or other institution, he is to be released only to the custody of a specified law
14 enforcement agency. If the original or supplemental orders do not specify to whom the
15 respondent shall be released, the hospital or other institution may release the defendant to
16 whomever it thinks appropriate.

17 (d) If the defendant is placed in the custody of a hospital or institution pursuant to
18 proceedings for involuntary civil commitment, or if the defendant is placed in the custody of
19 another person pursuant to subsection (b), the orders of the trial court must require that the
20 hospital, institution, or individual report the condition of the defendant to the clerk at the same
21 times that reports on the condition of the defendant respondent are required under Part 7 of
22 Article 5 of Chapter 122C of the General Statutes, or more frequently if the court requires, and
23 immediately if the defendant gains capacity to proceed. The order must also require the report to
24 state the likelihood of the defendant's gaining capacity to proceed, to the extent that the hospital,
25 institution, or individual is capable of making such a judgment.

26 (e) The orders must require and provide for the return of the defendant to stand trial in
27 the event that he gains capacity to proceed, unless the charges have been dismissed pursuant to
28 G.S. 15A-1008, and may also provide for the confinement or pretrial release of the defendant in
29 that event.

30 (f) The orders of the court may be amended or supplemented from time to time as
31 changed conditions require.

32 **"§ 15A-1004. Examinations and reports required for defendants lacking capacity.**

33 (a) When a defendant is enrolled in a capacity restoration program pursuant to
34 G.S. 15A-1003(a), the court shall order the program to do all of the following:

35 (1) To report to the clerk on the condition of the defendant every 60 days
36 following program entry, and immediately if the defendant gains capacity to
37 proceed, and to include in its report a statement of the likelihood of the
38 defendant's gaining capacity to proceed within the remaining time period of
39 the defendant's enrollment or within a subsequent period of enrollment, if
40 ordered.

41 (2) To report to the clerk immediately if at any time it appears the defendant is
42 not a suitable candidate for capacity restoration services, requires capacity
43 restoration in a different setting, or poses an unnecessary risk of danger to
44 program personnel.

45 (b) When a defendant is found incapable to proceed and is placed in the custody or care
46 of a hospital, institution, or provider through a proceeding for involuntary civil commitment,
47 whether on an inpatient or outpatient basis, the trial court's orders shall include all of the
48 following requirements of the hospital, institution, or provider:

49 (1) A requirement to report to the clerk whenever the defendant will not be
50 involuntarily committed, is to be discharged or released from involuntary

1 commitment, or upon a change in status from involuntary commitment on an
2 inpatient basis to involuntary commitment on an outpatient basis.

3 (2) A requirement to determine, prior to the defendant's discharge or release from
4 involuntary commitment, whether the defendant has the capacity to proceed
5 to trial and to provide a report of examination in compliance with the reporting
6 requirements under G.S. 15A-1002 to the extent that the hospital, institution,
7 or individual is capable of making such a judgment.

8 (3) A requirement to report the condition of the defendant to the clerk at the same
9 times that reports on the condition of the defendant-respondent are required

15 assault with a deadly weapon, a requirement that if the defendant is to be
16 released from the custody or care of the hospital, institution, or provider, the
17 defendant is to be released only to the custody of a specified law enforcement
18 agency. If the original or supplemental orders do not specify to whom the
19 respondent shall be released, the hospital, institution, or provider may release
20 the defendant to whomever is determined appropriate.

21 (c) When a defendant found incapable to proceed is placed in the secure custody of a
22 designated person or organization as a condition of release, the court shall require the supervising
23 person or organization to report to the clerk immediately if it appears that the defendant has
24 gained capacity to proceed. The court may also require a periodic report to the clerk from the
25 supervising person or organization as to the condition of the defendant and the defendant's
26 likelihood of gaining capacity to proceed, to the extent the person or organization is qualified to
27 do so."

28 SECTION 13.(f) G.S. 15A-1006 reads as rewritten:

29 ~~"§ 15A-1006. Return of defendant for trial upon gaining capacity.~~

30 ~~If a defendant who has been determined to be incapable of proceeding, and who is in the~~
31 ~~eustody of an institution or an individual, has been determined by the institution or individual~~

41 trial, the clerk shall provide written notification to the district attorney and the defendant's
42 attorney within 72 hours, and the matter shall proceed to a supplemental hearing pursuant to
43 G.S. 15A-1007, if conducted, and trial upon the court's determination that the defendant has
44 gained capacity to proceed. If the defendant is currently enrolled in any court-ordered capacity
45 restoration program pursuant to G.S. 15A-1003(a), this requirement shall remain in effect
46 pending the supplemental hearing.

47 (b) When a defendant who is charged with a violent crime, including a crime involving
48 assault with a deadly weapon, has likely gained capacity to proceed while involuntarily

4 **SECTION 13.(g)** G.S. 15A-1007 reads as rewritten:

6 (a) ~~When it has been reported to the court that a defendant has gained capacity to proceed,~~

24 (a) Upon receiving notification from the clerk under G.S. 15A-1006 that a defendant has
25 likely gained capacity to proceed, the district attorney shall calendar the matter for hearing within
26 30 days of receiving the notification or at the next available term of court. The court may hold a
27 supplemental hearing to determine whether the defendant has capacity to proceed. The parties
28 may stipulate to the defendant's capacity but not to the defendant's lack of capacity. If the parties
29 stipulate to a finding of capacity, the judge may review new evidence, including new evaluations,
30 and make a determination of capacity without holding a hearing.

31 (b) If the court determines that a defendant has gained the capacity to proceed, the case

2 motion, the court may hold a supplemental hearing any time the court determines it appropriate
3 or necessary to inquire into the condition of the defendant or to consider matters relevant to
4 disposition under G.S. 15A-1008.

5 (e) The court may take any action upon supplemental hearing that the court could have
6 taken at the initial hearing on a defendant's capacity to proceed.

7 (1) A defendant may be ordered to participate in a capacity restoration program
8 pursuant to G.S. 15A-1003(a) whenever the court finds upon supplemental
9 hearing that it is reasonably likely the defendant will gain capacity to proceed
10 within the foreseeable future. The court may also extend the time for capacity
11 restoration services in further increments of no more than four months per
12 extension, not counting wait times for program entry, upon a finding that the
13 defendant's continued participation in a capacity restoration program is
14 reasonably likely to restore the defendant's capacity. A defendant who is not
15 charged with a felony offense may not be required to participate in a capacity
16 restoration program under G.S. 15A-1003(a) with respect to the same charges
17 for a total period exceeding 12 months, not inclusive of wait times for program
18 entry. Additionally, a defendant's enrollment in a capacity restoration program
19 will not operate to preclude dismissal of the charges when any condition of
20 G.S. 15A-1008 is found to be met.

21 (2) At any supplemental hearing when the court finds reasonable grounds that a
22 defendant who lacks capacity to proceed probably has a mental illness and is
23 either (i) dangerous to self or others as defined under G.S. 122C-3 or (ii) in
24 need of treatment in order to prevent further disability or deterioration that
25 would predictably result in dangerousness, the court may proceed with a
26 referral for civil commitment pursuant to G.S. 15A-1003(d).

27 (3) A defendant released or discharged from involuntary civil commitment but
28 who is found to still lack capacity to proceed is subject to appropriate
29 supplemental court orders pursuant to G.S. 15A-1003 if the charges are not
30 dismissed pursuant to G.S. 15A-1008, including orders to participate in a
31 capacity restoration program pursuant to G.S. 15A-1003(a)."

32 **SECTION 13.(h)** G.S. 15A-1008 reads as rewritten:

33 "**§ 15A-1008. Dismissal of ~~charges~~; referral of defendant for civil commitment**
34 **proceedings upon dismissal.**

35 (a) When a defendant lacks capacity to proceed, the court shall dismiss the charges upon
36 the earliest of the following occurrences:

37 (1) When it appears to the satisfaction of the court that the defendant will not gain
38 capacity to proceed.

39 (2) When as a result of incarceration, involuntary commitment to an inpatient
40 facility, or other court-ordered confinement, the defendant has been
41 substantially deprived of his liberty for a period of time equal to or in excess
42 of the maximum term of imprisonment permissible for prior record Level VI
43 for felonies or prior conviction Level III for misdemeanors for the most
44 serious offense charged.

45 (3) Upon the expiration of a period of five years from the date of determination
46 of incapacity to proceed in the case of misdemeanor charges and a period of
47 10 years in the case of felony charges.

48 (b) A dismissal entered pursuant to subdivision (2) of subsection (a) of this section shall
49 be without leave.

50 (c) A dismissal entered pursuant to subdivision (1) or (3) of subsection (a) of this section
51 shall be issued without prejudice to the refileing of the charges.

1 (d) Dismissal of criminal charges pursuant to this section shall be upon motion of the
2 prosecutor or the defendant or upon the court's own motion and shall not be expunged pursuant
3 to G.S. 15A-146.

4 (e) Upon motion of the district attorney prior to dismissal of the charges under this
5 section, the court shall determine whether there are reasonable grounds to believe the defendant
6 meets the criteria for involuntary commitment under Part 7 of Article 5 of Chapter 122C of the
7 General Statutes. If the court finds reasonable grounds to believe that the defendant meets the
8 criteria, the court shall make findings of fact and issue a custody order in the same manner, upon
9 the same grounds and with the same effect as an order issued by a clerk or magistrate pursuant
10 to G.S. 122C-261. Proceedings thereafter, upon dismissal of the criminal charges, are in
11 accordance with Part 7 of Article 5 of Chapter 122C of the General Statutes and with
12 G.S. 15A-1003(d)(1), (2), (3), and (5). If the defendant was charged with a violent crime,
13 including a crime involving assault with a deadly weapon, the judge's custody order shall require
14 a law enforcement officer to take the defendant directly to a 24-hour facility as described in
15 G.S. 122C-252, and the order must indicate that the defendant was charged with a violent crime
16 and that he was found incapable of proceeding. The court may make appropriate orders for the
17 temporary detention of the defendant pending that proceeding. Evidence used at the hearing with
18 regard to capacity to proceed is admissible in the involuntary civil commitment proceedings."

19 SECTION 13.(i) Article 56 of Chapter 15A of the General Statutes is amended by
20 adding a new section to read:

21 "**§ 15A-1010. Compelled medication for capacity restoration generally prohibited; limited**
22 **conditions when court may order compelled medication of certain defendants**
23 **charged with serious felony offenses.**

24 (a) Except as authorized under subsection (b) of this section, a defendant found incapable
25 to proceed to trial may not be compelled to take any medication for the purpose of gaining or
26 maintaining capacity.

27 (b) Upon the State's motion or upon the court's own motion, the court may order
28 compelled medication of an uncooperative defendant for purposes of gaining or maintaining
29 capacity to proceed if the court affirmatively finds by clear and convincing evidence all of the
30 following, in writing, based on the particular circumstances presented and specific to the
31 defendant in question:

32 (1) The defendant is charged with a serious offense against the person or property,
33 and there are no apparent special circumstances which lessen the importance
34 of the government's interest in bringing the defendant to trial.

35 (2) The proposed treatment is reasonable and appropriate for the mental health
36 condition of the defendant and its proposed use is consistent with accepted
37 medical standards.

38 (3) The proposed treatment will not cause an unnecessary risk to the defendant's
39 physical or mental health.

40 (4) The proposed treatment is necessary insofar as it is substantially likely to
41 render the defendant competent for trial and less intrusive means would not
42 further this interest.

43 (5) The proposed treatment is substantially unlikely to have side effects that
44 undermine the fairness of the defendant's trial.

45 (c) The administration of any treatment ordered pursuant to this section must be at the
46 direction and under the supervision of a licensed medical professional. However, the proposed
47 course of treatment shall be reviewed and authorized by the court prior to implementation, and
48 the court may impose any other conditions necessary to protect the rights of the defendant and to
49 ensure the safety of others, not inconsistent with accepted medical standards.

50 (d) The court's treatment order may provide for multiple alternative courses of treatment
51 in the discretion of the licensed medical professional treating the defendant, so long as each such

1 alternative course of treatment is reviewed by the court and found to meet the requirements of
2 subsection (b) of this section.

3 (e) The court may review and amend previous compelled medication orders upon motion
4 of the district attorney, the defendant's attorney, the court's own motion, or upon notice by the
5 treatment provider to the clerk that a change in the approved course or alternative courses of
6 treatment is warranted.

7 (f) This section does not preclude medical treatment of persons involuntarily committed
8 as authorized under Chapter 122C of the General Statutes or medical treatment authorized under
9 any other provision of law.

10 (g) Treatment ordered pursuant to this section is subject to G.S. 15A-1001(e)."

11 **SECTION 13.(j)** G.S. 122C-54(b) reads as rewritten:

12 "(b) If an individual is a defendant in a criminal case and a mental examination of the
13 defendant has been ordered by the court as provided in G.S. 15A-1002, the facility shall send the
14 results or the report of the mental examination to the clerk of court, to the district attorney or
15 prosecuting officer, and to the attorney of record for the defendant as provided in
16 G.S. 15A-1002(d). The report shall contain ~~a treatment recommendation, if any, and an opinion~~
17 ~~as to whether there is a likelihood that the defendant will gain the capacity to proceed.~~ all matters
18 required under G.S. 15A-1002(b3)."

19 **SECTION 13.(k)** G.S. 122C-256 reads as rewritten:

20 **"§ 122C-256. Capacity restoration pilot programs.**

21 (a) The following definitions apply in this section:

22 (1) CBCRP. – Community-based capacity restoration program.

23 (2) DCCRP. – Detention center capacity restoration program.

24 (3) IBCRP. – Inpatient-based capacity restoration program.

25 (b) Community-Based Capacity Restoration Program. – The Department or an
26 LME/MCO may contract for three or more CBCRPs. CBCRPs may be county-based or
27 regionally based. If regionally based, a CBCRP shall align with the State-operated psychiatric
28 hospital within closest proximity. The Department may consult with one or more LME/MCOs
29 for the purposes of contracting for CBCRPs under this subsection.

30 (c) Detention Center Capacity Restoration Program. – The Department or an LME/MCO,
31 in consultation and with the consent of relevant sheriffs, may contract for up to three or more
32 DCCRPs. DCCRPs may be county-based or regionally based. All county sheriffs choosing to
33 participate in a regional program must enter into an operational agreement with the sheriff hosting
34 the regional program prior to referring defendants to the program. A regionally based DCCRP
35 shall align with the State-operated psychiatric hospital within closest proximity. The Department
36 may consult with one or more LME/MCOs for the purposes of contracting for DCCRPs under
37 this subsection.

38 (d) Inpatient-Based Capacity Restoration Program. – IBCRPs are programs offered by
39 inpatient psychiatric facilities with the expertise to provide capacity restoration programming.
40 These programs shall be available within the State psychiatric hospital system. Inpatient
41 treatment is intended for defendants that are likely to benefit from inpatient level of care but who
42 may or may not meet involuntary commitment criteria."

43 **SECTION 13.(l)** The Department of Health and Human Services shall by December
44 1, 2026, adopt guidelines for treatment of individuals who are referred pursuant to
45 G.S. 15A-1003 to a detention center capacity restoration program, community-based capacity
46 restoration program, or inpatient-based capacity restoration program, as defined in
47 G.S. 122C-256, as amended by this act, incorporating best practices to restore the individual's
48 capacity to proceed to trial in criminal court. The adopted guidelines shall be published to the
49 official website of the Department of Health and Human Services.

50 **SECTION 13.(m)** G.S. 122C-273(a) reads as rewritten:

1 "(a) Unless prohibited by Chapter 90 of the General Statutes, if the commitment order
2 directs outpatient treatment, the outpatient treatment physician may prescribe or administer, or
3 the center may administer, to the respondent reasonable and appropriate medication and
4 treatment that are consistent with accepted medical standards.

5 (1) If the respondent fails to comply or clearly refuses to comply with all or part
6 of the prescribed treatment, the physician, the physician's designee, or the
7 center shall make all reasonable effort to solicit the respondent's compliance.
8 These efforts shall be documented and reported to the court with a request for
9 a supplemental hearing.

10 (2) If the respondent fails to comply, but does not clearly refuse to comply, with
11 all or part of the prescribed treatment after reasonable effort to solicit the
12 respondent's compliance, the physician, the physician's designee, or the center
13 may request the court to order the respondent taken into custody for the
14 purpose of examination. Upon receipt of this request, the clerk shall issue an
15 order to a law-enforcement officer to take the respondent into custody and to
16 take him immediately to the designated outpatient treatment physician or
17 center for examination. The custody order is valid throughout the State. The
18 law-enforcement officer shall turn the respondent over to the custody of the
19 physician or center who shall conduct the examination and then release the
20 respondent. The law-enforcement officer may wait during the examination
21 and return the respondent to his home after the examination. An examination
22 conducted under this subsection in which a physician or eligible psychologist
23 determines that the respondent meets the criteria for inpatient commitment
24 may be substituted for the first examination required by G.S. 122C-263 if the
25 clerk or magistrate issues a custody order within six hours after the
26 examination was performed.

27 (3) In no case may the respondent be physically forced to take medication or
28 forcibly detained for treatment unless he poses an immediate danger to himself
29 or others. In such cases inpatient commitment proceedings shall be initiated.
30 The administration of medication pursuant to court order for a criminal
31 defendant found incapable to proceed to trial is governed by the provisions of
32 G.S. 15A-1010 and not by this section.

33 (4) At any time that the outpatient treatment physician or center finds that the
34 respondent no longer meets the criteria set out in G.S. 122C-263(d)(1), the
35 physician or center shall so notify the court and the case shall be terminated;
36 provided, however, if the respondent was initially committed as a result of
37 conduct resulting in his being charged with a violent crime, including a crime
38 involving an assault with a deadly weapon, and the respondent was found
39 incapable of proceeding, the designated outpatient treatment physician or
40 center shall notify the clerk that discharge is recommended. The clerk shall
41 calendar a supplemental hearing as provided in G.S. 122C-274 to determine
42 whether the respondent meets the criteria for outpatient commitment.

43 (5) Any individual who has knowledge that a respondent on outpatient
44 commitment has become dangerous to himself, as defined by
45 G.S. 122C-3(11)a., and others, as defined in G.S. 122C-3(11)b., may initiate
46 a new petition for inpatient commitment as provided in this Part. If the
47 respondent is committed as an inpatient, the outpatient commitment shall be
48 terminated and notice sent by the clerk of court in the county where the
49 respondent is committed as an inpatient to the clerk of court of the county
50 where the outpatient commitment is being supervised."

1 **SECTION 13.(n)** This section becomes effective December 1, 2026, and applies to
2 any initial or supplemental capacity hearing conducted on or after that date.

10 conditions on or after that date. Subsection (b1) of G.S. 15A-533, as enacted by subsection (c) of
11 this section, becomes effective ~~December 1, 2026,~~ July 1, 2028, and applies to persons appearing
12 before a judicial official for the determination of pretrial release conditions on or after that date.
13 The remainder of this section is effective when it becomes law."

19 **SECTION 15.** Except as otherwise provided, this act is effective when it becomes
20 law.
