# Status Report on the Community Health Grant Program

Session Law 2023-134, Section 9B.2.(e)

The Department of Health and Human Services, Office of Rural Heath (ORH) respectfully submits this Legislative Report to satisfy SL 2023-134, Section 9B.2.(e) on the Community Health Grant Program.

Session Law 2023-134 directed ORH to report the following information on the Community Health Grant Program:

- The identity and a brief description of each grantee and each program or service offered by the grantee.
- The amount of funding awarded to each grantee.
- The number of individuals served by each grantee, and for the individuals served, the types of services provided to each.
- Any other information requested by ORH as necessary for evaluating the success of the Community Health Grant Program.

The Community Health Grant Program was established and funded by the North Carolina General Assembly in 2005 (S.L. 2005-276) to increase access to preventive and primary care services for uninsured or medically indigent patients. Since the Community Health Grant Program's inception, ORH works collaboratively with stakeholders and representatives of key safety net providers to obtain input used by ORH to guide its administration of the Community Health Grant Program. In Session Law 2017-57, the Community Health Grant Program funding expanded, the program criteria were defined, and the Primary Care Advisory Committee was formalized to advise on the Community Health Grant Program process.

ORH submitted a Legislative Report to satisfy Session Law 2017-57 and Session Law 2021-180 on the establishment of a Primary Care Advisory Committee. ORH works directly with the Primary Care Advisory Committee members, which includes the North Carolina Community Health Center Association, the North Carolina Association of Local Health Directors, the North Carolina Association of Free and Charitable Clinics, the North Carolina School-Based Health Alliance, and other organizations representative of eligible grant recipients.

As defined in Session Law, the maximum awards are \$150,000 per year. The Program award period aligns with the State Fiscal Year (July 1<sup>st</sup> through June 30<sup>th</sup>). The competitive grant process begins with an annual Request for Applications (RFA). The SFY 2025 RFA was released and posted to the ORH website on October 24, 2023. The Community Health Grant team held two RFA technical assistance workshops on November 6, 2023, and November 8, 2023, to assist applicants with effectively applying for Community Health Grant funding.

Applications were submitted via an electronic application process and were due on December 8, 2023. Eligible applications are organized within the six Medicaid regions and scored by a team of reviewers, with awards given to the highest scoring applications from each Medicaid region. This process ensures that funding distribution is equitable across the State. The demand for the Community Health Grant Program is substantial. On average, the program funding supports awards to approximately 41% of eligible applicants. In SFY25, the Community Health Grant program received 91 applications for funding and 36 of those applicants were awarded.

In compliance with Session Law noted above, the following information and tables are respectfully submitted. Awards are separated into three one-year budget cycles. New awards were generated by the competitive application cycle that opened on October 24, 2023, and closed on December 8, 2023. The new awards are documented in Table 1. Continuation awards that began Year 2 of their three-year award are documented in Table 2, and continuation awards that began Year 3 of their three-year award are documented in Table 3. In the tables below, the Total Patients Served data is reported by each grantee to ORH. Grantee organizations are categorized in the table below as providing one of the following types of data about the patients they serve: Sub-Populations: Data from a specific group of patients supported by the grant (i.e., dental patients, maternal care patients, behavioral health, etc.).

- One-Site Population: Data reported will include only those patients seen at a specific practice site location supported by the grant.
- <u>Multi-Sites Population</u>: Data reported will include patients from more than one specific practice site location supported by the grant.

The purpose of each grantee defining its "patient served populations" as noted above is to provide additional information to explain the variations between the number of patients served across grantees. Community Health Grant Program grantees range vastly in size: from a school-based health center that operates in one or a few schools, or a free clinic that is only open a few days a week (with few patients served by the site) to a large federally qualified health center (FQHC) that has multiple sites across multiple counties or a hospital with several rural health clinics (with large patient population served). Each grantee bases their reporting on both their grant structure and their system's ability to develop reporting capabilities. Sub-Populations tend to be service/initiative focused, so only the patients benefiting from a specific service are reported. Multi-Sites Population locations tend to have higher numbers of patients served due to the data being reported from more than one specific practice site location. In addition to variations attributed to the grantee definition of patient population, grantee outcomes can vary due to a multitude of factors, including but not limited to practice operations, primary care provider challenges, operational expenses, location of service delivery sites, hours of operation, and the complexity of care provided to high-need populations.
