Purpose of NC IOLTA

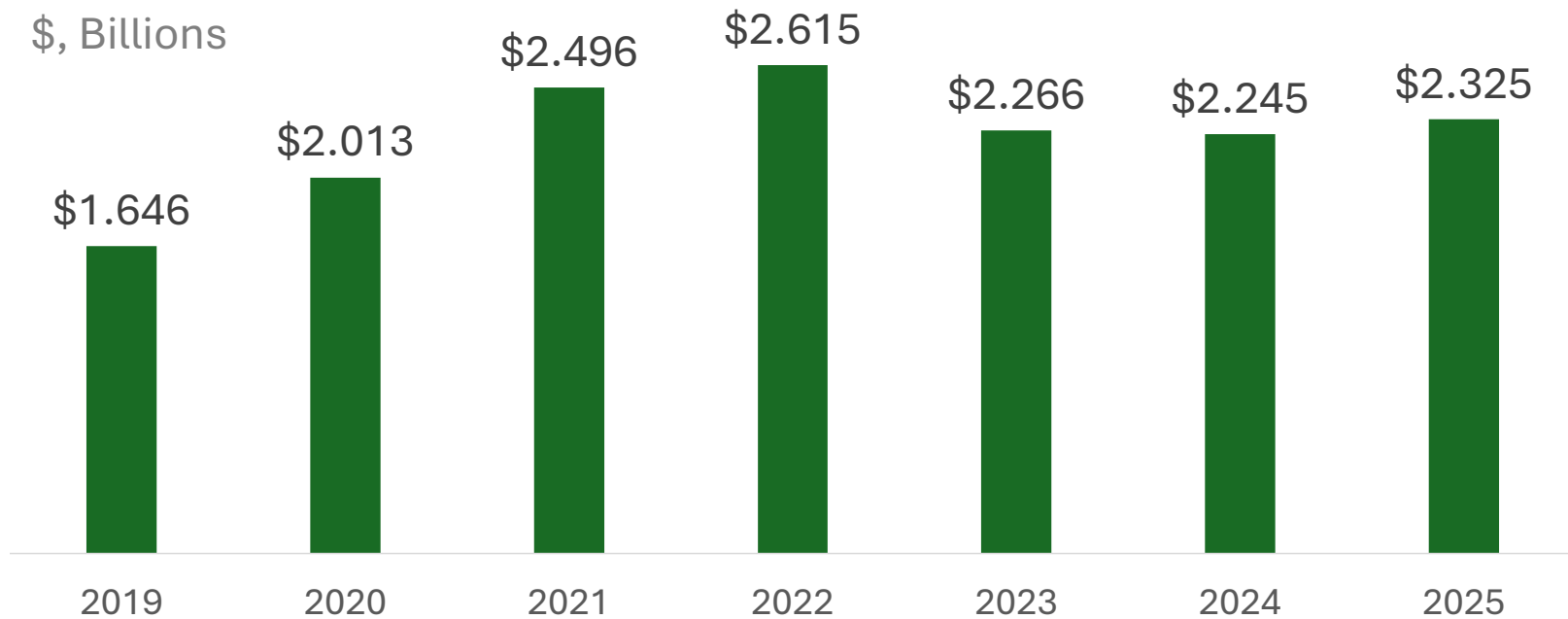
The North Carolina State Bar and the North Carolina Supreme Court established NC IOLTA in 1983 to generate income from lawyers' general trust accounts in order to fund civil legal services and other programs for the public's benefit.

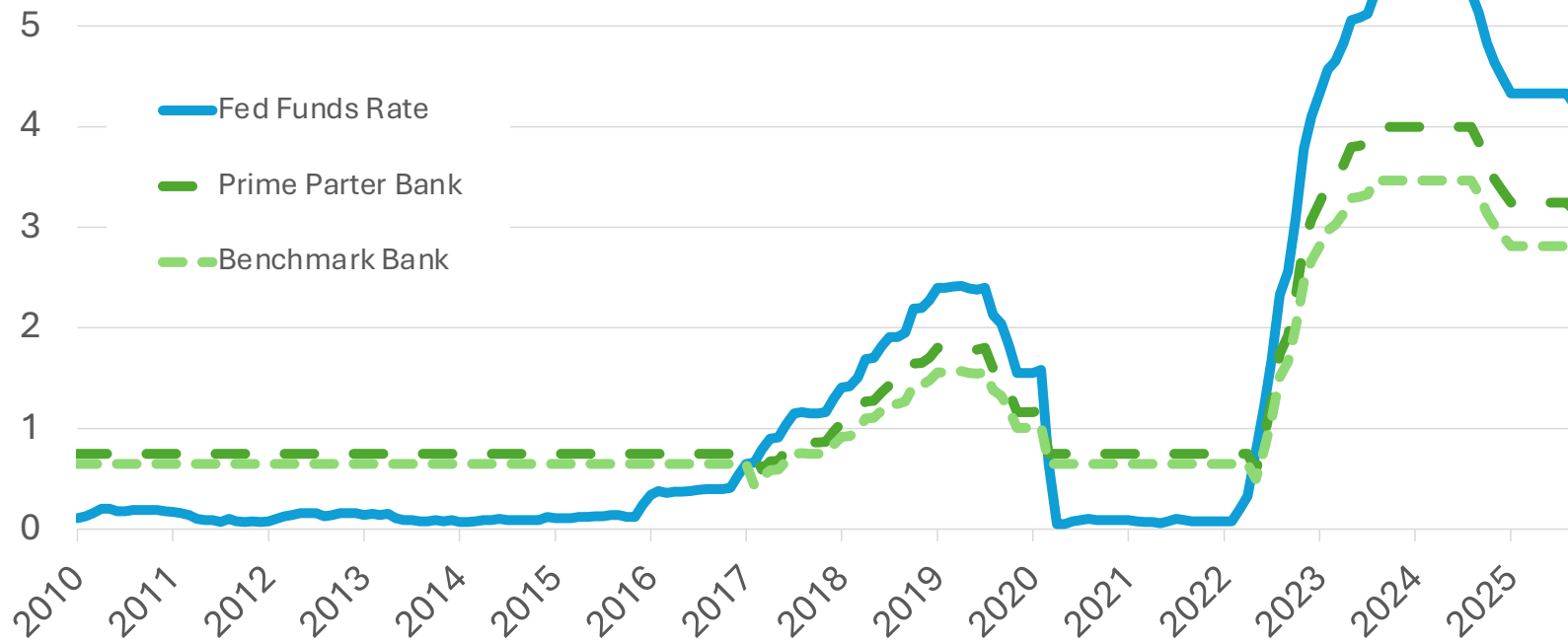
By rule (27 NCAC 1D.1301) IOLTA funds can be used for

- (1) providing civil legal services for indigents;
- (2) enhancement and improvement of grievance and disciplinary procedures to protect the public more fully from incompetent or unethical attorneys;
- (3) development and maintenance of a fund for student loans to enable meritorious persons to obtain a legal education who would not otherwise have adequate funds for this purpose;
- (4) such other programs designed to improve the administration of justice as may from time to time be proposed by the board and approved by the Supreme Court of North Carolina.

The 2020–2022 NC real estate boom led to higher balances in trust accounts

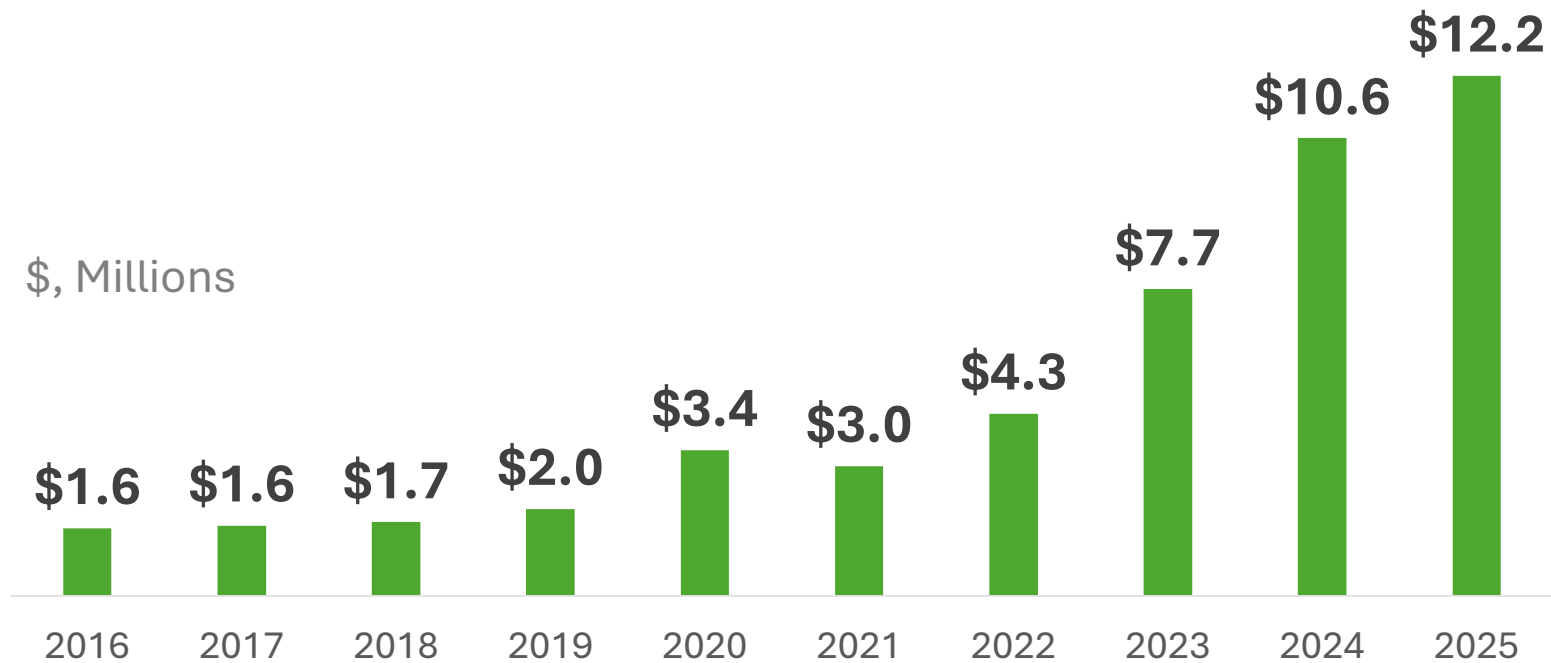


Interest rates since 2023 have been 4x higher than prior years

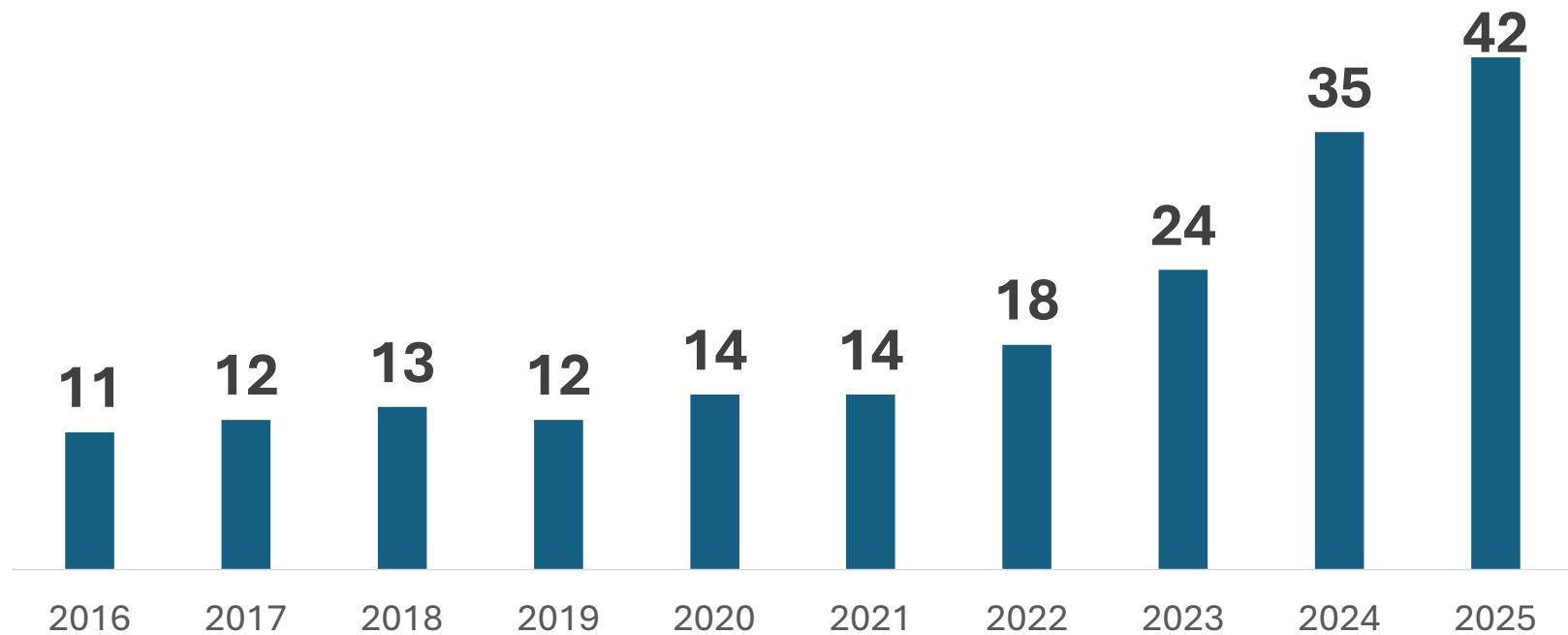

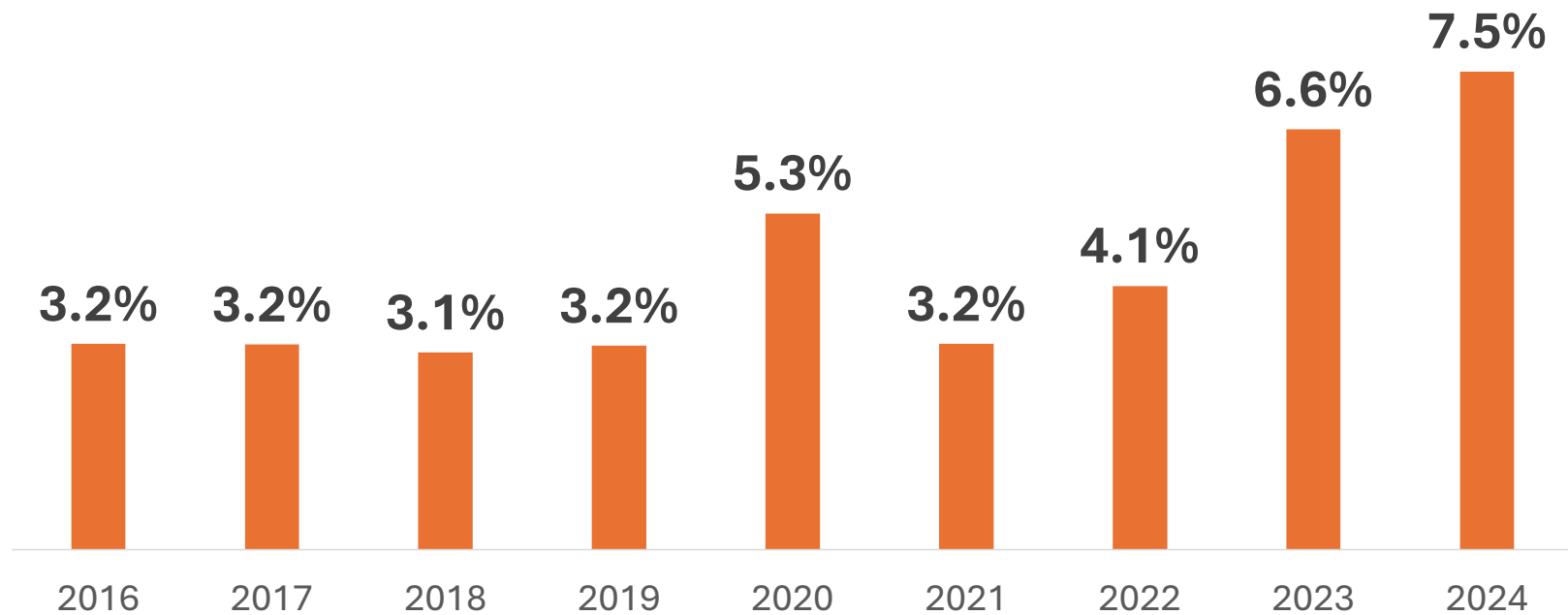

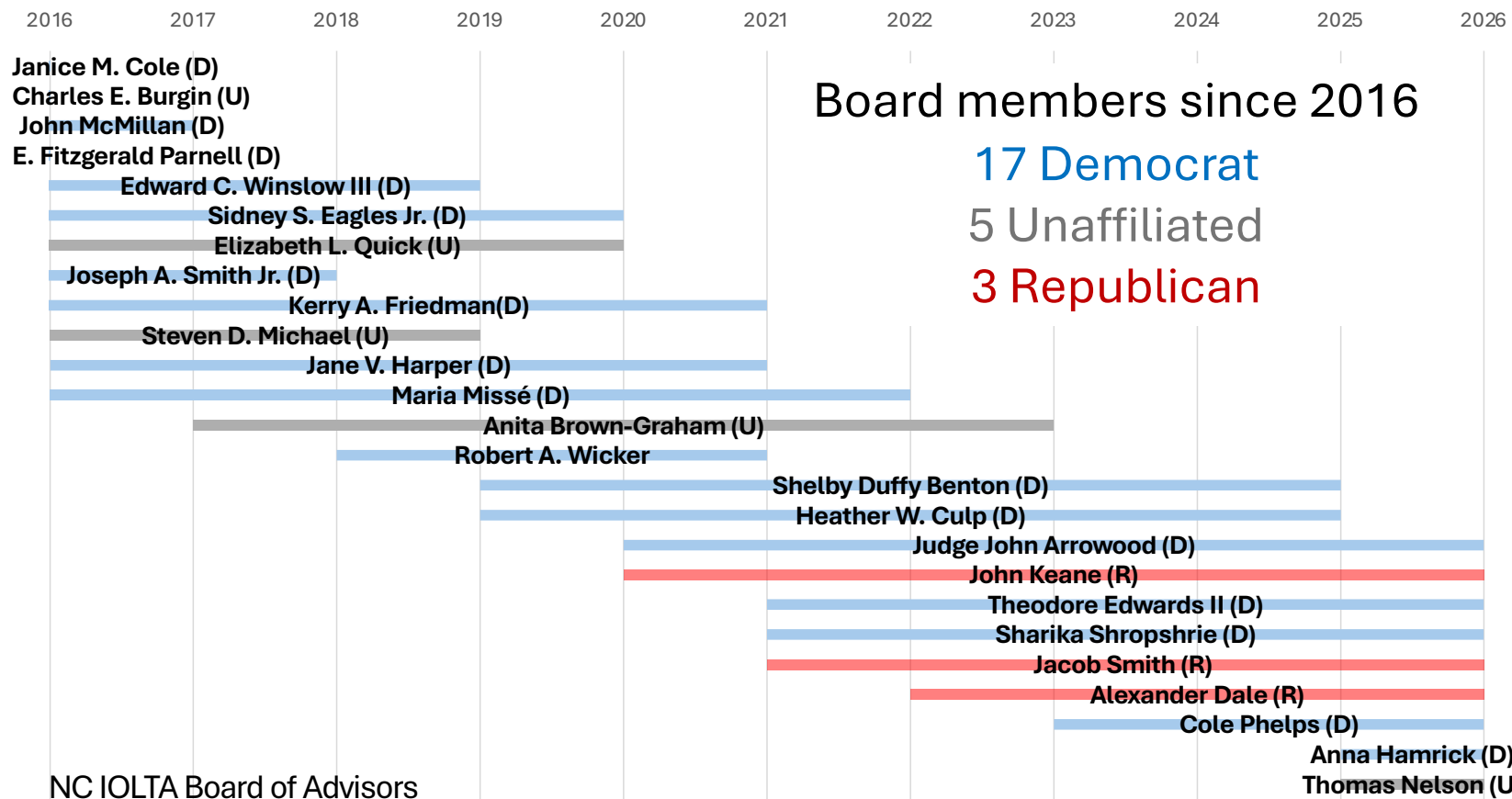

Becoming an anti-racist organization

The United States' wealth and power is built on stolen land, from enslaved labor, and under the racist lie that White people were superior to Black people, indigenous people, and people of color.

This systemic racism from our country's origins continues to perpetuate inequity throughout all facets of life in this country today. Being an anti-racist organization means actively working to dismantle inequitable institutions and systems, including the immigration detention and deportation system.

How we started

We started as a project of the Washington Lawyers Committee for Civil Rights and Urban Affairs and became an independent non-profit in 1999 known as the Capital Area Immigrants' Rights (CAIR) Coalition. To this day, we're the only non-profit organization in the Capital region focused on providing free legal and social services to immigrant children and adults who are detained and at risk of deportation.

How we've grown

Since 2010, we have more than doubled in size and added two programs to complement our original work serving immigrant adults who are detained: the Children's Program, which assists unaccompanied immigrant children in detention, and the Immigration Impact Lab, which uses impact litigation to seek to usher in systematic change.

Where we are now

With support from donors, partner organizations, and our growing and passionate team of attorneys and advocates, we have expanded our reach beyond the Capital region. Now known as the Amica Center for Immigrant Rights, we're honored to help immigrants across multiple states successfully navigate the immigration system.



OUR ORIGIN STORY

CMN was co-founded by Stefanía Arteaga and Becca O'Neill in 2019. Stefanía and Becca met in 2017 doing legal advocacy work in the non-profit sector in Charlotte, NC. Together they worked to create and implement a policy limiting Immigration Customs Enforcement (ICE) access to the Mecklenburg County Jail, which had one of the oldest 287(g) agreements in the country. Born out of their collective understanding of the urgent unmet legal and organizing needs of community members in removal proceedings, the Carolina Migrant Network fuses legal services and community advocacy to provide holistic support for our clients and their families.

The Carolinas have an established (and growing) migrant and immigrant population with an ever-increasing need for representation for individuals in removal proceedings. CMN is the only organization across the Carolinas that is bridging the gap between immigration legal services and pro-immigrant community organizing.

CMN bridges the gap between legal services and advocacy efforts. North Carolina ranks 47 in the country for access to legal representation for immigrants facing detention and removal, despite its significant and growing immigrant population. CMN utilizes a dual-pronged approach, providing access to free legal representation and implementing organizing tactics to create community-based social safety nets.

Dismantling Structural Racism and Mass Incarceration Across North Carolina

Through community education, narrative shift, and litigation, Emancipate NC supports North Carolina's people as they free themselves from mass incarceration and structural racism.

About

Emancipate NC was founded on the knowledge that mass incarceration and structural racism harm all of us. Prison is state-sponsored violence. We are all complicit in its harms. As an organization, we are dedicated to shifting the narrative on racialized mass incarceration through community education and mobilization. The mainstream narrative that criminalizes Black and Brown people must be transformed—so that we can all get free. Emancipate NC is a 501(c)(3) nonprofit organization and was previously known as the **Carolina Justice Policy Center**.



Authentic Community Safety

In our community education work, we collaborate with Black communities that are suffering from criminalization, incarceration, and structural racism. Their neighborhoods are over-policed and their members are over-arrested. Magistrates set high cash bail for the simplest crimes. Then they are coerced into pleading guilty so they can secure freedom from jail. They are also disproportionately punished to harsh sentences, and they are displaced from their friends, families, children, jobs, and homes. They are traumatized in body and in mind. Prison is state violence and it magnifies pain for all parties. Through restorative justice education, we are committed to replacing criminalization and incarceration with alternative approaches that address violence and repair harm.



National Health Law Program's **Equity Stance**

Vision:

The National Health Law Program (NHeLP) believes that health equity is achieved when a person's characteristics and circumstances — including race and ethnicity, sex, gender identity, sexual orientation, age, income, class, disability, health, immigration status, nationality, religious beliefs, language proficiency, or geographic location — do not predict their health outcomes. We also believe that these characteristics and circumstances should not limit people's experience in the world or in our organization.
