AREA: 30.068 acres

UNIT COST: \$4,500/acre

CONSIDERATION: \$135,306 (subject to survey)

COMMENTS: The property proposed for acquisition has been identified as meeting the ecological criteria for the Department of Agriculture's Plant Conservation Program. Acquisition of this property is crucial to protecting an identified Significant Natural Heritage Area containing state and federally endangered plant populations. The Natural Heritage Trust Fund has provided funds for this acquisition.

Acquisition of this property is crucial to protecting an identified Significant Natural Heritage Area containing state and federally endangered plant populations. The Natural Heritage Trust Fund has provided funds for this acquisition.

COMMENTS: The subject property is adjacent to the northeast shore of Horseshoe Lake. The property proposed for this acquisition will be incorporated into the Suggs Mill Pond Game Land and will be utilized to protect important wildlife habitat and provide hunting and other wildlife recreational opportunities for sportsmen. Funding from the Clean Water Management Trust Fund.

The property proposed for this acquisition will be incorporated into the Nicholson Creek Game Land and will be utilized to protect important wildlife habitat and provide hunting and other wildlife recreational opportunities for sportsmen. Funding from the Natural heritage Trust Fund.

COMMENTS: The property proposed for acquisition will be incorporated into the Sand Hills Game Land and will be utilized to protect important wildlife habitat and provide hunting and other wildlife recreational opportunities for sportsmen. The subject property will link isolated parcels of the Sand Hills Game Land. Funding from the Natural Heritage Trust Fund -  $\pm$ \$71,779.50 ( $\pm$ 45%) and Department of the Interior – US Fish and Wildlife Service –

± \$87,730.50 (±55%)

UNIT COST: \$3,000/acre

CONSIDERATION: \$2,018,640 (subject to survey)

COMMENTS: The property proposed for acquisition will be incorporated into the Sand Hills Game Land and will be utilized to protect important wildlife habitat and provide hunting and other wildlife recreational opportunities for sportsmen. The subject property will link isolated parcels of the Sand Hills Game Land. Funding from the Natural Heritage Trust Fund (\$908,388), Department of the Interior-US Fish and Wildlife Service (\$1,110,252).

GRANTOR: Sidney E. Thompson and wife, Esther R. Thompson

GRANTEE: State of NC, Fayetteville State University

LOCATION: 2813 Skye Drive, Fayetteville, Cumberland County

AREA: One-acre site improved with one-story dwelling containing approx 3,632 sq. ft.

UNIT COST: \$4.59/sq.ft. – land

\$43.78/sq.ft. – dwelling

CONSIDERATION: \$359,000

COMMENTS: Property proposed for acquisition is being acquired at a bargain sale and will be utilized as a chancellor's residence.

#### **OTHER MATTERS**

#### ITEM 11

At the request of the Department of Environment and Natural Resources, Division of Forest Resources, authorization is requested to affect a land exchange between the State of North Carolina and Southwestern Community College. Southwestern Community College proposes to convey to the State a 10-acre vacant tract of land located off U.S. Highway 441, Sylva, Jackson County to the State of North Carolina for construction of a new forestry headquarters. The Division of Forest Resources will seek funding for construction of the proposed forestry headquarters from the 2006 Legislative Session of the General Assembly.

In exchange upon construction of the new forestry headquarters the State will convey to Southwestern Community College its existing 6.6-acre tract of land and improvements to accommodate Southwestern's expansion.

If the State is unable to secure funds for the construction of their forestry headquarters by December 31, 2007, the 10-acre tract will revert back to Southwestern Community College.

The State's existing 6.6-acre tract currently contains a reverter in favor of the County of Jackson. The State will seek authorization from the County of Jackson to remove the reverter restrictions prior to the transfer from the State to the College.

Therefore, approval is requested to affect the land exchange as proposed.
