EMERGENCY CAPITAL PROJECTS

In accordance with G.S. 120-76.1 the following expenditure was approved without consulting the Commission because of an emergency that posed an imminent threat to public health and safety.

Baynes Hall Heating System - NCCU (\$390,000)

On November 9, 2007, it was brought to the Chancellor's attention that electric space heaters were being used on the only heat source for 27 of the 208 rooms in Baynes Residence Hall because of the deteriorating central heating system. NCCU immediately discontinued the use of space heaters and relocated students living in these rooms to temporary living space. This project involves repair to the 41 year-old heating system and supporting electrical system in Baynes Residence Hall. The project is estimated to cost \$390,000 and will be funded from lapsed salaries and available operating funds.
